COMMISSION ANNOUNCEMENTS

ENFORCEMENT PROCEEDINGS

COMMISSION DENIES MOTION TO STRIKE AND DISMISS

The Commission has denied Richard H. Morrow's motion to strike and dismiss a claim against Morrow for a cease-and-desist order. The order instituting administrative proceedings against Morrow alleges that, between December 1989 and April 1990, Morrow, while participating in a minimum-maximum private placement of limited partnership offerings, willfully violated Section 17(a) of the Securities Act of 1933 and Section 10(b) and 15(c) of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder. The order seeks a cease and desist order, as well as other sanctions against Morrow.

Morrow noted that the Commission's authority to obtain cease-and-desist orders was granted by the enactment of the Securities Enforcement Remedies and Penny Stock Reform Act of 1990 in October 1990, after the date of his alleged violations. He argued that the Commission could not therefore impose a cease-and-desist order against him for conduct that occurred before that date. The Commission held that, when an intervening statute authorizes prospective relief such as a cease-and-desist order, imposition of such relief is not retroactive. (Rel. 34-35508)

COMMISSION DENIES MOTIONS TO RECONSIDER BY DIVISION OF ENFORCEMENT AND BENJAMIN SPRECHER

The Commission has denied motions by both the Division of Enforcement and Benjamin G. Sprecher to reconsider an earlier ruling. On December 27, 1994, the Commission had dismissed that portion of an administrative proceeding against Sprecher seeking disgorgement. It determined to permit the proceeding to go forward on the issue of whether to impose

a penny stock bar on Sprecher.

In this order, the Commission reiterated its view that, based on the particular facts before it, amended Section 15(b)(6) of the Securities Exchange Act of 1934, which was added by the Securities Enforcement Remedies and Penny Stock Reform Act of 1990 (the Remedies Act) and was the basis for the disgorgement action against Sprecher, was to be enforced prospectively only. The Commission noted that its conclusion was limited to the unique facts presented to it, and did not mean that relief under the Remedies Act would never be available for acts occurring before the effective date of that statute. The Commission also declined to reconsider its refusal to dismiss the proceeding against Sprecher for a penny stock bar. (Rel. 34-35509)

ORDERS ISSUED AGAINST JONATHAN GOOGEL, BENJAMIN SISTI AND PETER CURLEY

The Commission announced that, on March 13, the Honorable Jose A. Cabranes, U.S. Circuit Judge, sitting by designation in the U.S. District Court for the District of Connecticut, issued Final Judgments of Permanent Injunction against Jonathan N. Googel (Googel), Benjamin J. Sisti (B. Sisti) and Peter J. Curley (Curley). These defendants, who consented to this order without admitting or denying the Commission's allegations, were enjoined from further violations of the registration and antifraud provisions of the securities laws. Googel and B. Sisti were also barred from acting as an officer or director of a public company and ordered to disgorge the sums of \$4,260,597 and \$3,853,089, respectively, plus prejudgment interest thereon, provided, however that payment of such amounts was waived based on their demonstrated inability to pay.

The complaint, filed against seven individuals, alleges violations of several antifraud and securities registration provisions of the federal securities laws in connection with a fraudulent unregistered public offering by Colonial Realty Company of 1200 limited partnership units in the Colonial Constitution Limited Partnership (CCLP) during 1989 and 1990. During the offering period, CCLP interests totaling more than \$30 million were purchased by over 700 investors residing in 28 states and the District of Columbia. [SEC v. INVESTMENT COMPANY ACT RELEASE

THE BANK OF NEW YORK

A notice has been issued giving interested persons until April 17 to request a hearing on an application by The Bank of New York for an order under Section 6(c) of the Investment Company Act that would grant an exemption from Section 17(f) of the Act. The order would permit Bank of New York-Argentina to act as custodian or subcustodian for investment

company assets in Argentina under two alternative forms of foreign custody arrangements. (Rel. IC - 20963; International Series Rel. 796)

HOLDING COMPANY ACT RELEASES

ALLEGHENY POWER SYSTEM, INC.

An order has been issued authorizing a proposal by Allegheny Power System, Inc., a registered holding company, to issue and sell up to 6,025,000 shares of its authorized and unissued common stock. (Rel. 35-26255)

GENERAL PUBLIC UTILITIES CORPORATION

An order has been issued authorizing General Public Utilities Corporation (GPU), a registered holding company, to amend its Articles of Incorporation to increase the number of authorized shares of its common stock, \$2.50 par value, from 150,000,000 to 350,000,000 and eliminate the rights of its shareholders to purchase additional shares of GPU common stock in certain circumstances. GPU will submit these amendments for action at GPU's annual meeting of shareholders to be held on May 4, 1995. GPU was authorized by interim order dated February 27, 1995 (HCAR No. 26239) to solicit proxies from shareholders in connection with the proposed amendments. (Rel. 35-26256)

SELF-REGULATORY ORGANIZATIONS

APPROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change filed by the <u>National Association of Securities Dealers</u> under Rule 19b-4 (SR-NASD-95-05) to amend Part III, Section 32 of the NASD Code of Arbitration Procedure. The rule change amends Section 32(c) of the Code to increase the amount of time before a hearing where the parties are required to exchange documents from 10 to 20 days. (Release No. 34-35525)

The Commission approved a proposed rule change submitted under Rule 19b-4 by the <u>Philadelphia Stock Exchange</u> (SR-Phlx-94-77) and notice of filing and order granting accelerated approval relating to the imposition of an approved lessor's initiation fee and a requirement that approved lessors pledge to abide by the by-laws and rules. (Rel. 34-35528)

NOTICE OF PROPOSED RULE CHANGE

The <u>Boston Stock Exchange</u> has filed a proposed rule change (SR-BSE-95-04) under Rule 19b-4 of the Exchange Act relating to the permanent approval of BEACON subscriber credits. Publication of the proposal is expected in the <u>Federal Register</u> during the week of March 27. (Rel. 34-35529)
