ENFORCEMENT PROCEEDINGS

APPLICATION FOR REVIEW OF NASD DECISION TO DELIST BIORELEASE CORPORATION FROM NASDAQ SMALLCAP MARKET DISMISSED

The Commission has dismissed an application for review of a decision of the National Association of Securities Dealers, Inc. (NASD) to delist Biorelease Corporation, an issuer formerly listed on the Nasdaq SmallCap Market. The NASD determined that Biorelease was not in compliance with the requirements that it maintain \$2 million total assets and \$1 million in capital and surplus. The Commission found that Biorelease failed to demonstrate its compliance with maintenance requirements. (Rel. 34-35575)

PERMANENT INJUNCTION ENTERED AGAINST JASON SPENCER WEEKS, HARRY MARRERO AND THEODORE NAVOLIO

The Commission announced that on March 27 Final Judgments of Permanent Injunction by Default were entered against Jason Spencer Weeks (Weeks),

Harry W. Marrero (Marrero) and Theodore T. Navolio (Navolio) by the United States District Court for the Middle District of Florida. The Final Judgments permanently enjoin Weeks, Marrero and Navolio from future violations of Sections 5(a), 5(c) and 17(a) of the Securities Act of 1933 (Securities Act), Section 10(b) of the Securities Exchange Act of 1934 (Exchange Act) and Rule 10b-5 promulgated thereunder, and orders Weeks, Marrero and Navolio to disgorge \$204,082.64, \$50,063.30 and \$113,200.00, respectively, plus prejudgment interest. Weeks, Marrero and Navolio were principals of Premier Benefit Capital Trust (Premier Trust).

The Commission's complaint, filed on July 1, 1993, and its amended complaint, filed on November 16, 1994, alleged that from at least January 1993 through July 1993, Premier Trust, through Weeks, Marrero and Navolio, among others, offered and sold unregistered securities, namely Premier Trust certificates, to the general public through newspaper and radio advertisements and public seminars. Premier Trust, through Weeks, Marrero and Navolio, among others, raised approximately \$6,600,000 through the sale of the certificates to 180 investors residing in a number of states.

The complaint further alleged that Weeks, Marrero and Navolio, among others, disseminated to the public, various offering materials, in connection with the offers and sales of the certificates, which contained misrepresentations and omissions of material facts regarding Premier Trust, its operations, its trustees, the risks involved in the investment and the use of investors' funds. HOLDING COMPANY ACT RELEASES

NEW ENGLAND ELECTRIC SYSTEM, ET AL.

An order has been issued authorizing New England Electric System (NEES), a registered holding company, New England Energy, Incorporated (NEEI), and New England Power Company, both wholly owned subsidiary companies of NEES, for NEEI to refinance its present bank debt through an agreement for loans of up to \$225 million with a syndicate of banks. NCP ENERGY, INC.

An order has been issued authorizing NCP Energy, Inc. (NCP), a nonutility subsidiary of General Public Utilities Corporation, a registered holding company, to acquire a promissory note from North Canadian Resources, Inc.
