ENFORCEMENT PROCEEDINGS

TRADING SUSPENDED IN THE SECURITIES OF PANWORLD MINERALS

The Commission announced the single ten-day suspension of over-the-counter trading, on NASDAQ or otherwise, in the securities of PanWorld Minerals International, Inc. (PanWorld) for the period beginning at 9:30 a.m. (EDT) on May 10, 1995 and terminating at 11:59 p.m. (EDT) on May 23, 1995.

The Commission suspended trading in PanWorld securities because of questions concerning the adequacy and accuracy of publicly disseminated information concerning, among other things, agreements between PanWorld and others; whether PanWorld, its officers, directors or affiliates have distributed and are distributing securities in violation of the registration provisions of the Securities Act of 1933; and the accuracy and adequacy of PanWorld's financial statements. PanWorld is a Nevada corporation based in Salt Lake City, Utah. (Rel. 34-35697)
