COMMISSION ANNOUNCEMENTS

CHANGE IN METHOD FOR CALCULATING FEES

Effective at 9:00 a.m. on Monday, May 22, 1995, the formula used to calculate the filing fees paid pursuant to Section 6(b) of the Securities Act of 1933 will be changed from multiplying by the factor of .00034483 in order to more accurately reflect the statutory fee rate. The fee rate of one-twenty-ninth of one percent (1/29 of 1%) will remain the same, but the fee will now be calculated by dividing by 2900. ENFORCEMENT PROCEEDINGS

LAW JUDGE'S FINDING OF LIABILITY AND SANCTIONS IMPOSED AFFIRMED

The Commission has affirmed a law judge's finding of liability and sanctions imposed against Patricia A. Johnson, a former branch manager of the Beverly Hills office of PaineWebber, Inc. The law judge suspended Johnson for six months from acting in a supervisory capacity with any broker or dealer.

The Commission found that, from 1987 through May 1988, Johnson failed to provide effective and reasonable supervision of registered representative David Zetterstrom with a view towards preventing Zetterstrom's violations of Section 17(a) of the Securities Act of 1933 and Section 10(b) of the Securities Exchange Act and Rule 10b-5 thereunder. It found that Johnson's supervision was deficient in that, among other things, she disregarded firm procedures and ignored numerous "red flags" that should have caused her to impose a commensurately higher level of supervision over Zetterstrom.

The Commission concluded that Johnson displayed a lack of hands-on involvement with her staff and a lack of responsiveness to serious violations by a registered representative under her supervision. (Rel. 34-35698)

SELF-REGULATORY ORGANIZATIONS

APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change (SR-NASD-95-7) filed by the <u>National Association Securities Dealers</u>. The rule change establishes a vendor fee of \$.01/query for delivery, on a non-continuous basis, to the vendor's subscribers of inside bid/ask and last sale information for Nasdaq and OTCBB securities.
