COMMISSION ADOPTS RULES OF PRACTICE AND STATEMENT OF INFORMAL PROCEDURES AND SUPPLEMENTARY INFORMATION CONCERNING ADJUDICATORY PROCEEDINGS

The Commission has adopted comprehensive revisions to its Rules of Practice (Rules), the procedural rules that govern Commission administrative proceedings. Enforcement proceedings initiated by the Commission and appeals of disciplinary proceedings brought by self-regulatory organizations are among the most frequently occurring proceedings governed by the Rules.

The revised Rules better facilitate fair and efficient proceedings by setting forth applicable procedural requirements more completely and in an easier to use format; by streamlining procedures; and by the addition of provisions that address changes in statutory requirements, judicial and administrative case law developments, Commission policies, and litigation practices since the Rules were last revised. The Rules also contain new procedures implementing authority to issue administrative temporary cease-and-desist and disgorgement orders granted to the Commission by the Securities Enforcement Remedies and Penny Stock Reform Act.

The Commission also announces the issuance of a statement of Informal Procedures and Supplementary Information Concerning Adjudicatory Proceedings which establishes guidelines for the completion of key phases of contested adjudications; requires periodic case status reports; and provides for increased and more timely disclosure concerning the Commission's adjudicatory docket through the periodic publication in the <u>SEC Docket</u> of summary statistical information concerning changes in the Commission's case load.

The Rules will be effective 30 days after publication in the <u>Federal Register</u>. Any administrative proceeding docketed by the Commission prior to the publication date will be completed pursuant to the former Rules of Practice. ENFORCEMENT PROCEEDINGS

ADMINISTRATIVE AND CEASE AND DESIST PROCEEDINGS INSTITUTED AGAINST COLES FINANCIAL SERVICES, INC. AND JAMES COLES, JR.

The Commission announced that on June 5 it instituted and settled administrative proceedings pursuant to Sections 203(e), (f) and (k) of the Investment Advisers Act of 1940 (Advisers Act), Section 8A of the Securities Act of 1933 (Securities Act), and Section 21C of the Securities Exchange Act of 1934 (Exchange Act), against Coles Financial Services, Inc. (CFS) and James Coles, Jr. (Coles). Respondents consented to the issuance of the Order, without admitting or denying the Commission's findings.

The Commission found that, from September 1991 through May 1993, Respondents made fraudulent misrepresentations and omissions when recommending that advisory clients purchase investment contracts for four start-up companies, took \$24,500 in undisclosed fees and commissions in connection therewith, and misappropriated \$9,200, among other violations.

Respondents were ordered to cease and desist from committing or causing further violations of Sections 204, 206(1), (2), (3) and (4), and 207 of the Advisers Act and Rules 206(4)-2, 204-1, 204-2 and 204-3 thereunder, Section 17(a) of the Securities Act, and Sections 10(b) and 15(a) of the Exchange Act and Rule 10b-5 thereunder. CFS's registration was revoked, and Coles was barred from association with any broker-dealer or investment adviser. Disgorgement was waived, and civil penalties were not imposed, due to Respondents' demonstrated inability to pay. (Rel. 33-7176; 34-35803; IA-1493)

WEST PENN POWER COMPANY, ET AL.

A supplemental order has been issued authorizing Monongahela Power Company, a public-utility subsidiary company of Allegheny Power System, Inc., a registered holding company, to issue and sell up to an aggregate of \$95,000,000 principal amount of junior subordinated debentures at any time or from time to time through June 7, 1996. Jurisdiction was reserved over (1) the issuance and sale of such debentures by Monongahela from June 8, 1996 through December 31, 1998, (2) the issuance and sale of up to \$110,000,000 principal amount of junior subordinated debentures by West Penn Power Company from January 1, 1996

through December 31, 1998, and (3) the issuance and sale of up to \$61,834,900 principal amount of junior subordinated debentures by Potomac Edison Company through December 31, 1998. West Penn and Potomac Edison are also public-utility subsidiary companies of Allegheny Power System, Inc. (Rel. 35-26303)
