ENFORCEMENT PROCEEDINGS

CIVIL ACTION FILED AGAINST JOHN NADOLSKI AND OTHERS ALLEGING FINANCIAL FRAUD

The Commission announced the filing of a complaint on August 18 in the U.S. District Court for the Northern District of New York against John S. Nadolski, Thomas J. Blair and Marietta Corporation. Nadolski is Marietta's former president; Blair is Marietta's former chief financial officer.

The complaint alleges that between 1989 and 1991, Nadolski and Blair misrepresented to the public Marietta's financial condition. In furtherance of this scheme, Nadolski and Blair caused false accounting entries to be made, overstating Marietta's sales and understating its expenses. These changes increased Marietta's net income and were reflected in filings with the Commission.

The complaint also alleges insider trading. In November 1989, Marietta conducted a stock offering during which Nadolski and Blair both sold Marietta stock. At the time of these transactions, Nadolski and Blair were aware of material, non-public information about Marietta's financial condition.

The complaint seeks injunctive relief and disgorgement from Nadolski and Blair based on their wrongful sale of Marietta stock, and an officer and director bar. With the filing of the complaint, Marietta consented, without admitting or denying liability, to a permanent injunction. [SEC v. John S. INVESTMENT COMPANY ACT RELEASES

SUNAMERICA SERIES TRUST, ET AL.

An order has been issued on an application filed by SunAmerica Series Trust, et al. under Sections 6(c) and 17(b) of the Investment Company Act exempting applicants from Section 17(a) and Rule 17g-1(b) thereunder. The order permits each investment company that is advised by SunAmerica Asset Management Corp. or managed by Anchor Investment Adviser, Inc. to purchase fidelity bond coverage and/or directors' and officers' errors and omissions insurance from an insurance company that may be an affiliated person of an affiliated person of such investment company solely because the affiliated person is a subadviser to the investment company and settle any claims that may arise in connection with such insurance coverage. The order also permits an investment company to be named as a joint insured on a fidelity bond with the other investment companies, even though the investment company does not meet the requirements of Rule 17g-1(b)(3) under the Act. PROPOSED RULE CHANGES

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE BY THE PHILADELPHIA STOCK EXCHANGE, INC.

A proposed rule change filed by the Philadelphia Stock Exchange, Inc. with the Commission (File No. SR-Phlx-95-54), extending the pilot program for equity and index option specialist enhanced parity split

participations, has become immediately effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934 but does not become operative until August 27, 1995. Publication of the immediate effectiveness order is expected to appear in the <u>Federal Register</u> during the week of August 21. (Rel. 34-36122)
