RULES AND RELATED MATTERS

PUBLICATION OF REGULATORY FLEXIBILITY ACT RULE REVIEW SCHEDULE

The Commission has authorized publication in the <u>Federal Register</u> of a list of rules scheduled for review pursuant to the Regulatory Flexibility Act. The list provides the public with notice that these rules are scheduled for review by the agency and that the public is invited to comment on them. Public comments are due by January 31, 1996. (Rel. ENFORCEMENT PROCEEDINGS

COMMISSION DENIES MOTION BY BENJAMIN SPRECHER TO RECUSE LAW JUDGE

The Commission has denied a motion by Benjamin G. Sprecher to recuse the law judge in an administrative proceeding seeking a penny stock bar against Sprecher. Sprecher claimed that the law judge had displayed bias and prejudice against him by refusing to issue 10 subpoenas he had requested. The Commission found that the law judge's refusal to issue the requested subpoenas did not demonstrate any bias or prejudice, and that Sprecher's request for recusal was therefore meritless. In this order, the Commission also declined to consider the law judge's certified ruling refusing to issue the subpoenas requested by Sprecher, pointing out that the propriety of that ruling could be considered, if Sprecher requests, in the event the Commission is required to consider the merits. CIVIL INJUNCTIVE ACTION AGAINST EXPRESS COMMUNICATIONS, INC., ET AL.

The Commission announced the filing of a civil injunctive action against defendants Express Communications, Inc., Pendleton Waugh, and Communications Marketing Consultants Plus Corp. and relief defendants Personal Communications Corp., PCC Holdings Corp., PCC

Management Corp., and Next Communications, Inc. The Commission alleges that the defendants violated Sections 5 and 17(a) of the Securities Act, Section 10(b) of the Securities Exchange Act, and Rule 10b-5 thereunder. The Complaint also includes an Exchange Act Section 15(a) claim against one of the defendants and seeks disgorgement from four relief defendants controlled by defendant Waugh.

The complaint alleges that the defendants fraudulently sold unregistered securities in the form of investment contracts in two specialized mobile radio (SMR) communications offerings. The alleged fraudulent misrepresentations concern the use of investor proceeds, the control of SMR licenses, projected returns to the investors, valuations of the investments, and the adequacy of capitalization of the offerings. In addition, the Complaint alleges that the defendants made misrepresentations in purchasing and selling Express stock. [SEC v. Express Communications, Inc., Pendleton C.
