# FEE RATE ADVISORY

The current Continuing Resolution on fiscal 1996 funding expires at midnight, Friday, December 15. In the event that the Congress and the Administration do NOT enact a new continuing resolution, the fee rate for registration statements and other filings paid pursuant to Section 6(b) of the Securities Exchange Act of 1933 will revert to 1/50th of one percent of the offering amount. If a new Continuing Resolution is enacted, the Section 6(b) fee rate is expected to continue at the current rate of 1/29th of one percent.

Please be advised that a Continuing Resolution enacted after December 16 may restore the Section 6(b) fee rate to 1/29th of one percent effective as of December 16. In that event, filers who paid 1/50th of one percent would be required to pay an additional amount equal to the difference between the amount paid and 1/29th of one percent of the amount of the offering.

It is possible that formal notice regarding the status of any extension to the current Continuing Resolution may not be available before 8:00 a.m. on Monday, December 18, when the Commission's electronic filing and document receipt activity opens for business. Therefore, filers should contact the Office of Filer Support at (202) 942-8900 to obtain the proper fee rate in effect.

The Commission will issue further notices as appropriate to keep registrants informed of developments affecting the Section 6(b) fee rate. (Press Rel. 95-255)

### RULES AND RELATED MATTERS

# PROPOSED RULEMAKING

The Commission issued a release soliciting public comment on a proposed amendment to Rule 3a12-8 under the Securities Exchange Act of 1934. Rule 3a12-8 exempts certain designated foreign government securities for purposes of trading futures contracts on those securities. The amendment would add the debt securities of Brazil, Argentina and Venezuela to the list of designated foreign government securities that are exempted by Rule 3a12-8.

Publication of the proposed rule amendment is expected in the <u>Federal Register</u> during the week of December 18. (Rel. 34-36580; International Series Rel. 900; File No. S7-34-95)

#### ENFORCEMENT PROCEEDINGS

#### COMPLAINT FILED AGAINST THOMAS COLLINS AND EDWARD COLLINS

The Commission announced the filing of a complaint on December 11 in the U.S. District Court for the Northern District of Illinois against Thomas W. Collins (T. Collins) and Edward M. Collins (E. Collins) for violations of the antifraud, broker-dealer registration

and registration provisions of the federal securities laws. The complaint alleges that from December 1984 to June 1994 1992, T. Collins and E. Collins raised approximately \$120 million from 460 investors for the purchase of securities. In connection with the offer and sale of these securities, the complaint alleges that T. Collins and E. Collins misstated and omitted to state material facts to investors concerning, the use of proceeds, the rate of return and the risk of the investment. The complaint further alleges that investors were told that their funds would be pooled with other investors' funds to invest in commodity futures and other business ventures. Instead of investing all of the money as represented, the complaint alleges that T. Collins and E. Collins were running a Ponzi scheme and that most of investor funds were used to pay personal and business expenses and to pay interest and principal to prior investors. [SEC v. Thomas W. #### EATON VANCE HIGH INCOME TRUST

A notice has been issued giving interested persons until January 8 to request a hearing on an application filed by Connecticut General Life Insurance Company (CG Life), CG Variable Life Insurance Separate Account II (Account), and CIGNA Financial Advisors, Inc. Applicants seek an order pursuant to Section 6(c) of the Investment Company Act exempting them from the provisions of Section 27(c)(2) of the Act and Rule 6e-3(T)(c)(4)(v) thereunder to the extent necessary to permit the deduction of a charge that is reasonable in relation to CG Life's increased federal income tax burden resulting from the receipt of premiums in connection with certain flexible premium variable life insurance contracts issued by CG Life, the Account and any other separate account established in the future by CG Life. MUTUAL FUND GROUP, ET AL.

A notice has been issued giving interested persons until January 8 to request a hearing on an application filed under the Investment Company Act by Mutual Fund Group, et al. for an order that would permit each applicant investment company to enter into deferred compensation arrangements with its trustees who are not employees of affiliated persons of the company. GEORGIA POWER CO.

An order has been issued authorizing a proposal by Georgia Power Company, a wholly owned public-utility subsidiary company of the Southern Company, a registered holding company, to purchase from Florida Power Corporation a one-third undivided ownership interest in the Intercession City Facility Combustion Turbine. GENERAL PUBLIC UTILITIES CORPORATION

A supplemental order has been issued releasing jurisdiction over the specific terms of the issuance and sale of four million additional shares of common stock by General Public Utilities Corporation, a registered holding company. (Rel. 35-26430)

SIGCORP, INC., ET AL.

An order has been issued authorizing SIGCORP, Inc., a wholly owned subsidiary of Southern Indiana Gas and Electric Company (Southern Indiana), an Indiana public-utility holding company exempt from registration under the Public Utility Holding Company Act of 1935, as amended, to acquire all the outstanding common stock of Southern Indiana and, through the acquisition, 33% and 100%, respectively, of the outstanding common stock of Community Natural Gas Company, Inc., and Lincoln Natural Gas Company, both Indiana gas utility companies. Upon consummation of the acquisition, the order exempts SIGCORP under Section 3(a)(1) from all provisions of the Act, except Section (a)(2). (Rel. 35-26431)
