ENFORCEMENT PROCEEDINGS

JAMES EATON BARRED

The Commission today announced the issuance of an Order permanently barring James E. Eaton, by consent, from association with any broker, dealer, municipal securities dealer, investment adviser or investment company. The Commission's order was based upon the entry of an order, on December 9, 1997, by Judge Willis B. Hunt, Jr., of the U.S. District Court for the Northern District of Georgia, enjoining Eaton from future violations of Section 17(a) of the Securities Act of 1933, Section 10(b) of the Exchange Act and Rule 10b-5 thereunder, and Section 15B(c)(1) of the Exchange Act and Rules G-17 and G-20 of the Municipal Securities Rulemaking Board, in the action (SEC v. Richard P. Poirier, Jr., James E. Eaton and Michael S. deVegter, Civil Action No. 1:97-CV-3478-WBH, N.D. Ga. 1997; LR-15565; Nov. 20, 1997).

The Commission's complaint, filed in November 1997, alleged that Eaton, formerly an employee of the municipal finance department of Lazard Freres & Co. LLC, defrauded the Fulton County Commission, the Fulton-DeKalb Hospital Authority and investors in two offerings of municipal securities issued by those bodies. (Rel. 34-39515; File No.1; 3-9524)

INVESTMENT COMPANY ACT RELEASES

EMERALD FUNDS, ET AL.

An order has been issued on an application filed by Emerald Funds, Barnett Capital Advisors, Inc. (Adviser), Rodney Square Management Corporation (Rodney Square), and Brandes investment Partners, L.P. (Brandes) (Brandes and Rodney Square, the Sub-Advisers) under Section 6(c) of the Investment Company for an exemption from Section 15(a) of the Act. The order permits the implementation, without shareholder approval, of new investment advisory and sub-advisory agreements (New Advisory Agreements) for a period of up to 120 days following consummation of a merger between Barnett Banks, Inc. and NationsBank Corporation or a subsidiary of NationsBank Corporation

(but in no event later than May 30, 1998). The order also permits the Adviser and Sub-Advisers to receive all fees earned under the New Advisory Agreements following shareholder approval. (Rel. IC-22990 - December 31)

SELF-REGULATORY ORGANIZATIONS

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

A proposed rule change (SR-NASD-97-96) filed by the <u>National Association of Securities Dealers</u> relating to the hearing process fees on members that are parties to arbitration has become effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. Publication of the proposal is expected in the <u>Federal Register</u> during the week of January 5. (Rel. 34-39504)
