ENFORCEMENT PROCEEDINGS

SCOTT EVANS AND BRIAN WHITE SETTLE INSIDER TRADING CASE

On January 15, the Commission filed an action in federal district court against Scott Evans and Brain White alleging insider trading in the securities of NCR Corporation, an AT&T acquisition target, in violation of the federal securities laws. The complaint alleges that Evans and White were part of a massive insider trading ring based on information supplied by Charles Brumfield, an AT&T labor relations executive, about AT&T's secret acquisition plans. After Evans and White were tipped in November 1990, Evans bought NCR call options for himself, White, and Charles Brumfield's son, Joseph Brumfield. The three made a substantial profit after AT&T announced a tender offer for NCR two weeks later.

Without admitting or denying the Commission's allegations, Evans and White consented to the entry of a proposed judgment simultaneously with the filing of the complaint. The proposed judgment includes a permanent injunction against both defendants. It would also require that Evans disgorge his own unlawful trading profits (\$7,279), be jointly and severally liable with White and Joseph Brumfield for their profits from trading in Evans's account (\$28,407), and pay prejudgment interest. The judgment would require White to disgorge his profits of \$14,261 and pay prejudgment interest. [SEC v. J. Scott Eskind, Civil Actio No. 1:97-CV-1790-CAM, N.D. GA] (LR-15618)

ROBERT BOGUTSKI, FORMER TRANSFER AGENT PRINCIPAL, PERMANENTLY ENJOINED

The Commission announced that on January 14 an Agreed Final Judgment was entered in United States District Court in Dallas, Texas, against Robert Bogutski. Without admitting or denying the allegations in the Commission's complaint, Bogutski consented to the entry of a permanent injunction enjoining him from future violations of the anti-fraud provisions found in Section 10(b) of the Securities Exchange Act of 1934, and Rule 10b-5 thereunder, and transfer agent recordkeeping provisions found in Section 17A(d)(1) and Rule 17Ad-10 thereunder. The complaint alleged that Bogutski, who was president of Idata, Inc., a registered transfer agent, participated in a scheme relating to the offer and sale of Enviromint Holdings, Inc. (EHI) securities. The complaint alleged that Bogutski destroyed Idata's securities transfer records for EHI's predecessor company, and created false or misleading transfer records for EHI. By these activities, the principals of EHI converted shares of the predecessor to themselves and their nominees, and concealed their control of the company. [Securities and Exchange Commission v. INVESTMENT COMPANY ACT RELEASES

SSGA FUNDS AND STATE STREET BANK AND TRUST COMPANY

A notice has been issued giving interested persons until February 9, 1998, to request a hearing on an application filed by Ssga Funds and State Street Bank and Trust Company for an order under Section 6(c) of the Investment Company Act that would exempt applicants from Sections 13(a)(2), 13(a)(3), 18(f)(1), 22(f), and 22(g) of the Act and Rule 2a-7 thereunder, under Sections 6(c) and 17(b) of the Act for an exemption from Sections 17(a)(1) and (2) of the Act, and pursuant to Section 17(d) of the Act and Rule 17d-1 thereunder. The order would permit the applicant investment companies to enter into deferred compensation arrangements with certain of their directors. (Rel. IC-22999 - January 14)

SARATOGA ADVANTAGE TRUST, ET AL.

A notice has been issued giving interested persons until February 9, 1998, to request a hearing on an application filed by Saratoga Advantage Trust, et al. for an order under Section 6(c) of the Investment Company Act exempting applicants from Section 15(a) of the Act and Rule 18f-2 under the Act, and from certain disclosure requirements under the Act. The order would permit the investment adviser to an open-end registered investment company to enter into and materially amend subadvisory contracts without receiving shareholder approval, and grant relief from certain disclosure requirements regarding advisory fees paid to subadvisers. NIKKO RESEARCH CENTER (AMERICA), INC.

A notice has been issued giving interested persons until February 9, 1998, to request a hearing on an application filed by Nikko Research Center (America), Inc. for an order under Section 203A(c) of the Investment Advisers Act. The order would permit Nikko Research

Center (America), Inc. to register with the SEC as an investment adviser, even though it does not have \$25 million of assets under management and might not otherwise meet the criteria for registration with the SEC as an investment adviser. (Rel. IA-1694 -January 15)

ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The <u>National Association of Securities Dealers</u> filed a proposed rule change (SR-NASD-97-94) extending the pilot program of the Short Sale Rule and the amendment to the definition of "legal" short sale. The Commission has granted accelerated approval of the proposed rule change. Publication of the proposal is expected in the <u>Federal</u> <u>Register</u> during the week of January 19.
