COMMISSION ANNOUNCEMENTS

TRADING SUSPENSION IN THE SECURITIES OF STRUTHERS INDUSTRIES, INC.

The Commission announced the single ten-day suspension of over-thecounter trading in the securities of Struthers Industries, Inc. (Struthers) for the period beginning at 9:30 a.m. EST on January 26, 1998 and terminating at 11:59 p.m. EST on February 6, 1998. The Commission temporarily suspended trading in the securities of Struthers because of questions regarding the accuracy of statements and material omissions in a press release issued by Struthers on or about January 12, 1998 to the effect that, among other things: (1) Struthers continues to work closely with representatives of its former auditor, BDO Seidman, to resolve the "disagreement with the SEC" over the value of the IVDS licenses Struthers holds under contract; and (2) Struthers' former auditor strongly believes that Struthers has fairly and accurately valued these licenses. ENFORCEMENT PROCEEDINGS

MOTION FOR RECONSIDERATION DENIED

On September 22, 1997, the Commission (Commissioner Hunt dissenting) sustained NASD disciplinary action against Gerald James Stoiber.

The NASD found that Stoiber violated Article III, Sections 1 and 40 of the NASD's Rules of Fair Practice. The NASD found Stoiber sold securities in the form of promissory notes to thirteen of his securities customers without giving prior written notification to the member which he was associated, American Investment Services, Inc.

Stoiber requested that the Commission reconsider its findings and conclusions. Stoiber asserted that the NASD did not prove that the notes at issue were securities, that the Commission reversed the burden of proof applicable in a self-regulatory organization disciplinary proceeding, and that he was therefore denied due process. The Commission rejected Stoiber's claims. Accordingly, the Commission denied Stoiber's motion for reconsideration. (Rel. 34-39565; File No. 3-8992)

ORDER MAKING FINDINGS AND IMPOSING REMEDIAL SANCTIONS ENTERED AGAINST AUGUST MEZZETTA

The Commission announced that on January 22 it settled an administrative proceeding against August Mezzetta (Mezzetta). Mezzetta, without admitting or denying the Commission's findings, consented to the issuance of the Order barring him from association with any broker, dealer, municipal securities dealer, investment adviser or investment company.

Pursuant to the Order and Mezzetta's Offer of Settlement, the Commission found that on December 5, 1996, in the United States District Court for the District of Connecticut, Mezzetta was convicted of using his position as an investment adviser and fiduciary to embezzle, steal and convert to his own use and the use of others, the money, funds, property, and other assets of an employee benefit plan advised by him, in violation of the Employee Retirement Income Security Act of 1974. Mezzetta's conduct underlying his conviction occurred while he was associated with GB Resources, Inc., a registered investment adviser, and a brokerdealer. On December 5, 1996, Mezzetta was sentenced to imprisonment for a term of 87 months and ordered to pay a special assessment of \$200. On January 9, 1997, Mezzetta was ordered to pay restitution of \$2,819,250. (Rel. 34-39568; IA-1697; File No. 3-9387)

GREAT-WEST LIFE & ANNUITY INSURANCE COMPANY, ET AL.

AMERICAN CENTURY CAPITAL PORTFOLIOS, INC., ET AL.

A notice has been issued giving interested persons until February 13, 1998, to request a hearing on an application filed by American Century Capital Portfolios, Inc., American Century Investment Management, Inc. (Advisor), RREEF Real Estate Securities Adviser, L.P. (Subadvisor), and ROMEO America, L.L.C. (New Subadvisor) pursuant to Section 6(c) of Investment Company Act for relief from Section 15(a) of the Act. The order would permit the implementation, without prior shareholder approval, of a new subadvisory agreement for a period up to 120 days following the later of the acquisition of substantially all the assets of the Subadvisor by the New Subadvisor or the date on which the order is issued, but in no event later than May 27, 1998. The order would also permit the New Subadvisor to receive from the Advisor fees earned under the new subadvisory agreement following shareholder approval. (Rel. IC-23007 - January 22)

COLUMBIA ENERGY GROUP

An order has been issued authorizing a proposal by the Columbia Energy Group, a registered holding company, and its 32 non-utility subsidiaries, to provide consulting services to associate and nonassociate companies on an international basis, to invest up to \$10 million to provide consulting services, to engage in activities contemplated by the Gas Related Activities Act of 1990 on an international basis, and to invest up to \$5 million to acquire oil and natural gas leasehold interests in southern Ontario, Canada.
