COMMISSION ANNOUNCEMENTS

STAFF ACCOUNTING BULLETIN NO. 98

Staff Accounting Bulletin No. 98 revises the views of the staff contained in certain topics of the staff accounting bulletin series to be consistent with the provisions of certain accounting standards recently adopted by the Financial Accounting Standards Board. Topics 1.B.2 and 1.B.3, regarding the allocation of expenses and related disclosure in financial statements of subsidiaries, divisions or lesser business components of another entity, are revised to eliminate instructions to delete historical EPS in the entity's financial statements. Topic 3.A, regarding presentation of supplemental earnings per share in a convertible security registration, is revised to remove the reference to APB Opinion No. 15, Earnings per Share, and remind registrants of the pro forma requirements of Regulation S-X. The guidance regarding the dilutive effects of stock or options and warrants to purchase common stock included in Topic 4.D, Computation of Earnings per Share in an Initial Public Offering (IPO), is revised to instruct registrants to consider the dilutive effect of common stock or options and warrants to purchase common stock issued for nominal consideration (referred to as nominal issuances). Topic 6.B.1, regarding the presentation of income or loss applicable to common stock, is revised to clarify the Topic's continuing applicability to all registrants and to suggest a presentation format for registrants that elect to present a single statement of income and comprehensive Finally, Topic 6.G.1, regarding selected quarterly financial data, is updated to replace the terms "primary" and "fully diluted" with "basic" and "diluted."

INVESTMENT COMPANY ACT RELEASES

AMERICAN ODYSSEY FUNDS, INC., ET AL.

A notice has been issued giving interested persons until February 27 to request a hearing on an application filed by American Odyssey Funds, Inc., et al. for an order under Section 6(c) of the Investment Company Act exempting applicants from Section 15(a) of

the Act and Rule 18f-2 under the Act. The order would permit applicants to enter into and materially amend investment subadvisory agreements without shareholder approval. (Rel. IC-23017 - February 2)

HOLDING COMPANY ACT RELEASES

AMEREN CORPORATION, ET AL.

A notice has been issued giving interested persons until February 20 to request a hearing on a proposal by Ameren Corporation (Ameren), a to-be-formed registered holding company, and its utility and non-utility subsidiaries (Applicants). Applicants propose to engage in various financing and related transactions through January 31, 2003, subject to certain conditions. (Rel. 35-26822)

SELF-REGULATORY ORGANIZATIONS

ACCELERATED APPROVAL OF PROPOSED RULE CHANGES

The Commission granted accelerated approval to a proposed rule change filed by the <u>Chicago Board Options Exchange</u> (SR-CBOE-97-66) providing a definition of foreign broker-dealer. Publication of the proposal is expected in the <u>Federal Register</u> during the week of February 2. (Rel. 34-39604)

The Commission granted accelerated approval to a proposed rule change (SR-Philadep-97-06) filed by the <u>Philadelphia Depository Trust Company</u> granting approval of amendments to Philadep's by-laws to require certain corporate governance changes, including the composition of its board of directors. Publication of the proposal is expected in the <u>Federal Register</u> during the week of February 2. (Rel. 34-39608)

The Commission granted accelerated approval to a proposed rule change (SR-SCCP-97-06) filed by the <u>Stock Clearing Corporation of Philadelphia</u> granting approval of amendments to SCCP's by-laws to require certain corporate governance changes, including the composition of its board of directors. Publication of the proposal is expected in the <u>Federal Register</u> during the week of February 2. (Rel. 34-39609)

The Commission granted accelerated approval to a proposed rule change filed by the <u>National Securities Clearing Corporation</u> (SR-NSCC-97-15) amending NSCC's procedures to eliminate the distribution of odd-lot activity reports. Publication of the proposal is expected in the <u>Federal Register</u> during the week of February 2. (Rel. 34-39611)

APPROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change filed by the <u>Philadelphia Stock Exchange</u> (SR-PHLX-97-42) relating to the Responsibility of Floor Brokers to Represent Orders to the Trading Crowd. (Rel. 34-39606)

The Commission approved a proposed rule change filed by the Philadelphia Stock Exchange (SR-PHLX-97-52) which modifies the PHLX's rules governing options trading rotations to, among other things, require reverse rotations when there is a heavy influx of orders and require floor official approval of second and subsequent trading rotations. Publication of the order is expected in the Federal Register during the week of February 2. (Rel. 34-39610)
