INVESTMENT COMPANY ACT RELEASES

CYPRESSTREE ASSET MANAGEMENT CORPORATION, ET. AL.

A notice has been issued giving interested persons until March 2, 1998, to request a hearing on an application filed by CypressTree Asset Management Corporation, et. al. for an order under Sections 6(c) and 23(c) of the Investment Company Act exempting applicants from certain provisions of Rule 23c-3 under the Act. The order would permit a registered closed-end investment company to make repurchase offers on a monthly basis. (Rel. IC-23020 - February 4)

THE DREYFUS SOCIALLY RESPONSIBLE GROWTH FUND, INC., ET AL.

An order has been issued pursuant to Section 6(c) of the Investment Company Act exempting The Dreyfus Socially Responsible Growth Fund, Inc. (Fund) and The Dreyfus Corporation (Dreyfus) from the provisions of Sections 9(a), 13(a), 15(a) and 15(b) of the Act, and Rules 6e-2(b) (15) and 6e-3(T)(b) (15) thereunder. The exemption will permit shares of the Fund and shares of any other investment company or portfolio thereof that is designed to fund insurance products and for which Dreyfus or any of its affiliates may serve in the future, as investment adviser, administrator, manager, principal underwriter, or sponsor to be sold to and held by separate accounts funding variable annuity and variable life insurance contracts issued by both affiliated and unaffiliated life insurance companies; and qualified pension and retirement plans outside of the separate account context. HOLDING COMPANY ACT RELEASES

OHIO VALLEY ELECTRIC CORPORATION

A notice has been issued giving interested persons until March 2, 1998, to request a hearing on a proposal by Ohio Valley Electric Corporation (Ohio Valley), an electric public utility subsidiary company of American Electric Power Company, Inc., a registered holding company. The proposal would allow Ohio Valley to issue and

sell notes (Notes) to banks in an aggregate amount not to exceed \$50 million outstanding at any one time, through December 31, 2001, provided that no Notes shall mature later than June 30, 2002. (Rel. 35-26823)

ENTERGY LOUISIANA, INC.

A notice has been issued giving interested persons until March 2, 1998, to request a hearing on a proposal by Entergy Louisiana, Inc. (ELI), an electric public-utility subsidiary company of Entergy Corporation, a registered holding company. Under the proposal, ELI could issue and sell through December 31, 2002, one or more new series of (1) first mortgage bonds and debentures up to a combined aggregate principal amount of \$600 million; (2) preferred stock, either \$25 or \$100 par value, and/or interests in a special purpose limited partnership or a statutory business trust, up to a combined aggregate principal amount of \$260 million; and (3) collateral bonds, up to an aggregate amount of \$455 million. IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGES

A proposed rule change (SR-CBOE-98-01) filed by the <u>Chicago Board Options Exchange</u> on January 16, 1998, to change the Order Book Official rate schedule for equity options, has become immediately effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. Publication of the notice is expected in the <u>Federal Register</u> during the week of February 9. (Rel. 34-39618)

The <u>Philadelphia Stock Exchange</u> filed pursuant to Section 19(b)(1) of the Securities Exchange Act of 1934 a proposed rule change (SR-Phlx-98-01) concerning notice to persons who are the subject of an investigative report to the Business Conduct Committee. Publication of the proposal is expected in the <u>Federal Register</u> during the week of February 9. (Rel. 34-39619)

NOTICE OF PROPOSED RULE CHANGES

A proposed rule change (SR-NASD-97-95) has been filed by the National Association of Securities Dealers to Amend Interpretive Material IM-2110-1 and Conduct Rule 2720 to revise certain aspects of the Free-Riding and Withholding Interpretation. Among other things, the proposal clarifies the threshold limits for passive investment in a member firm and amends the Free-Riding and Withholding Rules to provide for appeals of exemption requests to

the National Adjudicatory Council. Publication of the proposal is expected in the <u>Federal Register</u> during the week of February 9. (Rel. 34-39620)

<u>Delta Clearing Corp.</u> filed a proposed rule change (SR-DCC-97-10) under Section 19(b)(2)(A) of the Exchange Act. The proposed rule change will amend DCC's rules to provide for clearing services of repurchase agreement instrument transactions. Publication of the proposal is expected in the <u>Federal Register</u> during the week of February 9. (Rel. 34-39623)
