### ENFORCEMENT PROCEEDINGS

COMMISSION BARS WILLIAM LINCOLN

The Commission has barred William F. Lincoln from participation in any offering of a penny stock and from association with a broker, a dealer, or a member of a national securities exchange or a registered securities association. In 1995, Lincoln was convicted in the United States District Court for the Northern District of Georgia of securities fraud, conspiracy to commit securities fraud, and interstate transportation of monies obtained by fraud.

Lincoln raised various objections to his criminal conviction but the Commission rejected Lincoln's attempts to attack that conviction in this proceeding. The Commission also rejected Lincoln's assertion that this proceeding constituted a second punishment for the same activity and thereby violated the Double Jeopardy Clause of the Constitution. Relying on the Supreme Court's recent decision in <u>Hudson v. United States</u>, the Commission concluded that the sanctions imposed were civil in nature, not criminal, and that the Double Jeopardy Clause did not apply. (Rel. 34-39628; File No. 3-8998)
