INVESTMENT COMPANY ACT RELEASES

MERRILL LYNCH & CO., INC., ET AL.

An order has been issued on an application filed by Merrill Lynch & Co., Inc. (ML & Co.), Merrill Lynch Preferred Funding I, L.P. (First Partnership), and Merrill Lynch Preferred Capital Trust I (First Trust) under Section 6(c) of the Investment Company Act for an exemption from all provisions of the Act. The order permits the First Partnership and the First Trust to sell certain debt securities and use the proceeds to finance the business activities of its parent company, ML & Co., and certain companies controlled by the parent company. INVESTMENT ADVISERS ACT RELEASES

MORELAND MANAGEMENT COMPANY

A notice has been issued giving interested persons until March 9, 1998, to request a hearing on an application filed by Moreland Management Company for an order under Section 202(a)(11)(F) of the Investment Advisers Act. The order would declare Moreland Management Company to be a person not within the intent of Section 202(a)(11) of the Advisers Act, which defines the term "investment adviser." (Rel. IA-1700 - February 12)

HOLDING COMPANY ACT RELEASES

CONSOLIDATED NATURAL GAS COMPANY, ET AL.

A supplemental order has been issued authorizing Consolidated Natural Gas Company, a gas registered holding company, to invest up to an aggregate amount of \$165 million in a foreign gas pipeline, and reserving jurisdiction over related transactions. (Rel. 35-26824; International Series Rel. 1115)

ENTERGY CORPORATION, ET AL.

A notice has been issued giving interested persons until March 9, 1998, to request a hearing on a proposal by Entergy Corporation (Entergy), a registered holding company, and certain wholly owned nonutility subsidiary companies of Entergy. Entergy proposes to form subsidiaries (New Subsidiaries) to hold ownership interests in associate companies that are exempt wholesale generators, foreign utility companies, exempt telecommunications companies, energyrelated companies, other New Subsidiaries and other nonutility (collectively, Nonutility Companies). Entergy businesses and Nonutility Companies propose to issue guarantees in an aggregate amount up to \$750 million through December 31, 2002. Nonutility Companies propose to issue and sell securities to Entergy, other Nonutility Companies and nonassociate companies. Nonutility Companies also propose to issue and pay dividends to their parent companies out of capital or unearned surplus through December 31, 2002, and to engage in related transactions. SELF-REGULATORY ORGANIZATIONS

APPROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change submitted by the <u>American Stock Exchange</u> (SR-Amex-97-44) to increase both position and exercise limits, as well as the firm facilitation exemption, for Institutional Index Options. (Rel. 34-39646)

The Commission approved a proposed rule change filed by <u>The</u> <u>Depository Trust Company</u> (SR-DTC-97-14) that amends DTC's procedures for running call lotteries for book-entry only issues of securities so that DTC will run the lottery using its participants' positions as of the close of business on the day DTC announces the lottery. (Rel. 34-39658)

PROPOSED RULE CHANGES

<u>The Options Clearing Corporation</u> filed a proposed rule change (SR-OCC-97-12) regarding initial and minimum net capital requirements for its members that are also futures commission merchants. Publication of the proposal is expected in the <u>Federal Register</u> during the week of February 16. (Rel. 34-39648)

The Depository Trust Company filed a proposed rule change (SR-DTC-97-22) that will permit DTC to establish an omnibus account at the Canadian Depository for Securities. Publication of the proposal is expected in the <u>Federal Register</u> during the week of February 16. (Rel. 34-39657; International Series Rel. 1116)

IMMEDIATE EFFECTIVE OF PROPOSED RULE CHANGES

<u>The Options Clearing Corporation</u> filed a proposed rule change (SR-OCC-97-18), which became effective upon filing, revising OCC's fee structure to provide for an interim discounted fee schedule for the clearing and trading of new products. Publication of the proposal is expected in the <u>Federal Register</u> during the week of February 16. (Rel. 34-39654)

The National Securities Clearing Corporation filed a proposed rule change (SR-NSCC-97-18), which became effective upon filing, modifying its interpretation on the release of clearing data to regulatory and self-regulatory organizations. Publication of the proposal is expected in the <u>Federal Register</u> during the week of February 16. (Rel. 34-39656)

TEMPORARY APPROVAL OF APPLICATION FOR CLEARING AGENCY REGISTRATION

The Commission has temporarily approved the application of the <u>Emerging Markets Clearing Corporation</u> for clearing agency registration (File No. 600-30).
