#### ENFORCEMENT PROCEEDINGS

MICHAEL MILKEN AND MC GROUP SETTLE CASE ARISING OUT OF MILKEN'S VIOLATION OF COMMISSION BAR ORDER

The Commission announced today the filing of a complaint in the United States District Court for the Southern District of New York against Michael R. Milken and MC Group arising out of Milken's violation of a March 11, 1991 Commission order barring Milken from associating with a securities broker. According to the complaint, Milken established, owns, and controls MC Group, which acted as a broker in connection with two transactions, including a 1995 transaction between MCI Communications Corporation and The News Corporation Limited. The Commission alleges that, through Milken and others, MC Group (a) introduced companies, (b) proposed business arrangements that involved the purchase, sale, or exchange of securities, and (c) participated in negotiations regarding the structure of the transactions and securities to be issued in connection therewith. As payment for these services, MC Group and Milken received transaction-based compensation of \$42 million. Milken and MC Group have consented to the entry of final judgments pursuant to which Milken would be commanded to comply with the Commission's March 11, 1991 order, Milken and MC Group would be

enjoined permanently from violating Section 15(a) of the Securities Exchange Act of 1934, and Milken and MC Group, would be required, jointly and severally, to disgorge \$42 million, plus prejudgment interest of \$5 million.
