ENFORCEMENT PROCEEDINGS

JUDGMENTS ENTERED AGAINST TWO COMMISSION DEFENDANTS

On March 2, the District Court for the Central District of California entered final judgments of permanent injunction against Philip L. Thomas (Thomas) and David V. Sims (Sims) prohibiting future violations of the antifraud provisions of the federal securities laws. Thomas and Sims consented, without admitting or denying the allegations in the Commission's complaint, to the permanent injunctions enjoining them from future violations of the federal securities laws. Litigation is still pending against Rob Nite (Nite), the sole remaining defendant, who is currently incarcerated in federal prison on charges unrelated to the Commission's case.

The Commission filed the complaint in federal district court on September 3, 1997 alleging that Nite, Thomas and Sims violated the antifraud provisions of the federal securities laws by perpetrating a fraudulent investment scheme involving the fictional trading of securities purportedly issued by major international banks. The defendants guaranteed investors returns of \$1 million per week for 40 weeks (\$40 million) on an initial investment of either \$50,000 or \$150,000. The defendants amassed approximately \$3.7 million through the scheme, most of which was used for their own personal benefit, including donations to religious organizations, purchases of luxury automobiles and gifts to family members. SELF-REGULATORY ORGANIZATIONS

ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The <u>Pacific Exchange</u> filed a proposed rule change (SR-PCX-97-39) pursuant to Section 19(b)(3)(A) of the Exchange Act. The proposed rule would allow the exchange to establish the minimum trading increment for bids and offers in options. Publication of the

proposal is expected in the <u>Federal Register</u> during the week of March 16. (Rel. 34-39735)

APPROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change submitted by the Chicago Board Options Exchange (SR-CBOE-97-49) pursuant to Section 19(b)(3)(A) of the Exchange Act. The rule permits the Exchange to establish the minimum trading increment for bids and offers in option contracts. (Rel. 34-39736)

The Commission approved a proposed rule change (SR-OCC-97-11) filed by <u>The Options Clearing Corp.</u> The rule change amends OCC's by-laws to eliminate the requirements in OCC's stock loan/hedge system with respect to the accounts in which stock loan positions must be maintained. PROPOSED RULE CHANGES

The <u>Philadelphia Stock Exchange</u> filed a proposed rule change (SR-Phlx-98-10) to amend the Exchange's procedures for providing automatic price improvement for certain PACE orders. Publication of the proposal is expected in the <u>Federal Register</u> during the week of March 16. (Rel. 34-39740)

The <u>Philadelphia Stock Exchange</u> filed a proposed rule change (SR-PHLX-98-03) which will replace the current text of PHLX Rule 124, "Disputes," with new text stating, among other things, that floor officials may resolve trading disputes occurring on and relating to the trading floor if the dispute is not settled by agreement between the members interested or by vote of the members knowing of the transaction. Publication of the proposal is expected in the <u>Federal Register</u> during the week of March 16. (Rel. 34-39741)

A proposed rule change has been filed by the <u>Philadelphia Stock Exchange</u> (SR-Phlx-97-62) that would require each of its respective trading floor standing committees to consult with its corresponding quality of markets committee on all matters which are to be presented to the Phlx Board of Governors. Publication of the proposal is expected in the <u>Federal Register</u> during the week of March 16. (Rel. 34-39742)

WITHDRAWAL GRANTED

An order has been issued granting the application of Complete Management, Inc. to withdraw its Common Shares, \$.001 Par Value; 8% Convertible Subordinated Debentures, due 2003; and 8% Convertible Subordinated Debentures, due December 15, 2003, from listing and registration on the <u>American Stock Exchange</u>.
