ENFORCEMENT PROCEEDINGS

COMMISSION SETS ASIDE ACTION OF PACIFIC EXCHANGE TO RESTRICT USE OF HAND-HELD BROKERAGE ORDER ROUTING TERMINALS IN TRADING CROWDS

The Commission has set aside action of the Pacific Exchange (PCX) restricting the use of hand-held brokerage order routing terminals (hand-helds) in its options trading crowds. Hand-helds are computer devices which can receive customer orders directly and which may be carried by floor brokers directly into trading crowds, thereby speeding execution of orders.

In September 1995, PCX established a pilot program for use of handhelds in options trading crowds. Interactive Brokers LLC (IB) participated in the pilot program, but subsequently was excluded from the pilot program on the grounds that it was taking orders from off-floor broker-dealers in violation of pilot program rules. Because IB was excluded from the pilot program, PCX prohibited its use of hand-helds on the PCX floor.

IB appealed its expulsion from the pilot program to the Commission, which ruled that the pilot program was never submitted to the Commission for its approval as required by relevant laws and regulations, and therefore was not a valid PCX rule. The Commission held further that the restriction by PCX of IB's use of hand-helds was not pursuant to a valid PCX rule and therefore must be set aside. (Rel. 34-39765; File No. 3-9237)

FORMER ARTHUR ANDERSEN PARTNER CONVICTED ON FRAUD CHARGES IN CONNECTION WITH COLONIAL REALTY LIMITED PARTNERSHIP OFFERING

The Commission and the United States Attorney's Office for the District of Connecticut announced that on March 12 Edmund M. Autuori (Autuori), a CPA and former partner of Arthur Andersen & Co., was convicted by a federal jury on 16 fraud-related counts arising from his work for Colonial Realty Company (Colonial), a former real estate syndicator. The jury found that Autuori knowingly assisted Colonial's principals in marketing investments, including the offering of 1200 limited partnership units in the Colonial

Constitution Limited Partnership (CCLP). While engaged in these marketing efforts, Autuori knew that the investments offered by Colonial could not realize the promised returns. Autuori will be sentenced on May 28. Each of the counts carries a maximum penalty of five years and a \$250,000 fine.

On March 9, 1995, the Commission filed a complaint against Autuori, Jonathan N. Googel, Benjamin J. Sisti, William Candelori, Kevin P. Sisti, Peter J. Curley and Kenneth A. Zak, alleging violations of several antifraud and securities registration provisions of the federal securities laws in connection with Colonial's offering of CCLP units. During the offering period, CCLP interests totaling more than \$30 million were purchased by over 700 investors residing in 28 states and the District of Columbia. Autuori is the sole remaining defendant in the Commission's civil action, which was stayed pending resolution of the criminal trial. [U.S. v. Autori, No. 3:96CR161-ALL, D. Conn.] (LR-15673)

INVESTMENT COMPANY ACT RELEASES

MORGAN STANLEY CAPITAL INVESTORS, L.P. AND MORGAN STANLEY, DEAN WITTER, DISCOVER & CO.

A notice has been issued giving interested persons until April 13, 1998, to request a hearing on an application filed by Morgan Stanley Capital Investors, L.P. and Morgan Stanley, Dean Witter, Discover & Co. (MSDWD) for an order under Sections 6(b) and 6(e) of the Investment Company Act in connection with the formation of limited partnerships and limited liability companies (Partnerships) to be offered to certain key employees and qualified participants of MSDWD. Each Partnership will be an "employees' securities company" within the meaning of Section 2(a)(13) of the Act. (Rel. IC-23067 - March 17)

FRANKLIN FLOATING RATE TRUST, ET AL.

An order has been issued on an application filed by Franklin Floating Rate Trust, et al., under Sections 6(c) and 23(c) of the Investment Company Act for an exemption from certain provisions of Rule 23c-3 under the Act. The order permits certain registered closed-end investment companies to impose early withdrawal charges. (Rel. IC-23068 - March 17)

HOLDING COMPANY ACT RELEASES

CENTRAL POWER AND LIGHT CO., ET AL.

A notice has been issued giving interested persons until April 9, 1998, to request a hearing on a proposal by Central Power and Light

Company, Public Service Company of Oklahoma, Southwestern Electric Power Company and West Texas Utilities Company (Utilities), all of which are public utility subsidiary companies of Central and South West Corporation (CSW), a registered holding company, and Central and South West Services, Inc. (Services), a CSW subsidiary service company, for the Utilities and Services to market the mortgage services of PHH Mortgage Services Corporation, the relocation services of PHH Real Estate Services Corporation, and the mortgage and relocation services of other companies with comparable services and benefits. CONECTIV, INC.

A notice has been issued giving interested persons until April 9, 1998, to request a hearing on a proposal by Conectiv, Inc., a corporation that will register as a public utility holding company under the Public Utility Holding Company Act of 1935, as amended, to present a stockholders rights plan (Plan) to its board of directors (Board) for consideration, and to implement the Plan upon Board approval. SELF-REGULATORY ORGANIZATIONS

APPROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change submitted by the <u>Philadelphia Stock Exchange</u> (SR-Phlx-97-53) to amend its floor procedure advice A-1 regarding displaying best bids and offers. (Rel. 34-39754)

The Commission approved a proposed rule change filed by <u>The Depository Trust Company</u> (SR-DTC-97-09) that will allow DTC to enter into contracts with participants to provide customized custodian, transaction, and related processing services as a part of DTC's existing custody service for certain securities that are not depository eligible. (Rel. 34-39761)

PROPOSED RULE CHANGE

The <u>National Association of Securities Dealers</u> filed a proposed rule change (SR-NASD-98-21) to expand NASD Rule 4613 to permit market makers to display their actual quotation size for all Nasdaq securities. Publication of the proposal is expected in the <u>Federal Register</u> during the week of March 16. (Rel. 34-39760)

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

A proposed rule change filed by the <u>National Association of Securities Dealers</u> has become immediately effective. The rule change proposes to undergo the periodic reclassification of the Nasdaq National Market (NNM) securities into appropriate tier sizes for purposes of determining the maximum size order for a particular

security eligible for execution through Nasdaq's Small Order Execution System. Publication of the proposal is expected in the Federal Register during the week of March 23. (Rel. 34-39762)
