ENFORCEMENT PROCEEDINGS

PERMANENT INJUNCTIONS BY DEFAULT ENTERED AGAINST GARTH POTTS, ROBERT EAMES AND MARK EAMES

The Commission announced that on January 13, 1998, the Honorable J. Thomas Greene, U.S. District Judge for the District of Utah, issued orders of permanent injunction by default against Mark Eames, Robert Eames, and Garth Potts. The Commission's complaint alleged that Mark Eames, Robert Eames, and Garth Potts violated the antifraud provisions of the federal securities laws by making misrepresentations to two investors resulting in the loss of more than \$700,000 to those investors. The false statements included the dissemination of a false financial statement which was used to guarantee a return on an investment. The Commission's complaint also alleged that Mark Eames misappropriated investor funds that were to be used to establish a Hong Kong broker-dealer, and instead used the funds for his personal benefit.

The Commission's complaint, filed May 24, 1994, alleged extensive violations of the Commission's registration, recordkeeping, and net capital rules by San Marino Securities, Inc. (San Marino), Mark Eames, Robert Eames, and Garth Potts. The complaint contended that Mark Eames and Garth Potts were "control persons" of San Marino and caused San Marino to violate the Exchange Act rules governing recordkeeping and net capital. San Marino itself was permanently enjoined by consent on November 14, 1994. [SEC v. San Marino Securities, Inc., et al., USDC UT, Civil Action No. 2:94 CV 529-J] (LR-15693)

FINAL JUDGMENTS OF PERMANENT INJUNCTION ENTERED AGAINST INVESTORS DYNAMICS CORPORATION AND STEVEN DOWN

The Commission announced that on March 26, 1998, the Honorable David Sam, U.S. District Judge for the District of Utah, issued permanent injunctions by consent against Investors Dynamics Corporation (IDC) and Steven L. Down (Down). The Commission's complaint alleged that IDC and Down operated a multilevel marketing pyramid scheme by offering and selling independent consultant memberships in IDC in an unregistered distribution of securities. The complaint also alleged that IDC and Down made fraudulent misrepresentations regarding the potential profit to be expected from an IDC membership, and failed to disclose the risk of market saturation inherent in IDC's pyramid scheme. The complaint, filed March 12, 1996, alleged that at that time IDC was signing up over 100 new members each day and had raised in excess of \$1 million.

The final judgment, to which IDC and Down consented without admitting or denying the allegations of the Commission's complaint, orders that the defendants be permanently enjoined from committing violations of Sections 5(a), 5(c), and 17(a) of the Securities Act of 1933 and from violations of Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder. The court waived disgorgement and determined not to impose civil penalties based on the demonstrated inability of the defendants to pay. [SEC v. Investors Dynamics Corporation and Steven L. Down, USDC UT, Docket No. 2:96CV 0220S] (LR-15694)

INVESTMENT COMPANY ACT RELEASES

INVESCO GLOBAL HEALTH SCIENCES FUND, ET AL.

An order has been issued on an application filed by INVESCO Global Health Sciences Fund, et al. under Section 6(c) of the Investment Company Act for an exemption from Section 19(b) of the Act and Rule 19b-1 under the Act. The order permits the INVESCO Global Health Sciences Fund (Fund) to make up to four distributions of net longterm capital gains in any one taxable year, so long as the Fund maintains in effect a distribution policy calling for quarterly distributions of a fixed percentage of its net asset value. HOLDING COMPANY ACT RELEASES

CENTRAL AND SOUTH WEST CORPORATION, ET AL.

A supplemental order has been issued authorizing Central and South West Corporation (CSW), a registered holding company, to increase its aggregate short-term borrowing limitation from \$1.2 billion to \$2.5 billion. The supplemental order also authorizes current participants in the CSW intrasystem money pool to increase their borrowing limitations. (Rel. 35-26854)
