ENFORCEMENT PROCEEDINGS

ROTHSCHILD INVESTMENT CORPORATION CONSENTS TO A CEASE-AND-DESIST ORDER AND A \$15,000 CIVIL PENALTY

The Commission announced that it entered an Order Instituting Public Administrative and Cease-and-Desist Proceedings, Making Findings and Imposing Sanctions Pursuant to Sections 203(e) and 203(k) of the Investment Advisers Act (Order) against Rothschild Investment Corporation (Rothschild), a dually registered investment adviser and a broker-dealer. Without admitting or denying the Commission's findings, Rothschild consented to the issuance of the Order.

The Order finds that, during 1994 and 1995, Rothschild effected approximately 3,750 riskless principal transactions with its advisory clients without disclosing these transactions to, or obtaining the consent of, those clients. Moreover, although Rothschild did disclose in Part II of its Form ADV that it engaged in principal transactions with advisory clients, it did not give its clients a copy of Part II. Instead, Rothschild provided a brochure which failed to disclose that Rothschild engaged in principal

transactions with its advisory clients. As a result, the Order finds that Rothschild violated Sections 204 and 206(3) of the Investment Advisers Act and Rule 204-3 promulgated thereunder. The Order orders Rothschild to cease and desist from committing or causing violations of the federal securities laws and to pay a civil penalty of \$15,000. (Rel. IA-1714; File No. 3-9577)

PROCEEDINGS INSTITUTED AGAINST STEVEN DOWN

The Commission instituted proceedings against Steven L. Down pursuant to Section 203(f) of the Investment Advisers Act. The Order sets a public hearing, at a time and place to be fixed and before an Administrative Law Judge, for the purposes of taking evidence on the question of whether Down should be sanctioned based upon the entry of a civil injunction against him in SEC v. Investors Dynamics Corporation and Steven L. Down.

The Commission's complaint in the civil action alleged that from October 1994 through March 1996, Down offered and sold unregistered securities in the form of a pyramid marketing plan. The Commission's complaint also alleged that in marketing these securities Down fraudulently: exaggerated earnings projections by stating participants in the program could earn \$1,000 per week; failed to disclose the risk of market saturation which arose as a result of the pyramid nature of IDC's membership program with the consequent risk that latecomers to the pyramid program might not realize the same returns received by prior members; and failed to disclose that Down had received virtually all the net profit of the company in the form of putative loan repayments or other compensation. CIVIL ACTION AGAINST GEORGE WALLACE STEWART, ET AL.

Today, the Commission filed a complaint in federal court in Manhattan charging five individuals and five related entities with fraudulently obtaining more than \$1.7 million, from at least three individuals, through offering and selling securities in the form of participations in investment programs purportedly to trade "prime bank" instruments. The complaint alleges that the defendants claimed that they operated investment programs that successfully bought and traded financial instruments issued by the world's largest banks. These instruments were described variously as medium-term bank notes, stand-by letters of credit, and prime bank quarantees. The trading was to result in spectacular profits for investors--returns of ten to fifty times their initial investments in two months to two years--at no risk. The investment programs were scams, the instruments themselves boqus. Instead of using the money as promised, the defendants misappropriated the investors' funds for their own benefit, transferring portions of the money to at least one individual and three entities, who were named as relief defendants.

The complaint charges that the defendants, through their respective roles in the investment schemes, violated the antifraud provisions

of 1933 and Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder. As to the defendants, the SEC seeks permanent prohibitory injunctions, disgorgement of their ill-gotten gains plus prejudgment interest, and civil money penalties. As to the relief defendants, the SEC seeks return of the investors' funds that they received and prejudgment interest thereon. [SEC v. George Wallace Stewart, Patrick J. Madden, Allen B. INVESTMENT COMPANY ACT RELEASES

STATE STREET BANK AND TRUST COMPANY

A notice has been issued giving interested persons until May 8, 1998 to request a hearing on an application filed by State Street Bank and Trust Company for an order pursuant to Sections 6(c) and 17(b) of the Investment Company Act exempting applicant from Sections 17(a)(1) and 17(a)(2) of the Act. The requested order would permit applicant to engage in repurchase agreements and affiliated with certain registered management transactions (Funds) for which applicant investment companies serves custodian. Applicant will be an affiliated person, or an affiliated person of an affiliated person, of a Fund solely by reason of applicant's owning, controlling, or holding 5% or more (but less than 20%) of the outstanding voting securities of the Fund. requested order would not extend to transactions between applicant and a Fund when applicant or an affiliated person of applicant is the investment adviser to the Fund. The Commission approved a proposed rule change (SR-Amex-97-48) filed by the <u>American Stock Exchange</u> to approve the listing and trading of index warrants based on the Merrill Lynch 1998 Equity Focus Index. (Rel. 34-39853)
