COMMISSION ANNOUNCEMENTS

MOU BETWEEN SEC AND THE GERMAN BUNDESAUFSICHTSAMT FUR DEN WERTPAPIERHANDEL

On October 17, 1997, SEC Chairman Arthur Levitt and Georg Wittich, President of the German Bundesaufsichtsamt fur den Wertpapierhandel (BAWe), signed a Memorandum of Understanding Concerning Consultation and Cooperation in the Administration and Enforcement of Securities Laws. This is the first MOU the BAWe signed with a securities commission outside of the European Union. (International Series Rel. 1129)

ENFORCEMENT PROCEEDINGS

COMMISSION OBTAINS TRO AND ASSET FREEZE AGAINST PROMOTERS OF OFFERING FRAUD

The Commission announced that on April 14 the U.S. District Court for the District of Massachusetts unsealed a previously entered emergency order temporarily restraining Edward J. Paradis, Jr., and Walter R. Snyder, Jr., from continuing a fraudulent investment scheme in violation of the federal securities laws. The order also freezes the assets of Paradis and Snyder.

The Commission's complaint alleges that Paradis and Snyder obtained \$175,000 from an investor, promising him a return of over 300% in stock and cash within thirty days. They falsely told the investor that his money would be safely held in Snyder's attorney escrow account until completion of a "financing" transaction that would produce the 300% profit. Contrary to their promises to the investor, however, Paradis and Snyder began removing the investor's funds as soon as the funds arrived in Snyder's account, and have misappropriated at least \$144,000 to date, using it for purposes such as paying Paradis's rent. The complaint alleges that even after the money was misappropriated, Paradis assured the investor that the completion of the transaction was imminent.

In addition to temporarily restraining and freezing the assets of

Paradis and Snyder, the Court's order requires them to file sworn accountings, orders the repatriation of investor funds abroad and grants other emergency relief. The Commission filed its complaint on April 13 on an emergency <u>ex parte</u> basis.

Both Paradis and Snyder are charged with violating the antifraud provisions of the federal securities laws, Section 17(a) of the Securities Act of 1933 and Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder. In its complaint the Commission also seeks a permanent injunction, disgorgement of Paradis' and Snyder's ill-gotten gains and civil monetary penalties. [SEC v. Edward J. Paradis Jr. and Walter R. INVESTMENT COMPANY ACT RELEASES

LEHMAN BROTHERS INC.

A notice has been issued giving interested persons until May 7, 1998, to request a hearing on an application filed by Lehman Brothers Inc. (Lehman) for an order under Section 12(d)(1)(J) of the Investment Company Act exempting PIES Trusts for which Lehman will serve as a principal underwriter (Trusts) from Section 12(d)(1) of the Act; under Section 6(c) of the Act exempting the Trusts from Section 14(a) of the Act; and under Section 17(b) of the Act exempting Lehman and the Trusts from Section 17(a) of the Act. The requested order would permit other registered investment companies, and companies excepted from the definition of investment company under sections 3(c)(1) and (c)(7) of the Act, to own a greater percentage of the total outstanding voting stock (Securities) of each Trust than that permitted by Section 12(d)(1); exempt the Trusts from the initial net worth requirements of Section 14(a); and permit the Trusts to purchase U.S. government securities from Lehman at the time of a Trust's initial issuance of Securities. MORGAN STANLEY CAPITAL INVESTORS, L.P. AND MORGAN STANLEY, DEAN WITTER, DISCOVER & CO.

An order has been issued under Sections 6(b) and 6(e) of the Investment Company Act on an application filed by Morgan Stanley Capital Investors, L.P. and Morgan Stanley, Dean Witter, Discover & Co. for an exemption from all provisions of the Act except Section 9, certain provisions of Section 17 (other than certain provisions of paragraphs (a), (d), (e), (f), (g) and (j)), Section 30 (other than certain provisions of paragraphs (a), (b), (e) and (h)), Sections 36 through 53, and the rules and regulations thereunder. The order permits the formation of certain partnerships that will be "employees' securities companies" within the meaning of Section 2(a)(13) of the Act. (Rel. IC-23111 - April 14)

SELF-REGULATORY ORGANIZATIONS

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGES

MBS Clearing Corporation filed a proposed rule change (SR-MBSCC-97-09), which became effective upon filing, revising MBSCC's fee schedule to add fees for late payment of participants' obligations. Publication of the proposal is expected in the Federal Register during the week of April 13. (Rel. 34-39849)

<u>Delta Clearing Corp.</u> filed a proposed rule change (SR-DCC-98-02), which became effective upon filing, relating to the authorization of Tullet & Tokyo Securities, Inc. to participate as a broker for overthe-counter U.S. treasury options trades. Publication of the proposal is expected in the <u>Federal Register</u> during the week of April 13. (Rel. 34-39850)

A proposed rule change filed by the <u>American Stock Exchange</u> (SR-Amex-98-14) to trade options on a Computer Hardware Index, a new index developed by the Amex based on the stocks of companies engaged in the design and production of commercial and consumer personal computers and systems, has become effective immediately upon filing. Publication of the proposal is expected in the <u>Federal Register</u> during the week of April 20. (Rel. 34-39854)

APPROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change filed by <u>The Depository Trust Company</u> (SR-DTC-97-12) that allows DTC to establish an investor's voluntary redemption and sales service that will enable participants to redeem or sell units in unit investment trusts through DTC's participant terminal system. (Rel. 34-39852)

The Commission approved a proposed rule change (SR-PCX-97-07) filed by the <u>Pacific Exchange</u> relating to position and exercise limits. (Rel. 34-39855)

The Commission approved a proposed rule change (SR-NASD-97-20) filed by the <u>National Association of Securities Dealers</u> which amends NASD Rule 6440 to (1) allow members to accept stop orders in eligible securities; and (2) eliminate the requirement that the stop price equal the limit price in order for a member to accept a stop limit order in an eligible security. Publication of the order is expected in the <u>Federal Register</u> during the week of April 20. (Rel. 34-39857)

PROPOSED RULE CHANGE

The <u>Philadelphia Stock Exchange</u> filed a proposed rule change (SR-Phlx-97-63) relating to the calculation of margin requirements for foreign currency options. Publication of the proposal is expected in the <u>Federal Register</u> during the week of April 20. (Rel. 34-39856)
