ENFORCEMENT PROCEEDINGS

ADMINISTRATIVE PROCEEDING INSTITUTED AGAINST JEFFREY LOBEL

The Commission issued an Order on April 22 instituting a public administrative proceeding pursuant to Sections 15(b)(6) and 19(h) of the Exchange Act against Jeffrey A. Lobel (Lobel). Lobel simultaneously consented to the entry of an order barring him from association with any broker, dealer, municipal securities dealer, investment adviser or investment company, with the right to reapply, after a period of five years.

The administrative proceeding was based on the entry of an April 14, 1998 consent judgment, enjoining Lobel from future violations of the registration and antifraud provisions of the Securities Act and Exchange Act. The complaint alleged that from approximately July 1, 1993 to May 15, 1995, Lobel and others fraudulently offered and sold nine-month promissory notes (Notes) issued by Direct Participation Services, Inc. d/b/a Government Financial (GF), raising about \$26 million from approximately 750 investors. The complaint alleged that Lobel and others misrepresented information to investors concerning: (a) the duties performed by a purportedly independent trustee, (b) the percentage of accounts receivable payable by governmental entities, (c) Noteholders' security interest in assets acquired by GF, (d) existence of credit insurance, and (e) the use of proceeds for related party transactions. The complaint also alleged that GF failed to register the Notes with the Commission. [SEC v. Direct Participation Services, Inc. dba Government Financial, Jeffrey A. BROKER SETTLES ALLEGATIONS THAT HE RECEIVED KICKBACKS

The Commission announced that a stockbroker, previously charged with receiving kickbacks in exchange for selling certain securities to his clients, has settled the charges against him. On September 27, 1996, the Commission filed a complaint in U.S. District Court for the Middle District of Florida alleging that a group of stock promoters engaged in an 18-month fraudulent scheme in which they

paid \$477,580 in kickbacks to seven stockbrokers to induce them to retail certain securities to their customers. The complaint further alleges that the stockbrokers defrauded their customers by failing to disclose to the customers that they were receiving these kickbacks.

The settling stock broker is Michael Cardascia, (Cardascia), age 32, of Manhasset, New York. During the period Cardascia was alleged to have received the illegal payments, he was employed by Corporate Securities Group, Inc., a broker-dealer registered with the Commission.

Cardascia consented, without admitting or denying the allegations in the complaint, to the issuance of a Final Judgment by Judge Patricia C. Fawsett of the United States District Court for the Middle District of Florida enjoining him from future violations of Section 17(a) of the Securities Act of 1933 and Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5 -- the "antifraud" provisions of the federal securities laws. The amount of any disgorgement, prejudgment interest and civil penalties to be paid by Cardascia is yet to be determined.

INVESTMENT COMPANY ACT RELEASES

THE GUARDIAN INSURANCE AND ANNUITY COMPANY, INC., ET AL.

An order has been issued pursuant to Section 6(c) of the Investment Company Act exempting The Guardian Insurance and Annuity Company, Inc., The Guardian Separate Account B, The Guardian Separate Account C, The Guardian Separate Account K, The Guardian Separate Account M, The Guardian Cash Fund, Inc., The Guardian Bond Fund, Inc., The Guardian Stock Fund, Inc., GIAC Funds, Inc., Gabelli Capital Series Funds, Inc. (the Funds), Guardian Investor Services Corporation (GISC) and Guardian Baillie Gifford Limited (GBGL) from the provisions of Sections 9(a), 13(a), 15(a), and 15(b) of the Act, and Rules 6e-2(b)(15) and 6e-3(T)(b)(15) thereunder, to the extent necessary to permit shares of the Funds and shares of any other investment company or portfolio that is designed to fund insurance products and for which GISC or GBGL, or any of their affiliates, may serve as investment adviser, administrator, manager, principal underwriter or sponsor to be sold to and held by: (a) variable

annuity and variable life insurance separate accounts of both affiliated and unaffiliated life insurance companies, and (b) qualified pension and retirement plans outside the separate account context. (Rel. IC-23121 - April 21)

LORD ABBETT INVESTMENT TRUST, ET AL.

An order has been issued on an application filed by Lord Abbett Investment Trust, et al. under Section 12(d)(1)(J) of the Investment Company Act for an exemption from Section 12(d)(1)(G)(i)(II) of the Act and pursuant to Section 17(d) of the Act and Rule 17d-1 under the Act. The order permits a fund of funds relying on Section 12(d)(1)(G) to make investments in equity and debt securities and permits applicants to enter into certain expense sharing arrangements. (Rel. NATIONS FUND TRUST, ET AL.

A notice has been issued giving interested persons until May 13, 1998, to request a hearing on an application filed by Nations Fund Trust, et al. for an order under Section 17(b) of the Investment Company Act granting an exemption from Section 17(a) of the Act. The order would permit certain series of Nations Fund Trust, Nations Fund, Inc. and Nations Institutional Reserves to acquire all of the assets and liabilities of all of the series of Emerald Funds. Because of certain affiliations, applicants may not rely on Rule 17a-8 under the Act. (Rel. IC-23124 - April 22)

FREEDOM MUTUAL FUND, ET AL.

A notice has been issued giving interested persons until May 14, 1998, to request a hearing on an application filed by Freedom Mutual Fund, et al. for an order under Section 6(c) of the Investment Company Act. The order would exempt applicants from Section 15(a) of the Act to permit the implementation, without prior shareholder approval, of new investment advisory agreements, for a period of up to 150 days following the later of: (i) the date the assignment of the existing investment advisory agreements is deemed to have occurred, or (ii) the date the requested order is issued (but in no event later than October 31, 1998), and to permit the investment adviser to certain registered management investment companies to receive all fees earned under the new agreements during this interim period.
