COMMISSION ANNOUNCEMENTS

COLLEEN MAHONEY NAMED ACTING GENERAL COUNSEL

Chairman Levitt today named Colleen P. Mahoney Acting General Counsel. Ms. Mahoney, currently the Commission's Deputy Enforcement Director, will leave that post on May 11, 1998 and serve as General Counsel until a permanent General Counsel is named. Ms. Mahoney succeeds Richard Walker, who will take over the Commission's Division of Enforcement on May 5, 1998. (Press Rel. 98-43)

ENFORCEMENT PROCEEDINGS

COMMISSION SANCTIONS FORMER PRESIDENT OF BROKER-DEALER

The Commission has issued an Order Instituting Public Proceedings, Making Findings and Imposing Remedial Sanctions against R. James Brower (Brower), the former president and compliance officer of a broker-dealer in Charlotte, North Carolina. The order instituting public proceedings alleged that Brower participated in free riding transactions and that while he was the broker-dealer's president, compliance officer, and financial principal, he failed adequately to monitor the value of securities supporting the broker-dealer's net capital. The Commission accepted the Offer of Settlement of Brower in which, without admitting or denying the Commission's findings, except for findings pertaining to the jurisdiction of the Commission, he consented to an order suspending him from association with any broker, dealer, investment adviser, investment company or municipal securities dealer for a period of 12 months. Pursuant to his consent, Brower was also ordered by the Commission to cease and desist from committing or causing any violation or future violation of Sections 10(b) and 15(c)(3) of the Securities Exchange Act of 1934 (Exchange Act) and Rules 10b-5 and 15c3-1 thereunder. Brower was ordered to pay a civil money penalty of five thousand dollars and to pay disgorgement and prejudgment interest of sixteen thousand two hundred fifty-five dollars and twenty-eight cents. ROY MATLOCK AND ALAN ROOT INDICTED FOR FRAUD

The Commission and the Acting United States Attorney for the Northern District of Illinois announced that on March 18, 1998, Roy Matlock (Matlock) was indicted on seven counts of mail, wire and securities fraud and conspiring to commit those crimes. Matlock, a former registered representative living in Kingsport, Tennessee, is accused of defrauding various investors out of over \$3.6 million.

On April 8, a superseding indictment was returned naming Alan Root (Root), Matlock's business partner, for his role in the fraud. Root, formerly of Orland Park, Illinois, is expected to plead guilty on May 6th. [U.S. v. Roy Matlock and Alan Root, Criminal case #98 CR 172, N.D. Ill.] (LR-15722)

COMMISSION COMPLAINT NAMES SEVEN IN MARKET MANIPULATION SCHEME INVOLVING TWO MICROCAP STOCKS

The Commission announced today that on April 27 it filed a complaint in an action involving unregistered distributions of two stocks, Technigen Corporation of Vancouver, British Columbia, and TV Communications Network, Inc. of Englewood Colorado. The complaint further alleges that certain of the defendants engaged in manipulative trading, including matched trades and trading through nominee accounts, to support the market price of both stocks while the distributions were ongoing. The Commission's complaint, which seeks injunctive relief, disgorgement and penalties, names as defendants Techniqen and its former president Lawrence J. Nesis of Vancouver, British Columbia, Douglas E. Mallach of Aurora, Colorado, Sovereign Equity Management Corporation of Boca Raton, Florida and its president Glen T. Vittor, and Morton J. Glickman of Ontario, Canada. [SEC v. Technigen Corporation, et al., Civ. Action No. 98-S-933, D. Colo.] (LR-15723)

TED MONG SENTENCED TO 15 TO 35 YEARS ON CONVICTION OF 78 COUNTS OF CRIMINAL LAW VIOLATIONS

The Commission announced that on April 16 Ted E. Mong (Mong) was convicted by a Licking County, Ohio jury on 78 counts of Ohio criminal law violations. Mong was convicted of securities fraud, receiving stolen property, engaging in a pattern of corrupt activity, selling unregistered securities and acting as an unlicensed dealer of securities in violation of the Ohio Revised Code. On April 23, the Court sentenced Mong to a prison term of 15 to 35 years.

The charges against Mong stemmed from his sale of promissory notes to investors through certain corporations under his control, including McKenzie-Matthew, Inc. (McKenzie) and Liberty Bell Association, Inc. (Liberty Bell). The Ohio indictment charged that Mong made such sales through fraudulent representations and practices. The Commission, in its action against Mong pending in the United States District Court for the Southern District of Ohio, also alleges that Mong raised more than \$1.6 million from Liberty

Bell and McKenzie investors by misrepresenting the risk of investing, the return investors would receive and the use of investor proceeds. The Commission has alleged that Mong's conduct violated the antifraud provisions and the broker-dealer registration provisions of the federal securities laws. [State of Ohio v. Theodore Mong, Common Pleas Court, Licking County, Ohio, Case No. 97 CR 207]; [SEC v. Ted E. Mong, et al., S.D. Ohio, Case No. C2-96-989] (LR-15724)

INVESTMENT COMPANY ACT RELEASES

COREFUNDS, INC. AND CORESTATES INVESTMENT ADVISERS, INC.

An order has been issued on an application filed by CoreFunds, Inc. (Fund) and CoreStates Investment Advisers, Inc. (Adviser) under Section 6(c) of the Investment Company Act exempting applicants from Section 15(a) of the Act. The order permits the implementation, without prior shareholder approval, of an interim investment advisory agreement and sub-advisory agreements (Interim Agreements) between the Fund and the Adviser and sub-advisers, in connection with the merger of CoreStates Financial Corp. with and into First Union Corporation. The order covers a period of up to 150 days following the date of the consummation of the merger (but in no event later than September 30, 1998) (Interim Period). The order approval, to receive all fees earned under the Interim Agreements during the Interim Period. (Rel. IC-23132 - April 28)

HOLDING COMPANY ACT RELEASES

AMERICAN ELECTRIC POWER COMPANY, ET AL.

A memorandum opinion and order has been issued by the Commission authorizing American Electric Power (AEP) to invest financing proceeds in exempt wholesale generators and foreign utility companies in amounts which, when added to existing investments in these entities, would not exceed 100% of AEP's consolidated retained earnings. SELF-REGULATORY ORGANIZATIONS

APPROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change (SR-CBOE-97-50) filed by the <u>Chicago Board Options Exchange</u> relating to "go along" orders. (Rel. 34-39923)

ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission approved on an accelerated basis a proposed rule change filed by <u>The Depository Trust Company</u> (SR-DTC-98-01) that amends DTC's rules to make them consistent with the revisions to Article 8 of the Uniform Commercial Code of the State of New York. (Rel. 34-39924)

PROPOSED RULE CHANGE

The <u>Chicago Board Options Exchange</u> filed a proposed rule change (SR-CBOE-97-67) to amend the CBOE's margin rules to, among other things: (i) expand the types of short positions that would be considered "covered" in a cash account; (ii) recognize butterfly and box spreads as strategies for purposes of margin treatment and establish appropriate margin requirements; (iii) recognize various strategies involving stocks (or other underlying instruments) paired with long options, and provide for lower maintenance margin requirements on such hedged stock positions; and (iv) permit the extension of credit on certain long term options and certain long box spreads. Publication of the proposal is expected in the <u>Federal Register</u> during the week of May 4. (Rel. 34-39925)

An order has been issued granting the application of the <u>American</u> <u>Stock Exchange</u> to strike from listing and registration Digital Communications Technology Corporation, Common Stock, \$0.0002 Par Value. (Rel. 34-39927)
