COMMISSION ANNOUNCEMENTS

LYNN TURNER NAMED NEW SEC CHIEF ACCOUNTANT

Chairman Levitt today announced the appointment of Lynn Turner as the Commission's Chief Accountant. Mr. Turner, who succeeds Michael Sutton, will join the Commission on July 1, 1998.

Arthur Levitt said, "Lynn has worked at the SEC, as an auditor, as a standard setter, and most recently as the CFO of a high-tech company. He has sat on all four sides of the table, giving him a keen understanding of the various and sometimes competing needs and views of the participants in the financial reporting process. This unique background, combined with a zeal for fairness and transparency, will make Lynn an effective advocate for investors. I am pleased to welcome him back to the Commission."

"I am excited about the challenges of the new position and look forward to rejoining the SEC," said Lynn Turner. "I feel my experience in the private sector -- both as CFO of an international high-technology company and as a Coopers & Lybrand audit partner -will enable me to forge strong relationships with all constituencies."

As Chief Accountant, Mr. Turner will manage a number of important accounting issues, including the development and coordination of international accounting standards and professional independence issues.

Since 1996, Mr. Turner has served as Chief Financial Officer and Vice President of Symbios, Inc., a Colorado-based manufacturer of semiconductors and storage systems. Prior to that he was a partner at Coopers & Lybrand, where he was designated as an SEC Consulting partner. He also was appointed as the National Practice Leader for the Coopers & Lybrand High Technology Audit Practice, with responsibility for more than 1,000 professionals. Mr. Turner has worked on various industry task forces, including the AICPA Task Force on Accounting for Software Revenue Recognition. From 1989 to 1991, he served as a Professional Accounting Fellow at the Securities and Exchange Commission, where he focused on oversight of the professional standard setting practice. And from 1976 to 1989 Turner served in various auditor and management positions at Coopers & Lybrand.

Mr. Turner received his M.A. in Accounting from the University of Nebraska and his B.A. in Business Administration from Colorado State University. He is a member of the AICPA and the Financial Executives Institute. (Press Rel. 98-46)

(Applicant) pursuant to Section 12(h) of the Securities Exchange Act of 1934, as amended (Exchange Act) for an order exempting the Applicant from the provisions of Section 16 of the Exchange Act with respect to its ownership of and transactions in units of limited partnership interest of Summit Properties Partnership, L.P. (Rel. 34-39962; File No. 81-926)

ENFORCEMENT PROCEEDINGS

ADMINISTRATIVE PROCEEDINGS ENTERED AGAINST JEAN YAWN

The Commission has entered an Order Instituting Administrative Proceedings pursuant to Sections 15(b) and 19(h) of the Securities Exchange Act of 1934, Making Findings and Imposing Remedial Sanctions (Order) against Jean M. Yawn, formerly of Fort Lauderdale, Florida. The Commission simultaneously accepted Yawn's Offer of Settlement, in which she agreed to be permanently barred from association with any broker, dealer, municipal securities dealer, investment adviser, or investment company, while neither admitting nor denying the allegations in the proceeding. The Order alleges that from least December 1994 to Auqust 1996, at Yawn misappropriated \$306,500 from the estate account of a deceased client and deposited the funds into her own personal account for her own use. On July 7, 1997, Yawn pled guilty to one count of grand theft in the first degree. On December 17, 1997, Yawn was convicted and sentenced to 21 months in prison (State of Florida v. Jean M. Yawn, Case No. 96-20199 CF, Dec. 1997). (Rel. 34-39961; File No. 3-9600)

INVESTMENT COMPANY ACT RELEASES

LIBERTY VARIABLE INVESTMENT TRUST, ET AL.

An order has been issued on an application filed by Liberty Variable Investment Trust, Liberty Asset Management Company, and Liberty Advisory Services Corp. under Section 6(c) of the Investment Company Act exempting applicants from Section 15(a) of the Act and Rule 18f-2 under the Act. The order permits applicants to enter into and materially amend subadvisory agreements without obtaining shareholder approval. (Rel. IC-23170 - May 5)

SANFORD C. BERNSTEIN FUND, INC., ET AL.

An order has been issued on an application filed by Sanford C. Bernstein Fund, Inc. and Sanford C. Bernstein & Co., Inc. under Section 17(d) of the Investment Company Act and Rule 17d-1 under the Act. The order permits certain registered open-end management investment companies to deposit their uninvested cash balances in a joint account to be used to enter into short-term investments. (Rel. IC-23171 - May 5)

OPPENHEIMER SERIES FUND, INC., ET AL.

A notice has been issued giving interested persons until June 1, 1998, to request a hearing on an application filed by Oppenheimer Series Fund, Inc., et al. for an order under Section 17(b) of the Investment Company Act granting an exemption from Section 17(a) of the Act. The order will permit certain series of Oppenheimer Series Fund, Inc. and Oppenheimer Integrity Funds, both registered open-end management investment companies, to acquire the assets and liabilities of certain series of Oppenheimer Series Fund, Inc. Because of certain affiliations, applicants may not rely on Rule 17a-8 under the Act. (Rel. IC-23172 - May 5)

REICH & TANG DISTRIBUTORS, INC., ET AL.

An order has been issued on an application filed by Reich & Tang Distributors, Inc. (Sponsor) and Equity Securities Trust, Asset Allocation Trust (Series 1 and Subsequent Series) (Trust) under Section 12(d)(1)(J) of the Investment Company Act. The order grants an exemption from Section 12(d)(1)(F)(ii) of the Act, under Sections 6(c) and 17(b) of the Act granting an exemption from Section 17(a) of the Act, and under Section 6(c) of the Act granting an exemption from Sections 14(a) and 19(b) of the Act and Rule 19b-1 under the Act. The order permits each series of the Trust to offer its shares to the public with a sales load that exceeds the 1.5% limit of Section 12(d)(1)(F)(ii), the Trust to invest in affiliated registered investment companies within the limits of Section 12(d)(1)(F) of the Act, units of the Trust to be publicly offered without requiring the Sponsor to take for its own account or place with others \$100,000 worth of units in the Trust, and the Trust to distribute capital gains resulting from the sale of portfolio securities within a reasonable time after receipt. PROPOSED RULE CHANGES

<u>The Depository Trust Company</u> filed a proposed rule change (SR-DTC-98-03), which became effective upon filing, amending DTC's fees and charges. Publication of the proposal is expected in the <u>Federal</u> <u>Register</u> during the week of May 5. (Rel. 34-39946)

The <u>Chicago Stock Exchange</u> filed a proposed rule change (SR-CHX-98-01) relating to the stopping of market and marketable limit orders. Publication of the order is expected in the <u>Federal Register</u> the week of May 11. (Rel. 34-39956)

The <u>National Association of Securities Dealers</u> filed a proposed rule change (SR-NASD-98-34) to allow hearing officers to oversee procedures involving cancellations and suspensions related to failure to comply with an arbitration award. The <u>American Stock Exchange</u> filed a proposed rule change (SR-AMEX-98-16) to permit closing rotations in equity options to be announced after 4:02 p.m. Publication of the notice in the <u>Federal Register</u> is expected during the week of May 11. (Rel. 34-39959)

The Commission approved a proposed rule change (SR-NASD-97-92) submitted by the <u>National Association of Securities Dealers</u> to require members to update firm contact information electronically, to maintain electronic mail account and making certain technical amendments to correct misprints in earlier filings. The Commission approved a proposed rule change filed by <u>The</u> <u>Depository Trust Company</u> (SR-DTC-97-17) that modifies DTC's coupon collection service to include corporate bearer bonds in addition to municipal bearer bonds. (Rel. 34-39960)
