#### ENFORCEMENT PROCEEDINGS

PERMANENT INJUNCTION AND OTHER RELIEF ORDERED AGAINST MARSHALL MELTON AND ASSET MANAGEMENT & RESEARCH, INC.

On May 4, the Honorable William L. Osteen, Sr., United States District Judge for the Middle District of North Carolina, entered an order of permanent injunction and other relief as to defendants Marshall E. Melton (Melton) and Asset Management & Research, Inc. (AMR). The order permanently enjoins and restrains Melton and AMR from violating Section 17(a) of the Securities Act of 1933, Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder, and Section 206 of the Investment Advisors Act.

Melton was ordered to pay disgorgement in the amount of \$352,021.45, representing the income and fees he received from sales of interests in Westview Capital, L.C. (Westview Capital), Trading Partners, L.C. (TP) and Trading Partners II, L.C. (TP2), and prejudgment interest thereon. Payment of the disgorgement and prejudgment interest was waived based upon Melton's sworn statement which demonstrated an inability to pay the ordered amount.

AMR was ordered to pay disgorgement in the amount of \$188,243.21, representing its gains from fees received from the three limited liability companies listed above, and prejudgment interest thereon. AMR was also ordered by the Court to disgorge any ownership interest the company had in Westview Capital, TP and TP2. Based upon AMR's sworn financial statement which established an inability to pay disgorgement and prejudgment interest, the Court waived payment of the said amount.

Melton and AMR consented to the relief without admitting or denying the allegations set forth in a complaint, filed by the Commission on February 24, 1997. In its complaint, the Commission alleged that violations of the antifraud provisions of the securities laws by Melton and the defendant companies had occurred primarily between mid-1994 and late 1996. During that time, defendants Westview Capital, TP and TP2 raised approximately \$5,000,000 from 44 investors, many of whom had invested in more than one of the entities. Through misrepresentations and omissions of material facts, Melton solicited and raised funds from unwitting investors. Among other violations, Melton commingled monies among the limited liability companies and used investors' funds to operate other entities he controlled. ## INVESTMENT COMPANY ACT RELEASES

## LEHMAN BROTHERS CAPITAL PARTNERS I, ET AL.

An order has been issued on an application filed by Lehman Brothers Capital Partners I, et al. under Sections 6(b) and 6(e) of the Investment Company Act granting certain partnerships and other investment vehicles an exemption from all provisions of the Act except Section 9, certain provisions of Sections 17 and 30, Sections 36 through 53, and the rules and regulations under those sections. Each partnership or investment vehicle will be an "employees' securities company" within the meaning of Section 2(a)(13) of the Act. (Rel. IC-23179 - May 11)

#### CELLCO FINANCE N.V.

An order has been issued on an application filed by Cellco Finance N.V. under Section 6(c) of the Investment Company Act for an exemption from all provisions of the Act. The order permits Cellco Finance N.V. to sell certain debt securities and use the proceeds to finance the business activities of Turkcell Iletisim Hizmetleri A.S. (Rel. IC-23180; International Series Rel. 1134 - May 12)
