# RULES AND RELATED MATTERS

### PROPOSED RULEMAKING

The Commission issued a release soliciting public comment on a proposed amendment to Rule 3a12-8 under the Securities Exchange Act of 1934. Rule 3a12-8 exempts certain designated foreign government securities for purposes of trading futures contracts on those securities. The amendment would add the debt securities of Belgium to the list of designated foreign government securities that are exempted by Rule 3a12-8. Publication of the proposed rule amendment

is expected in the <u>Federal Register</u> during the week of June 8. (Rel. 34-40077; International Series Rel. 1139; File No. S7-15-98)

### ENFORCEMENT PROCEEDINGS

# COMMISSION SETTLES PILLSBURY INSIDER TRADING CASE AGAINST TWO DEFENDANTS

The Commission announced that it recently entered into settlements with Eric Muenster and Mark Muenster, two of the defendants in its insider trading case arising from the 1988 tender offer by Grand Metropolitan PLC for The Pillsbury Company. The Commission's complaint, filed on September 16, 1992, alleged that both Muenster brothers violated Sections 10(b) and 14(e) of the Securities Exchange Act of 1934, and Rules 10b-5 and 14e-3 promulgated thereunder, by purchasing Pillsbury call options before the tender offer was publicly announced and while possessing material nonpublic information about it. Without admitting or denying the Commission's allegations, Eric Muenster consented to entry of a final judgment that permanently enjoins him from violating these provisions of the federal securities laws and orders him to disgorge \$42,678.02 in profits plus prejudgment interest in the amount of \$53,889.14. Also without admitting or denying the Commission's allegations, Mark Muenster consented to entry of a final judgment that permanently enjoins him from violating the same provisions and orders him to disgorge \$43,389.39 in profits plus prejudment interest in the amount of \$54,279.03. Based on their demonstrated inability to pay, the disgorgement obligations of both Muensters were waived and no civil monetary penalties were imposed. [SEC v. COMMISSION FILES COMPLAINT AGAINST GLOBAL TIMBER CORPORATION, STEPHEN SAND, JOSE GARCIA, JONATHON BENTLEY-STEVENS, DAVID KIRK AND PAMELA VEGA

The Commission announced that on June 8 it filed a complaint against defendants Global Timber Corporation (Global), Stephen J. Sand (Sand), Jose F. Garcia (Garcia), Jonathon Bentley-Stevens (Stevens), David A. Kirk (Kirk), and Pamela J. Vega (Vega) charging them with making fraudulent misrepresentations in three Rule 15c2-11 Disclosure Statements and a Form 10 Registration Statement.

The Commission's complaint alleges that Global, Sand, Garcia and Stevens grossly overstated Global's financial condition by misrepresenting that Global had the right to harvest certain timber located in the Philippines. Further, Kirk and Vega misrepresented that Vega was a certified public accountant who performed a valuation of Global's purported timber rights in accordance with Generally Accepted Auditing Standards.

Garcia consented, without admitting or denying the allegations in the complaint, to the entry of a judgment of permanent injunction enjoining him from future violations of Section 10(b) of the Exchange Act and Rule 10b-5 thereunder and imposing a civil penalty of \$25,000.

The Commission previously obtained a temporary trading suspension of Global's stock, pursuant to Section 12(k) of the Exchange Act, based on questions regarding the accuracy of publicly disseminated information concerning Global's financial condition (Rel. 34-37580). # THE COMMISSION OBTAINS EMERGENCY RELIEF IN CONNECTION WITH ATTEMPTS TO NEGOTIATE FRAUDULENT SECURITIES

On June 8, the Commission obtained emergency injunctive relief in an action involving the offer and attempt to sell forged and fictitious securities. The Honorable John G. Koeltl of the U.S District Court for the Southern District of New York issued a temporary restraining order and other relief against Daniel T. Todt, Rebecca L. Todt, Bay State Trust, Inge Marilyn Perry, Shmmuel Emmanuel Abijah Quijano (a/k/a HRH Shmmuel Abijah, a/k/a Sergio Arcineagas), Neal Harris, ABE Investments Group, Inc. and Jorge Bryson. Todt and Rebecca Todt consented to the relief requested. H. Wayne Leggett is also named as a defendant in the action for an injunction, but was not included in the Commission's motion for a temporary restraining order. The Commission alleges in its complaint, which was filed on June 5, 1998, that the defendants are engaged in a scheme to obtain money using fraudulent "bank certificates" in violation of the antifraud provisions of the federal securities laws.

To prevent the defendants from continuing to try to negotiate these or other securities, the District Court entered a temporary restraining order against the defendants and an order that the defendants tender the original fraudulent securities to the Clerk of the Court. The District Court ordered that all defendants appear before the Court on June 18, 1998, to show cause why the Court should not enter a preliminary injunction. [SEC v. Daniel T. # M FUND, INC., ET AL.

A notice has been issued giving interested persons until June 30 to request a hearing on an application filed by M Fund, Inc. and M Financial Investment Advisers, Inc. for an order under Section 6(c) of the Investment Company Act from Section 15(a) of the Act and Rule 18f-2 under the Act to permit applicants to enter into and materially amend investment advisory contracts with certain registered open-end investment companies without shareholder approval.
