AMENDMENT TO RULE 102(E) PROPOSED

On June 12, the Commission proposed an amendment to Rule 102(e) of the Commission Rules of Practice clarifying the Commission's standard for determining when accountants engage in "improper professional conduct." ENFORCEMENT PROCEEDINGS

ADMINISTRATIVE PROCEEDINGS SETTLED WITH FORMER REGISTERED REPRESENTATIVE AND INVESTMENT ADVISER

The Commission instituted and simultaneously settled public administrative proceedings today against Emmanuel A.U. Lagpacan of Lafayette, California, formerly a registered investment adviser doing business under the name Money Matters, Financial Consultants and Accountants. Before that, Lagpacan worked as a stockbroker. As a result of these proceedings, Lagpacan is barred from association with any broker, dealer, municipal securities dealer, investment adviser, or investment company.

The Commission had alleged that from January 1990 through at least February 1997, Lagpacan raised more than \$4.4 million by making fraudulent misrepresentations to approximately 73 advisory and brokerage clients, and that Lagpacan owes at least \$3 million to these clients and does not have sufficient assets to repay them.

The administrative proceedings are based upon the entry of a permanent injunction against Lagpacan in the Commission's previously filed civil action. Lagpacan consented to the administrative order and injunction without admitting or denying the allegations. [SEC

INVESTMENT COMPANY ACT RELEASES

NEW YORK LIFE CAPITAL CORPORATION

A notice has been issued giving interested persons until July 8, 1998 to request a hearing on an application filed by New York Life Capital Corporation for an order under Section 6(c) of the Investment Company Act exempting applicant from all provisions of the Act. The order would permit applicant to sell certain debt securities and use the proceeds to finance the business activities of its parent company and certain companies controlled by the parent company.
