COMMISSION ANNOUNCEMENTS

SEC TO HOST ANNUAL GOVERNMENT BUSINESS FORUM

The Commission announced that the Seventeenth Annual Government Business Forum on Small Business Capital Formation will be held on Thursday, September 24, and Friday, September 25, 1998, in Chicago at The University of Chicago Downtown Conference Center, just east of Michigan Avenue on the north bank of the Chicago River.

The Forum offers small business an opportunity to articulate its views and needs. The Forum's participants discuss ways to eliminate unnecessary governmental impediments to raising capital. Afterwards, a final report of the Forum's activities is prepared, which includes recommendations for governmental action.

This report is provided to Congress and those governmental agencies that can craft the relief sought by the Forum. Over the years, many Forum recommendations have resulted in legislative and regulatory reform in the areas of taxation, securities regulation, financial services regulation, and state assistance programs.

This year's Forum will focus on current issues in taxation, international and transactional financing, the impact of financial services/consolidation on small businesses, and early stage dealmaking/exit strategies and their impact on securities regulation. Sessions will be comprised of two parts, following a basic format that has been used in recent years. The morning sessions will offer a variety of roundtable discussions, each devoted to one of the four targeted topics. The remainder of each morning and the afternoon sessions will be devoted to discussion in small interactive break-out groups to permit Forum participants sufficient time to develop thoughtful recommendations. An opening general session panel will focus on the use of the Internet by small businesses.

Participation at the Forum must be limited to 150 persons. Nonetheless, in view of its purposes, every effort will be made to ensure that each small business owner seeking to participate will be able to do so. In order to defray certain costs of the Forum, including the group luncheons and the welcoming reception, each participant will be charged \$170.

COMMISSION TEMPORARILY SUSPENDS TRADING IN THE SECURITIES OF GOLDEN EAGLE INTERNATIONAL, INC.

The Commission announced the temporary suspension, pursuant to Section 12(k) of the Securities Exchange Act of 1934, of over the counter trading of the securities of Golden Eagle International, Inc. at 9:30 a.m. on June 22, 1998, and terminating at 11:59 p.m. on July 6, 1998.

It appears to the Commission that there is a lack of current and accurate information concerning the securities of Golden Eagle because of questions regarding the accuracy and adequacy of assertions by Golden Eagle and by others concerning, among other things, the basis for its claims of proven gold reserves on its Bolivian mineral concessions. ENFORCEMENT PROCEEDINGS

CORTLANDT CAPITAL CORP., MAYER AMSEL, AND JOSEPH MICHAEL GUCCIONE CONSENT TO SANCTIONS

The Commission announced that it has settled an administrative proceeding against Cortlandt Capital Corp., a New York City brokerdealer formerly known as Greenway Capital Corp., Mayer Amsel, and Joseph Michael Guccione. The respondents consented to the Commission's Order, without admitting or denying the Commission's findings in the Order.

The Commission found that from September 1993 to February 1994, Amsel and Cortlandt manipulated the market for Vertex Industries, Inc. common stock, which traded over-the-counter on the Nasdag SmallCap Market. The Commission ordered all respondents to cease and desist from violating Sections 10(b) and 15(c) of the Exchange Act and Rules 10b-5 and 15c1-2.

The Commission barred Amsel and Guccione from association with any broker, dealer, municipal securities dealer, investment adviser or investment company. Guccione may reapply for association after four years. The Commission ordered Guccione to pay a \$20,000 civil money penalty, and did not impose a money penalty against Amsel or Cortlandt based upon a demonstrated inability to pay. HOLDING COMPANY ACT RELEASES

CENTRAL AND SOUTH WEST CORPORATION, ET AL.

An order has been issued authorizing Central and South West Corporation (CSW), a registered holding company, CSW International, Inc. and CSW Energy, Inc., both wholly owned nonutility subsidiary companies of CSW, to enter into agreements to provide energy-related services to associate companies at fair market prices. SELF-REGULATORY ORGANIZATIONS

APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change and issued notice of filing and granted accelerated approval of Amendment No. 1 to the proposed rule change submitted by the <u>Pacific Exchange</u> (SR-PCX-98-04) to require the broker-dealer status of an order to be identified by public outcry to the trading crowd prior to execution, regardless of whether the order is to be executed at the trading crowd's disseminated bid or offering price. IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

A proposed rule change filed by the NASD to undergo the periodic reclassification of Nasdaq National Market securities into appropriate tier sizes to determine the maximum order size for a particular security eligible for execution through Nasdaq's Small Order Execution System became immediately effective. Publication of the proposal is expected in the <u>Federal Register</u> during the week of June 22. (Rel. 34-40102)
