RULES AND RELATED MATTERS

SEC APPROVES PROPOSAL BY THE NASD WHICH ELIMINATES REQUIREMENT THAT EMPLOYEES MUST ARBITRATE STATUTORY DISCRIMINATION CLAIMS

The Commission announced today that it approved a proposed rule change filed by the <u>National Association of Securities Dealers</u> (SR-NASD-97-77) that would amend Rule 10201 of the NASD's Code of Arbitration Procedure to remove the requirement that employees of broker-dealers arbitrate statutory claims of employment discrimination.

The rule change will modify the current requirement that associated persons arbitrate all disputes arising out of their employment or termination of employment with a member broker-dealer. The rule change provides that associated persons are not required, solely by virtue of their association or their registration with the NASD, to arbitrate claims of statutory employment discrimination. The rule change will take effect on January 1, 1999. (Rel. 34-40109; Press Rel. 98-61)

ENFORCEMENT PROCEEDINGS

COMMISSION ISSUES ORDER AGAINST PAUL SAFRONCHIK, CPA

The Commission entered an Order pursuant to Rule 102(e) Of The Commission's Rules of Practice, denying Paul R. Safronchik, CPA (Safronchik) the privilege of appearing or practicing before the Commission as an accountant. Safronchik consented to the Order without admitting or denying the Commission's findings. On June 3, the United States District Court for the Central District of California entered a judgment enjoining Safronchik from committing future violations of the antifraud, books and records, registration and reporting provisions of the federal securities laws. Safronchik was chairman of the board of directors and chief executive officer of Home Theater Products International, Inc. (HTPI) and its predecessor, Home Theater Products, Inc., from July 1990 until his resignation on October 23, 1995. The Commission's complaint alleged that, from at least June 1992 through September 1995, Safronchik, among other things, falsified HTPI's books and records, overstated

HTPI's sales and income in reports filed with the Commission and sold HTPI securities while in possession of material nonpublic information (SEC v. Paul R. Safronchik, Civil Action No. SACV 98-416-GLT, EEx, CD Cal.). (Rel. 34-40106; AAE Rel. 1047; File No. 3-9628)

HOLDING COMPANY ACT RELEASES

CENTRAL MAINE POWER COMPANY, ET AL.

A notice has been issued giving interested persons until July 14, 1998, to request a hearing on a proposal by Central Maine Power Company (Central Maine), a public utility holding company exempt from regulation under the Public Utility Holding Company Act (Act), except Section 9(a)(2) and HoldCo, Inc (Holdco), a wholly owned subsidiary of Central Maine. Holdco proposes to acquire all of the outstanding shares of Central Maine common stock and, indirectly, Central Maine's utility and nonutility subsidiaries. In addition, Holdco and Central Maine each request an exemption under Section 3(a)(1) of the Act from all provisions of the Act, except Section 9(a)(2). (Rel. 35-26888)
