ENFORCEMENT PROCEEDINGS

CEASE AND DESIST PROCEEDING ORDERED AGAINST JAMES ROSS

The Commission announced the issuance of an Order Instituting Proceeding, Making Findings and Imposing a Remedial Sanction and a Cease and Desist Order pursuant to the Securities Act of 1933 (Securities Act) and the Securities Exchange Act of 1934 (Exchange Act) against James Ray Ross (Ross). The Commission simultaneously accepted Ross' Offer of Settlement wherein he consents to the issuance of the Order without admitting or denying the Commission's findings therein. The Order provides that Ross cease and desist from committing or causing any violations or any future violations of Sections 5(a) and 5(c) of the Securities Act and Section 15(a) of the Exchange Act and that Ross pay disgorgement and interest totaling \$55,857.50.

The Order finds that Ross violated the securities and broker-dealer registration provisions of the federal securities laws through his participation in a fraudulent scheme conducted by BeneFund, Inc. (BeneFund) and its president, Vernon R. Twyman, Jr. The Order also finds that Ross offered, sold and caused a public distribution of BeneFund stock registered pursuant to Form S-8. Finally, the Order finds that Ross acted as an unregistered broker-dealer in connection with the sales of BeneFund securities. (Rels. 33-7551; 34-40134; File No. 3-9636)

HOLDING COMPANY ACT RELEASES

SEMPRA ENERGY

An order has been issued authorizing Sempra Energy (Sempra), a California corporation not currently subject to the Act, to acquire all of the issued and outstanding common stock of Pacific Enterprises and Enova Corporation, each an exempt intrastate holding company. The order also exempts Sempra from all provisions of the Act, except Section 9(a)(2), following consummation of the proposed transactions. (Rel. 35-26894)

The Commission granted accelerated approval to a proposed rule change (SR-NASD-98-42) submitted by the <u>National Association of Securities Dealers</u> relating to the six month extension of effectiveness of the pilot injunctive relief rule.
