ENFORCEMENT PROCEEDINGS

PUBLIC ADMINISTRATIVE PROCEEDINGS INSTITUTED AGAINST SUSAN HENRY

The Commission today announced the institution and simultaneous settlement of public administrative proceedings against Susan L. Henry (Henry). Henry was the owner, president and general securities principal of Bluebonnet Securities, Inc., a now-defunct broker-dealer registered with the Commission. The Commission's Order found that Henry failed reasonably to supervise two registered representatives who were subject to her supervision. These registered representatives violated the antifraud and registration provisions of the federal securities laws by misrepresenting the high-risk, speculative nature of investments in disregard of their investment objectives and by submitting false statements of net worth for customers to qualify them as accredited investors in a private placement offering. Without admitting or denying the Commission's findings, Henry has agreed to the entry of an Order suspending her from association with any broker, dealer, municipal securities dealer, investment adviser or investment company for a period of 12 months, barring her in a supervisory and a proprietary capacity, with a right to reapply for such association after three years, from association with any broker, dealer, investment company, investment adviser or municipal securities dealer, and ordering her to pay a civil money penalty of \$5,000. PUBLIC ADMINISTRATIVE AND CEASE AND DESIST PROCEEDINGS INSTITUTED AGAINST ROBERT BETTIGA

The Commission today announced the institution of public administrative and cease and desist proceedings against Robert G. Bettiga (Bettiga). Bettiga was a registered representative of Bluebonnet Securities, Inc., a now defunct broker-dealer firm. The Commission's Order alleges that Bettiga willfully violated the antifraud and registration provisions of the federal securities laws by misrepresenting the high-risk, speculative nature of investments he sold to customers in disregard of their investment objectives and by submitting false statements of net worth for customers to qualify them as accredited investors in a private placement offering.

A hearing will be scheduled to determine what, if any, remedial action is appropriate in the public interest against Bettiga. (Rels. 33-7553; 34-40184; File No. 3-9648)

INVESTMENT COMPANY ACT RELEASES

CALVERT SOCIAL INVESTMENT FUND, ET AL.

A notice has been issued giving interested persons until August 3, 1998, to request a hearing on an application filed by Calvert Social Investment Fund, et al. for an order under Sections 6(c) and 17(b) of the Investment Company Act requesting an exemption from Section 17(a) of the Act and under Section 17(d) of the Act and Rule 17d-1 under the Act to permit certain registered investment companies to invest up to a specified percentage of their assets in an affiliated non-profit social and community development organization. (Rel. IC-23306 - July 8)

EUROPACIFIC GROWTH FUND, ET AL.

A notice has been issued giving interested persons until August 3, 1998, to request a hearing on an application filed by EuroPacific Growth Fund, et al. for an order under Section 6(c) of the Investment Company Act declaring that William H. Kling will not be deemed an "interested person" under the Act. Mr. Kling is a director on the boards of certain registered investment companies and is an outside director for the parent company of a registered broker-dealer. (Rel. IC-23307 - July 9)

CORPORATE INCOME FUND, ET AL.

A notice has been issued giving interested persons until August 3, 1998, to request a hearing on an application filed by Corporate Income Fund, et al. for an order under Section 6(c) of the Investment Company Act to permit certain unit investment trusts to invest up to 10.5% of their assets in securities of an issuer that derives more than 15% of its gross revenues from securities-related activities. HOLDING COMPANY ACT RELEASES

ATLANTIC CITY ELECTRIC COMPANY

An order has been issued authorizing Atlantic City Electric Company, an electric public utility subsidiary of Conectiv, Inc., a registered holding company, to purchase two combustion turbine generating units and accessory equipment. (Rel. 35-26893)

SELF-REGULATORY ORGANIZATIONS

APPROVAL OF PROPOSED RULE CHANGES

The Commission approved proposed rule changes filed by <u>The Depository Trust Company</u> and the <u>National Securities Clearing Corporation</u> (SR-DTC-98-09 and SR-NSCC-98-05). Under the rule changes, NSCC will discontinue its Direct Clearing Services and its New York Window Services. DTC will begin to offer its participants most of the services currently available through NSCC's Direct Clearing Services and New York Window Services. (Rel. 34-40179)

The Commission approved a proposed rule change filed by the <u>Pacific Exchange</u> (SR-PCX-98-12) relating to the treatment of PMP Orders generated through the matching of Profiles by the PCX Application of the OptiMark System. Publication of the proposal is expected in the Federal Register during the week of July 13. (Rel. 34-40182)

PROPOSED RULE CHANGE

The <u>Philadelphia Stock Exchange</u> filed a proposed rule change (SR-Phlx-98-22) relating to amendments to Phlx Rule 931 regarding the Exchange's filing requirements for approved lessors. Publication of the proposal is expected in the <u>Federal Register</u> during the week of July 13. (Rel. 34-40180).
