THE CHICAGO BOARD OF TRADE'S APPLICATIONS FOR CONTRACT MARKET DESIGNATION TO TRADE FUTURES AND RELATED OPTIONS ON THE DOW JONES UTILITIES AND TRANSPORTATION AVERAGES INDICES ARE DENIED

On July 16, the Commission denied the Chicago Board of Trade's applications for designation to trade futures and futures options contracts on the Dow Jones Utilities Average Index (DJUA) and the Dow Jones Transportation Average Index (DJTA) under the Commodity Exchange Act, 7 U.S.C. § 2a(ii). The Commission determined that the proposed contracts on the DJUA and DJTA fail to meet the requirement that each index measure and reflect a substantial segment of the equities market (or be comparable to such measure). #### **ENFORCEMENT PROCEEDINGS**

### JUDGMENTS ENTERED IN TOUCH TONE PARTNERS OFFERING LAWSUIT

The Commission announced that on June 17, 1998, the Honorable Christina A. Snyder, United States District Judge for the Central District of California, granted the Commission's motions for summary

judgment and default judgment, and entered final judgments against thirteen individual defendants and five entity defendants in this action. The Court ordered the defendants to pay over \$3.2 million in civil penalties and disgorgement of their ill-gotten gains with prejudgment interest (jointly and severally as to certain individuals and entities).

The Court also entered permanent injunctions against defendants Eugene Evangelist, B.M.C. Enterprises, Inc., Madison Consulting Inc., Livestock Financial Consulting, Inc., Brookside Management, Inc., and Lion's Share Ventures, prohibiting future violations of the antifraud, securities registration, and/or brokerdealer registration provisions of the federal securities laws (Sections 5(a), 5(c), and 17(a) of the Securities Act of 1933 and Sections 10(b) and 15(a) of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder). Ten of the defendants -- Michael E. Lopuszynski, C. Scott Courtney, Jonathan Shoucair, Michael W. Engelhardt, Joseph Widmer, Kent Bollenbach, Timothy Grayson, Brent Morris, and James Perez, and Robert Haug -- previously consented, admitting or denying the allegations, without to similar [SEC v. B.M.C. Enterprises, Inc., injunctions. Michael E. Lopuszynski, C. Scott Courtney, Madison Consulting Group, Inc., Jonathan Shoucair, Michael W. Engelhardt, Joseph Widmer, Livestock Financial Services, Inc., Eugene Evangelist, Kent Bollenbach, Brookside Management, Inc., Timothy Grayson, Lion's Share Ventures, Brent Morris, James Perez, Robert Haug d/b/a West Coast Investments, Frontline Consulting, Inc., Marc Levine, and Ira Itskowitz, Civil Action No. No. 97-4811 CAS, JGx, C.D. Cal.] (LR-15808)

#### COMMISSION FILES AND SETTLES ACTION AGAINST JOHN GILLETTE, JR.

The Commission announced that it has filed an action in United States District Court against John W. Gillette, Jr.

The Commission's complaint alleged that, from June 1994 through July 1997, Gillette, a resident of San Diego, acted as an unregistered investment adviser to over 85 clients, most of whom were professional athletes. The Commission further alleged that Gillette made false and misleading statements when recommending investments to these clients, and misappropriated client monies, resulting in losses of over \$11 million. The Commission alleged that Gillette misappropriated his client's investment profits, paid certain clients with other clients' monies, and represented he had invested client funds in partnerships and municipal bonds when in fact he had misappropriated those funds. In addition, the Commission alleges that from 1993 through June 1994, Gillette liquidated the securities of a client without her knowledge, and misappropriated \$400,000 for his personal benefit. Finally, the Commission alleged that, by giving investment advice to his clients in exchange for a fee, Gillette was acting as an unregistered investment adviser.

Without admitting or denying the Commission's allegations, Gillette agreed to be permanently enjoined from future violations of the antifraud and investment adviser registration provisions of the

federal securities laws. [SEC v. John W. Gillette, Jr., Civil Action No. 98- CV 1265S CGA, S.D. Cal.] (LR-15812)

TEMPORARY RESTRAINING ORDER AND ASSET FREEZE ISSUED AGAINST MICHAEL RICHMOND, LIBERTY NETWORK, ROYAL MERIDIAN INTERNATIONAL BANK, MERIDIAN MONETARY SERVICES, INC., WILLIAM DUKE, MERIDIAN MANAGEMENT SERVICES, LLC, K. BRUCE NUCKOLS, ANTHONY GARRY AND THOMAS CONNOLLY

On July 15, the Honorable Reginald C. Lindsay of the United States District Court for the District of Massachusetts granted the Commission's request for a Temporary Restraining Order against Michael D. Richmond, Liberty Network, Royal Meridian International Bank, Meridian Monetary Services, Inc., William Duke, Meridian Management Services, LLC, K. Bruce Nuckols, Anthony Garry, and Thomas Connolly. The Court also issued an order for the freezing of assets, an order prohibiting the acceptance of additional investor funds, an accounting of assets and an order requiring the repatriation to the United States of assets transferred abroad.

The Commission's complaint alleges that the defendants are engaging in a "Ponzi" scheme in violation of the federal securities laws. According to the Commission's complaint this scheme involved the fraudulent offer and sale of unregistered securities in the form of Certificates of Deposit (CDs). The complaint alleges that the defendants fraudulently induced individuals over the internet to purchase CDs at guaranteed above market rates, secured by 125% cash reserves, government bonds and UCC fillings with "The Federal Bank." The complaint further alleges that the funds were never invested as promised but were misappropriated by the promoters. The complaint charges that of the \$7.2 million raised only approximately \$2.7 million remains to repay defrauded investors. The Commission's action continues as the Commission seeks preliminary and permanent injunctions against future violations, disgorgement of ill-gotten gains and the imposition of civil monetary penalties as to all defendants. ## SAM ANTAR, ALLEN ANTAR AND BENJAMIN KUSZER FOUND LIABLE FOR INSIDER TRADING IN CRAZY EDDIE CASE

The Commission announced today that the Honorable Harold A. Ackerman of the United States District Court for the District of New Jersey issued an opinion holding that Sam M. Antar, Allen Antar and Benjamin Kuszer committed insider trading in violation of the United States securities laws in connection with a public company named Crazy Eddie, Inc. According to the Court's opinion, the defendants engaged in an extensive, multifaceted fraud that consisted of cash-skimming, falsification of inventory counts, and the inflation of comparable store sales figures. The purpose of these schemes was artificially to inflate the price of Crazy Eddie stock. The Commission sued the defendants and relief defendants Rori Antar, Sam A. Antar, Michelle Antar, Adam Kuszer, Sam Kuszer and Simon Kuszer for stock sales in which they reaped over \$27 million in gross proceeds. When the defendants sold Crazy Eddie stock, they knew of the fraudulent activities perpetrated at the company. The Court

stated that it would order full disgorgement of illegal profits by the defendants and relief defendants. The Court also held that the protection of the investing public necessitated that Sam M. Antar, Allen Antar and Benjamin Kuszer be enjoined from any further violations of federal securities laws. [SEC v. Sam M. Antar, et al., Civil Action No. 93-3988, HAA, D.N.J.] (LR-15814)

#### SELF-REGULATORY ORGANIZATIONS

#### APPROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change submitted by the <u>Pacific Exchange</u> (SR-PCX-98-21) to increase the recommended fines under the Minor Rule Plan for disruptive action involving physical contact between members while on the options trading floor. Publication of the approval order is expected in the <u>Federal Register</u> during the week of July 13. (Rel. 34-40193)

The Commission approved a proposed rule change (SR-MSRB-98-4) submitted by the <u>Municipal Securities Rulemaking Board</u> to amend Rule G-32, on disclosures in connection with new issues. The proposed rule change provides an alternate method of compliance by brokers, dealers and municipal securities dealers with their obligation to deliver official statements in final form to customers by settlement for certain new issues of variable rate demand obligations. Publication in the <u>Federal Register</u> is expected during the week of July 20. (Rel. 34-40197)

The Commission approved a proposed rule change submitted by the National Association of Securities Dealers (SR-NASD-98-33) relating to exemptions from fidelity bonding requirements. Publication of the approval order in the <u>Federal Register</u> is expected during the week of July 20. (Rel. 34-40200)

The Commission approved a proposed rule change filed by the Options Clearing Corporation (SR-OCC-97-12) regarding initial and minimum net capital requirements for its members that are also futures commission merchants. (Rel. 34-40205)

The Commission approved a proposed rule change filed by the Government Securities Clearing Corporation (SR-GSCC-98-01) that amends GSCC's rules regarding funds-only settlement payments procedures. (Rel. 34-40207)

The Commission approved a proposed rule change submitted by the <u>Philadelphia Stock Exchange</u> (SR-Phlx-97-63) to codify and amend its method of calculating initial and maintenance margin requirements for foreign currency options. (Rel. 34-40208)

#### ACCELERATED APPROVAL OF PROPOSED RULE CHANGES

The Commission granted accelerated approval to a proposed rule change submitted by the <u>Pacific Exchange</u> (SR-PCX-97-46) to permit members to trade on the Exchange in increments smaller than 1/16 in order to match bids and offers displayed in other markets for the purpose of preventing Intermarket Trading System trade-throughs. (Rel. 34-40199)

The Options Clearing Corporation filed a proposed rule change (SR-OCC-97-13) that will amend OCC's by-laws to allow adjustments to exercise prices to be rounded based on the trading increments applicable to their underlying securities. The Commission has approved the proposed rule change on an accelerated basis. Publication of the proposal is expected in the <u>Federal Register</u> during the week of July 20. (Rel. 34-40209)

#### PROPOSED RULE CHANGE

The <u>Chicago Stock Exchange</u> filed a proposed rule change (SR-CHX-98-15) to amend its rules to prohibit specialists from paying the listing fees of issuing companies for which they act as specialists. Publication of the proposal is expected in the <u>Federal Register</u> during the week of July 20. (Rel. 34-40202)
