COMMISSION ANNOUNCEMENTS

SINGLE TEN-DAY SUSPENSION OF OVER-THE-COUNTER TRADING IN THE SECURITIES OF INFOTEX HOLDINGS, LTD.

The Commission announced the single ten-day suspension of over-the-counter trading in the securities of Infotex Holdings, Ltd. (Infotex) for the period beginning at 9:30 a.m. eastern time on July 23 and terminating at 11:59 p.m. eastern time on August 5, 1998. The Commission temporarily suspended trading in the securities of Infotex because of questions about the accuracy and adequacy of publicly disseminated information concerning, among other things, (1) the nature and value of current contracts which Infotex claims to possess, and (2) the relationship between Infotex and an analyst who recommended purchase of its shares. RULES AND RELATED MATTERS

TEMPORARY EXEMPTION FOR CERTAIN INVESTMENT ADVISERS

The Commission issued a release proposing amendments to Rule 15a-4 under the Investment Company Act, the rule that permits an in certain circumstances, to advise investment adviser, investment company (fund) temporarily under a contract that the fund's shareholders have not approved. The proposed amendments would expand the exemption provided by the rule to include new advisory contracts entered into as a result of a merger or similar business combination involving the fund's adviser or a controlling person of the adviser, and would lengthen the period during which the adviser may serve under a contract without shareholder approval. The proposed amendments are intended to enable more investment advisers to rely on the rule rather than seek individual exemptions from the Commission, subject to conditions designed to protect investors pending the shareholder vote. ENFORCEMENT PROCEEDINGS

COMMISSION MODIFIES NASD FINDING OF VIOLATION AGAINST DANIEL MONTANO AND REMANDS PROCEEDINGS FOR RESANCTIONING

The Commission has sustained certain findings of violation made by the National Association of Securities Dealers, Inc. (NASD) against Daniel C. Montano of California. Montano, a registered general securities principal at the time of the violation in 1993, served as president of Montano Securities Corporation, an NASD member.

The Commission sustained NASD findings that Montano's statements during an infomercial: failed to provide a sound basis to evaluate his recommendation that viewers short-sell stock of a public company, improperly referred to results of Montano's previous recommendations, made exaggerated and unwarranted claims, and made improper comparisons and predictions. Like the NASD, the Commission concluded that this misconduct violated the NASD's Conduct Rules.

The Commission concluded, however, that the record did not support the NASD's finding that Montano had failed to provide sufficient information about the company whose stock formed the basis of his short-sell recommendation. Accordingly, the Commission remanded the matter to the NASD for consideration of an appropriate sanction for the violations sustained by the Commission. (Rel. 34-40243; File No. 3-9259)

COMMISSION SUSTAINS NASD DISCIPLINARY ACTION AGAINST KEVIN SHAUGHNESSY

The Commission has sustained the disciplinary action taken by the National Association of Securities Dealers, Inc. (NASD) against Kevin E. Shaughnessy of Pittsburgh, PA. Shaughnessy was a registered representative formerly associated with Gruntal & Co., Inc. The NASD censured Shaughnessy, fined him \$11,675, ordered restitution of \$1,916.37, and barred Shaughnessy from association with a member firm.

The Commission found that Shaughnessy accepted kickbacks from a stock promoter for selling certain securities to his clients without disclosing to them the fee arrangement or the receipt of the payments. Shaughnessy also failed to provide prompt written notice of the promoter's payments to his employer as required by NASD rules. (Rel. 34-40244; File No. 3-9332)

ADMINISTRATIVE PROCEEDING INSTITUTED AGAINST EMANUEL NEDWICK

The Commission instituted a public administrative proceeding against Emanuel B. Nedwick, a registered representative currently associated with a registered broker-dealer. To settle this proceeding, Nedwick agreed to consent to an Order suspending him from association with

any broker or dealer for a period of twelve months, effective on the second Monday after the entry of the Order.

The Commission's Order suspending Nedwick contains a finding that on July 17 Nedwick was permanently enjoined from future violations of Sections 5(a), 5(c), and 17(a) of the Securities Act of 1933 and Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder (SEC v. American Growth Capital Corp., et al., Civil Action No. 97-5993, RAP, JGx, C.D. Cal.). The Commission's complaint in this action alleges, among other things, that Nedwick offered and sold unregistered securities and defrauded investors by misrepresenting the amount of commissions he received on sales of interests in an investment fund. INITIAL DECISION IN THE MATTER OF PATRICIA BELLOWS

Today, July 23, Administrative Law Judge Lillian A. McEwen issued an initial decision in the administrative proceeding against Patricia Ann Bellows. It was alleged that from about May through August 1993, Ms. Bellows failed reasonably to supervise a registered representative. Judge McEwen found that the Division of Enforcement failed to prove that the registered representative was subject to the supervision of Ms. Bellows. In the alternative, assuming the registered representative was subject to Ms. Bellow's supervision, Judge McEwen found that Ms. Bellows reasonably delegated her supervisory duties to three subordinate employees. Judge McEwen found that neither Ms. Bellows nor the three subordinate employees could have anticipated the fraudulent actions of the registered representative. Therefore, Judge McEwen dismissed the proceeding. (Initial Decision Rel. 128; File No. 3-8951)

INVESTMENT COMPANY ACT RELEASES

CASH MANAGEMENT PORTFOLIO, ET AL.

An order has been issued on an application filed by Cash Management Portfolio, et al., under Sections 6(c) and 17(b) of the Investment Company Act granting an exemption from Section 17(a) of the Act. The order would permit in-kind redemptions of shares of certain registered investment companies by certain affiliated persons of the investment companies. (Rel. IC-23326 - July 22)
