ENFORCEMENT PROCEEDINGS

SETTLED INSIDER TRADING CASE AGAINST ANINDYA BAKRIE

The Commission announced that on August 6 it filed an insider trading complaint in the United States District Court for the Southern District of New York against Anindya N. Bakrie. The complaint alleges that Bakrie, an Indonesian national and former junior financial analyst with Salomon Smith Barney Inc.'s New York office, engaged in insider trading in Washington Gas Light Company. The complaint alleges that at the time of Bakrie's insider trading, Washington Gas was involved in confidential merger negotiations with Consolidated Natural Gas Company, for which Salomon was acting as the investment banker.

According to the complaint, in early September 1997, Bakrie learned through Salomon that a merger announcement was imminent, and he then asked his friend, Roy Handojo, to purchase common stock of Washington Gas on Bakrie's behalf, promising to share any resulting profits with Handojo. The complaint further alleges that on September 5, 1997, Handojo purchased 25,000 shares of Washington Gas common stock for a total investment of \$650,000. The complaint alleges that on September 7, 1997, after learning through Salomon that a merger was no longer likely, Bakrie told Handojo that he had changed his mind about purchasing the Washington Gas stock. According to the complaint, over the next two days, September 8 and 9, 1997, Handojo sold all of the Washington Gas stock, incurring a \$13,869 loss.

The Commission's complaint alleges that Bakrie violated the antifraud provisions of the Securities and Exchange Act of 1934 and seeks injunctive relief and civil penalties. Simultaneously with the filing of the Commission's complaint, Bakrie consented, without admitting or denying the allegations of the complaint, to the entry of a final judgment permanently enjoining him from violating Section 10(b) of the Exchange Act and Rule 10b-5 thereunder and ordering him to pay a \$40,000 civil penalty. INVESTMENT COMPANY ACT RELEASES

MORGAN STANLEY & CO. INCORPORATED

An order has been issued on an application filed by Morgan Stanley & Co. Incorporated (Morgan Stanley) amending a prior order. The prior order, among other things, permits registered investment companies to own a greater percentage of the total outstanding voting stock of each AJL PEPS Trust for which Morgan Stanley serves, or will serve, as the principal underwriter (Trust) than that permitted by Section 12(d)(1) of the Investment Company Act. The requested amendment permits companies that are excluded from the definition of investment company under Section 3(c)(1) or 3(c)(7) of the Act to own a greater percentage of the total outstanding voting stock of a Trust than that permitted by Section 12(d)(1)(A) of the Act. CALVERT SOCIAL INVESTMENT FUND, ET AL.

An order has been issued on an application filed by Calvert Social Investment Fund, et al. under Sections 6(c) and 17(b) of the Investment Company Act for an exemption from Section 17(a) of the Act and under Section 17(d) of the Act and Rule 17d-1 under the Act permitting certain registered investment companies to invest up to a specified percentage of their assets in an affiliated non-profit social and community development organization. MCLAUGHLIN, PIVEN, VOGEL SECURITIES, INC.

A conditional order has been issued on an application filed by McLaughlin, Piven, Vogel Securities, Inc. under Section 9(c) of the Investment Company Act exempting applicant from the disqualification provisions of Section 9(a) of the Act solely with respect to a securities related injunction entered against one of applicant's affiliates. The conditional order permits applicant to act as sponsor, depositor, and principal underwriter for one or more unit investment trusts. (Rel. IC-23377 - August 5)
