#### ENFORCEMENT PROCEEDINGS

### INITIAL DECISION IN THE MATTER OF STIRES & CO., INC. AND SIDNEY STIRES

An administrative law judge ordered that Sidney H. Stires, an owner and president of Stires & Co., now Stires, O'Donnell & Co., a registered broker-dealer located in New York, NY, be suspended from association with a broker-dealer for ninety days and she ordered Stires & Co. and Mr. Stires to pay civil penalties of \$300,000 and \$100,000, respectively, and to cease and desist from committing or causing violations of the antifraud and broker-dealer registration provisions of the federal securities laws. These sanctions resulted from findings that in 1993-94 the broker-dealer and Mr. Stires: (1) engaged in fraudulent conduct in connection with a private offering of fictitious Guaranteed Insurance Contracts supposedly issued by a syndicate of European insurance and reinsurance companies; (2) aided and abetted the activities of three individuals, who alleged they represented the Euro-GIC issuers, and used false representations to persuade five individuals to invest a total of \$700,000 in fictitious securities; and (3) aided and abetted the illegal brokerage activities of two unregistered individuals in violation of Section 15(a) of the Securities Exchange Act of 1934. # COMPLAINT FILED AGAINST MICHAEL JENKINS, LAWRENCE PETERSEN, JAMIE TSUTSUI AND MICHAEL KINNEY

The Commission announced that on August 10 it filed a complaint in Dallas, Texas, against Michael D. Jenkins, Lawrence A. Petersen, Jamie T. Tsutsui and Michael L. Kinney. Jenkins was the founder of Absolute Resource Corporation (ARC), a privately-held Texas corporation that purportedly engaged in mining operations in Missouri. Petersen and Tsutsui are former licensed securities salesmen and Kinney is a former employee of a registered broker-dealer.

The complaint alleges that between 1992 and 1996, ARC conducted at least two unregistered securities offerings that raised approximately \$4.6 million from the sale of promissory notes to at least 150 investors in fifteen states. It is further alleged that Jenkins misappropriated at least \$1.5 million of investor funds from both note offerings. The stated purpose of the first note offering was to develop a sand mine located in Pemiscot County, Missouri. In connection with the first offering the complaint alleges the defendants made numerous misstatements and omissions of material facts concerning, among other things, ARC's purported ownership of the sand mine, the use of investor funds, the safety of the investment, the compensation paid to the defendants, the financial condition of ARC, and the risks associated with the investment. The complaint also alleges that after a Missouri court ruled that ARC had no ownership interest in the sand mine, defendant Jenkins conducted a second fraudulent note offering involving a Missouri rock guarry. In April 1996, ARC filed for bankruptcy and defaulted on over \$4.4 million in investor notes. In May 1998, Jenkins was indicted by a federal grand jury on numerous counts of securities fraud, wire fraud, and money laundering, based on his activities described in the Commission's complaint.

The Commission's complaint alleges that each defendant violated the securities registration and antifraud provisions found in Sections 5(a), 5(c) and 17(a) of the Securities Act of 1933, and Section 10(b) of the Securities Exchange Act of 1934 Additionally, defendants Petersen, Tsutsui and Kinney are charged with acting as unregistered broker-dealers in violation of Section 15(a) of the Exchange Act. The complaint seeks a permanent injunction against each defendant, as well as an accounting, disgorgement and civil penalties. [SEC v. Michael D. # INVESTMENT COMPANY ACT RELEASES

#### COUNTRYWIDE INVESTMENT TRUST, ET AL.

A notice has been issued giving interested persons until September 8, 1998, to request a hearing on an application filed by Countrywide Investment Trust, Countrywide Tax-Free Trust, Countrywide Strategic Trust (collectively, the Trusts) and Countrywide Investments, Inc., for an order under Sections 6(c) and 17(b) of the Investment Company Act exempting applicants from Sections 17(a)(1), 17(a)(2) and 17(e) of the Act. The order would permit each Trust to engage in certain securities transactions with banks, bank holding companies, and their affiliates that are affiliated persons of a Trust solely because they own, hold, or control 5% or more of the outstanding voting securities of the Trust, or are an affiliated person of the bank, bank holding company or its affiliate. # THE RBB FUND, INC. AND BEA ASSOCIATES

An order has been issued on an application filed by The RBB Fund, Inc. and BEA Associates under Section 12(d)(1)(J) of the Investment Company Act granting relief from Section 12(d)(1)(G)(i)(II) of the Act. The order would permit a fund of funds relying on Section 12(d)(1)(G) of the Act to invest directly in securities and other instruments. (Rel. IC-23384 - August 11)

#### ALLMERICA INVESTMENT TRUST, ET AL.

An order has been issued on an application filed by Allmerica Investment Trust and Allmerica Financial Investment Management Services, Inc. under Section 6(c) of the Investment Company Act granting an exemption from Section 15(a) of the Act and Rule 18f-2 under the Act, and from certain disclosure requirements under the Act. The order permits applicants to enter into and amend subadvisory agreements without receiving shareholder approval, and grants relief from certain disclosure requirements regarding advisory fees paid to the subadvisers. #### PROPOSED RULE CHANGES

NASD Regulation, Inc. (NASD Regulation) has filed a proposed rule change (SR-NASD-98-14) to modify rules of the <u>National Association</u> of <u>Securities Dealers</u> relating to sales charges and prospectus disclosure for mutual funds and variable contracts. Publication of the proposal is expected in the <u>Federal Register</u> during the week of August 10. (Rel. 34-40310)

The Options Clearing Corp. filed a proposed rule change (SR-OCC-98-07) that will amend OCC's rules to modify the short option adjustment as it applies to non-equity options in OCC's theoretical intermarket margin system.
