ENFORCEMENT PROCEEDINGS

COMMISSION INSTITUTES AND SETTLES PROCEEDING AGAINST MERRILL LYNCH, PIERCE, FENNER & SMITH INCORPORATED IN CONNECTION WITH ORANGE COUNTY MUNICIPAL SECURITIES OFFERINGS

The Commission announced that on August 24, it instituted and settled a public administrative and cease-and-desist proceeding against Merrill Lynch, Pierce, Fenner & Smith Incorporated (Merrill Lynch). The action concerns Merrill Lynch's underwriting \$875 million in municipal securities issued by Orange County and the Orange County Flood Control District through four offerings in July and August 1994, just months before Orange County's bankruptcy. Merrill Lynch consented to the order without admitting or denying the Commission's findings. Merrill Lynch also agreed to pay a civil penalty in the amount of \$2 million. This is the Commission's latest enforcement action in its ongoing investigation relating to the financial collapse of Orange County.

In its order, the Commission found that Merrill Lynch sold the municipal securities to investors through Official Statements that omitted material information about the Orange County Investment Pools (the Pools), including the Pools' investment strategy, the risks of that strategy, and the Pools' investment losses. Accurate and complete disclosure about the Pools was material to investors because the funds pledged to repay the securities in all four offerings were invested in the Pools and the Pools guaranteed repayment of the securities in two of the offerings.

The Official Statements for three of the offerings also omitted to disclose that the variable interest rate paid on the securities was capped at 12%. This information was material to investors that had adopted policies against investing in securities with an interest rate cap.

Merrill Lynch, as underwriter of the Note Offerings, had a duty to conduct a professional review of the Official Statements, including an assessment of the information in its possession or reasonably accessible to it, sufficient to form a reasonable basis for believing in the accuracy and completeness of the key representations in the Official Statements. The order found that Merrill Lynch, through trading and sales personnel who conducted a

significant amount of securities business with Orange County, knew substantial material information about the Pools, including material information that was omitted from the Official Statements. Merrill Lynch, however, unreasonably failed to assure that such information was conveyed to the investment bankers responsible for reviewing and approving the Official Statements for the securities offerings.

In addition, Merrill Lynch, through its investment bankers responsible for reviewing and/or approving the Official Statements for the Note Offerings, also knew or reasonably should have known material information about the Pools and/or the Notes' interest rate. From a review of the Official Statements, Merrill Lynch, through its investment bankers, knew or reasonably should have known that the Official Statements omitted to disclose material information that was in its possession or reasonably accessible to it about the Pools and the Notes' interest rates.

The Commission found that, as a result, Merrill Lynch, through negligent conduct, violated Sections 17(a)(2) and (3) of the Securities Act of 1933 and Rule G-17 of the Municipal Securities Rulemaking Board. The Commission, accordingly, ordered Merrill Lynch to cease and desist from committing or causing any violation and any future violations of the above provisions and to pay a \$2 million civil penalty.

Previously, in January 1996, the Commission obtained injunctions against Orange County's former Treasurer-Tax Collector Robert L. Citron and former Assistant Treasurer Matthew R. Raabe for their fraudulent conduct in the offer and sale of over \$2.1 billion in municipal securities issued by Orange County and two local governmental agencies. In a separate concurrent administrative proceeding, the Commission ordered Orange County, the Orange County Board of Supervisors, and the Orange County Flood Control District to cease and desist from future fraudulent conduct in the offer and sale of securities. The Commission also issued a report relating to the conduct of the individual members of the Board of Supervisors in the offer and sale of securities. In January 1998, the Commission ordered CS First Boston Corp., the underwriter of another Orange County offering, and two of its investment bankers to cease and desist from future fraudulent conduct in the offer and sale of securities and to pay civil penalties totaling \$880,000. In August 1998, the Commission filed an injunctive action against Dain Rauscher, Inc., and two of its investment bankers for fraud in the offer and sales of over \$980 million in notes issued by Orange County and local governments located within the County.
