ENFORCEMENT PROCEEDINGS

INITIAL DECISION ISSUED IN PARNASSUS INVESTMENTS, ET AL.

On September 3, an administrative law judge ordered Parnassus Investments, Jerome L. Dodson, Marilyn Chou, and David L. Gibson to cease and desist from committing or causing violations of the federal securities laws. The cease and desist order resulted from findings that from December 1990 to January 1993 Parnassus Investments and Dodson improperly directed the Parnassus Fund to make an unauthorized loan; Parnassus Investments, Dodson, Chou, and Gibson caused the Parnassus Fund to overstate its net asset value; and Parnassus Investments and Dodson improperly used soft dollar credits.

The judge ordered Parnassus Investments and Jerome L. Dodson to cease and desist from committing or causing any violations of Sections 13(a)(3), 21(a), and 17(e)(1) of the Investment Company Act and Section 207 of the Investment Advisers Act. The judge further ordered that Parnassus Investments, Dodson, Gibson, and Chou cease and desist from committing or causing any violations or future violations of Rule 22c-1 promulgated under Section 22(c) of the Investment Company Act. ADMINISTRATIVE AND CEASE-AND-DESIST PROCEEDINGS INSTITUTED, FINDINGS MADE AND SANCTIONS IMPOSED AGAINST KEVIN SPERANZA AND ROBERT MAGGI

On September 3, the Commission has issued an Order Instituting Public Administrative and Cease-and-Desist Proceedings Pursuant to Section 8A of the Securities Act of 1933 and Sections 15(b), 19(h) and 21C of the Securities Exchange Act of 1934, Making Findings and Imposing Remedial Sanctions (Order) against Kevin C. Speranza (Speranza) of Pinellas Park, Florida, and Robert A. Maggi (Maggi) of Clearwater, Florida. Speranza and Maggi were both associated as officers and directors of Florida Health Plans & Investments Inc.

(FHPI), an unregistered broker-dealer. The Respondents submitted, and the Commission accepted, Offers of Settlement whereby they consented, without admitting or denying, to the entry of this Order. The Order finds that from December 1996 through October 1997, Speranza and Maggi willfully violated the securities registration provisions of the Securities Act and anti-fraud provisions of the Securities Act and Exchange Act, in that, in connection with the unregistered offer and sale to the public of securities in the form of promissory notes issued by Medco, Inc. (Medco), Speranza and Maggi misrepresented and omitted material facts regarding Medco, its operations, and the risks involved in the investment. Commission, based upon the findings and the Respondents' consents, barred Speranza and Maggi, with a right to apply after three years, from association with any broker, dealer, municipal securities dealer, investment company or investment adviser; ordered them to cease and desist from committing or causing any violations and any future violation of the registration and anti-fraud provisions of the federal securities laws; and required Speranza to disgorge \$68,709 and Maggi to disgorge \$69,786, representing ill-gotten gains obtained by them in the form of commissions from the sales of the Medco notes, plus prejudgment interest, but waived payments of such disgorgement based upon their financial inability to pay. The Order did not impose civil penalties. (Rels. 33-7571; 34-40396; File No. 3-9693)

COMMISSION OBTAINS ORDER OF PRELIMINARY INJUNCTION AGAINST JAMES COGLEY AND THE OHIO ESTATE GROUP, AND COURT FINDS DEFENDANTS IN VIOLATION OF TEMPORARY RESTRAINING ORDER

The Commission announced that on August 18, 1998, it obtained by consent an Order of Preliminary Injunction against James Michael Cogley (Cogley) and The Ohio Estate Group (OEG). The Order restrains Cogley and OEG from violating the antifraud provisions of the federal securities laws. The Order also freezes the assets of Cogley and OEG with the exception of payroll payments to OEG employees for the pay period immediately preceding the Court's entry of a temporary restraining order against Cogley and OEG on August 11, 1998, and the liquidation of an annuity in Cogley's name for purposes of paying for his living expenses.

On August 28, 1998, the Court entered an order by consent on the Commission's emergency motion to show cause why the Defendants should not be held in contempt. The order, among other things, finds that Cogley and OEG violated the provision of the Temporary Order that froze Cogley's and OEG's assets. [SEC v. James Michael Cogley, et al., S.D. INVESTMENT COMPANY ACT RELEASES

THE EXPEDITION FUNDS AND COMPASS BANK

An order and errata has been issued on an application filed by The Expedition Funds (Trust) and Compass Bank under Section 12(d)(1)(J) of the Investment Company Act exempting applicants from Sections 12(d)(1)(A) and (B) of the Act, under Sections 6(c) and 17(b) of the Act exempting applicants from Section 17(a) of the Act, and under Section 17(d) of the Act and Rule 17d-1 under the Act to permit certain joint transactions. The order permits non-money market series of the Trust to invest their uninvested cash in the money market series of the Trust. (Rel. IC-23423 - September 2)

INTEGRITY LIFE INSURANCE COMPANY, ET AL.

A notice has been issued giving interested persons until September 28 to request a hearing on an application filed by Integrity Life Insurance Company, Separate Account Ten of Integrity Life Insurance Company (Separate Account Ten), National Integrity Life Insurance Company, and Select Ten Plus Division of Separate Account II of National Integrity Life Insurance Company (Select Ten Plus Division) (collectively, the Applicants). The Applicants seek an order pursuant to Section 6(c) of the Investment Company Act exempting the Applicants, and other separate accounts of the Companies or affiliated insurance companies that support materially similar investment divisions, from the provisions of Section 12(d)(3) of the Act to the extent necessary to permit the divisions of Separate Account Ten and the Select Ten Plus Division to invest up to 10% of their total assets in securities of issuers that derive more than 15% of their gross revenues from securities related activities. SCUDDER SPAIN AND PORTUGAL FUND, INC. AND SCUDDER KEMPER INVESTMENTS, INC.

A notice has been issued giving interested persons until September 24 to request a hearing on an application filed by Scudder Spain and Portugal Fund, Inc. (Fund) and Scudder Kemper Investments, Inc. Applicants request an order under Section 17(b) of the Investment Company Act for an exemption from Section 17(a) of the Act to permit an in-kind redemption of shares of the Fund held by affiliated persons of the Fund. THE EVERGREEN INTERNATIONAL TRUST, ET AL.

A notice has been issued giving interested persons until September 25 to request a hearing on an application filed by Evergreen International Trust (Trust) and First Union National Bank for an order under Section 17(b) of the Investment Company Act granting an exemption from Section 17(a) of the Act. The order would permit one series of the Trust to acquire all of the assets and certain stated

liabilities of another series of the Trust. Because of certain affiliations, applicants may not rely on Rule 17a-8 under the Act. (Rel. IC-23426 - September 2)
