ENFORCEMENT PROCEEDINGS

IRA SCOTT IS BARRED FROM ASSOCIATION WITH AN INVESTMENT ADVISER

The Commission has barred Ira William Scott from association with any investment adviser. The Commission found that, on December 1, 1992, an Indiana state court entered a judgment of conviction against Scott on thirteen felony offenses: four counts of theft (three counts relating to investor funds and one count involving the property of a long-distance telephone carrier), three counts of sale of a security by an unregistered agent, three counts of sale of an unregistered security and three counts of fraud in connection with the sale of security. The Indiana Court of Appeals upheld Scott's conviction on appeal.

The Commission determined that it is in the public interest to bar Scott because he was convicted of serious felony offenses involving the sale of securities and the theft of investor funds. Scott's continued attacks on the validity of his conviction and insistence that the charges brought against him had no basis further demonstrated his inability to understand his obligations under the securities laws. Scott also expressed an interest in re-entering the securities industry but provided no assurances that he would not commit future violations. (Rel. IA-1752; File No. 3-9105)

COMMISSION OBTAINS TRO IN ACTION AGAINST BALANCED PLAN, INC., D/B/A BALANCED PLAN ACCUMULATION TRUST, JERALD ALBIN AND J.F. ALBIN COMPANIES, LTD.

The Commission announced that on September 11 the United States District Court for the Western District of Missouri issued a Temporary Restraining Order (TRO), temporarily barring, Defendants Balanced Plan, Inc., d/b/a Balanced Plan Accumulation Trust (Trust) and Jerald F. Albin (Albin) from violations of the antifraud provisions of the federal securities laws. The TRO also temporarily prohibits Albin, the Trust, and relief defendant J.F. Albin Companies, Ltd. (Albin Companies) from dissipating funds, pending a hearing on the Commission's request for a preliminary injunction.

In its complaint, the Commission alleges that Albin has raised more than \$1.7 million from at least 35 individuals who have invested in promissory notes sold by the Trust. The Trust and most Trust investors are located in the Kansas City, Missouri area. The Commission alleges that the Trust is an ongoing Ponzi scheme controlled by Albin and that Albin has misrepresented the use of investor proceeds, misappropriated investor funds and misrepresented the safety and liquidity of an investment with the Trust. The Commission named Albin Companies as relief defendant because, the Commission alleges, Albin Companies received Trust investor proceeds and used them to fund its operations. A hearing on the Commission's request for a preliminary injunction is scheduled for September 18, 1998. [SEC v. Jerald F. Albin, et al., W.D. Mo., Case No. 98-0977-CV-W-8] (LR-15881)

INVESTMENT COMPANY ACT RELEASES

CRABBE HUSON FUNDS, ET AL.

A notice has been issued giving interested persons until October 8, 1998, to request a hearing on an application filed by Crabbe Huson Funds (Trust), et al. for an order under Section 6(c) of the Investment Company Act exempting applicants from Section 15(a) of the Act. The order would permit the implementation, without prior shareholder approval, of new advisory agreements (New Agreements) for a period of up to 120 days following the later of the date of the acquisition of the assets of The Crabbe Huson Group, Inc. by LFC Acquisition Corp. (the New Advisor) or the date on which the requested order is issued (but in no event later than February 28, 1999) (the Interim Period). The order also would permit the New Advisor to receive all fees earned under the New Agreements during the Interim Period following shareholder approval. (Rel. IC-23435 - September 14)

THE VICTORY PORTFOLIOS, ET AL.

An order has been issued on an application filed by The Victory Portfolios, et al. under Sections 6(c) and 17(b) of the Investment Company Act for an exemption from Sections 12(d)(1)(A) and 17(a) of the Act, and under Section 17(d) of the Act and Rule 17d-1 under the Act. The order amends a prior order that permits non-money market series of a registered open-end management investment company to purchase shares of one or more of the money market series of such registered investment company by adding three registered open-end management investment companies and three investment advisers as applicants. (Rel. IC-23436 - September 15)

Z-SEVEN FUND, INC.

A notice has been issued giving interested persons until October 8, 1998, to request a hearing on an application filed by Z-Seven Fund,

Inc. (Company) for an order under Section 23(c)(3) of the Investment Company Act exempting the Company from Section 23(c) of the Act. The order would permit the Company to repurchase 698,210 of its common shares from Agape Co., S.A. in exchange for cash. (Rel. IC-23437 - September 15)

PROPOSED RULE CHANGES

The <u>Emerging Markets Clearing Corporation</u> filed a proposed rule change (SR-EMCC-98-08) to amend its articles of incorporation and modify its shareholder agreement to offer two thousand shares of Class A stock and four thousand shares of Class B stock. Publication of the proposal is expected in the <u>Federal Register</u> during the week of September 14. (Rel. 34-40433)

The <u>Chicago Board Options Exchange</u> filed a proposed change (SR-CBOE-98-22) that would consolidate most fines for minor rule violations under one regulatory circular, modify categories of behavior subject to summary fines, modify fine amounts, and permit the president of CBOE to authorize admission to the floor. Publication of the proposal is expected in the <u>Federal Register</u> during the week of September 21. (Rel. 34-40440)

ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission granted accelerated approval to a proposed rule change submitted by the <u>National Association of Securities Dealers</u> (SR-NASD-98-60) to integrate Nasdaq's Automated Confirmation Transaction Service (ACT) with the recently approved Order Audit Trail System (OATS). (Rel. 34-40437)
