RULES AND RELATED MATTERS

TRUST INDENTURE ACT OF 1939

The Commission has issued an order under Section 304(d) of the Trust Indenture Act of 1939 on an application by World Omni Financial Corp., World Omni 1998-A Automobile Lease Securitization (Issuer), World Omni Lease Securitization L.P., World Omni L.T., and Automobile Lease Finance L.P. with respect to an indenture (Indenture) between the Issuer and the Bank of New York, as trustee, conditionally exempting specified provisions of the Indenture from the requirements of Section 314(d) of the Act to the extent such requirements otherwise would apply. ENFORCEMENT PROCEEDINGS

COMMISSION SANCTIONS RICHARD CHEMA

On November 30, the Commission imposed sanctions on Richard D. Chema of Burke Virginia, a securities salesman for a registered broker-dealer. The Commission suspended Chema from association with any broker or dealer for a period of one year, effective December 7. Chema was also ordered to cease and desist from further violations of antifraud and anti-manipulative provisions of the Securities Exchange Act.

The Commission found that, in 1989 and 1990, Chema aided and abetted a manipulative and fraudulent scheme engineered by John G. Broumas, former board chairman of Madison National Bank of Virginia (MNBV) and a director of James Madison, Limited (JML), MNBV's parent company. In order to raise money, Broumas, in a scheme similar to check-kiting, arranged "wash trades" of JML stock between his accounts at 14 different brokerage firms. Since Broumas' stock was held in margin accounts, Broumas could obtain sales proceeds immediately, but could delay payment for purchases for a week. Broumas also engaged in the practice of "marking the close" by making small purchases of JML on the AMEX at the end of the day in order to boost the stock's price.

Chema executed Broumas' trades through several Broumas accounts at Chema's brokerage firm. The Commission found that, although Chema

suspected that Broumas was engaging in manipulative activity, he made no effort to determine whether or not his suspicions were justified. Instead, he simply continued to execute all of Broumas' orders. (Rel. 34-40719; File No. 3-8508)
