SEC FILES AMICUS CURIAE BRIEF ADDRESSING ISSUES CONCERNING THE APPOINTMENT OF MULTIPLE LEAD COUNSEL UNDER THE LITIGATION REFORM ACT

On December 4, the Commission filed a friend of the court brief, at the request of the court, which addresses the issue whether, and under what circumstances, it is appropriate to approve the appointment of multiple lead counsel under the Private Securities Litigation Reform Act of 1995. The Commission took the positions that (1) courts generally should defer to lead plaintiff's choice of counsel (e.g., except in very unusual circumstances, courts should not force a lead plaintiff to retain counsel it has not selected itself); (2) where multiple counsel are proposed, particular problems, including lack of ability of the lead plaintiff to supervise counsel and increased attorneys fees, may arise, and the courts should actively exercise their discretion to review proposals for such arrangements; (3) such arrangements may be justified by the need for resources, skill, experience, or expertise necessary to manage the litigation effectively for the class; (4) the court should not rely on, or give weight to, generic asserted benefits of assuring input from more rather than fewer class members or lawyers or avoiding disputes among competing lead plaintiff movants and among their counsel; (5) the presumptive lead plaintiff should provide the court with full information about the structure and intended functioning of the proposed counsel group; (6) the court should provide greater scrutiny where it appears that the selection of counsel is marked by a conflict of interest or based on factors other than the merits of the firms; and (7) the court should place appropriate conditions on the appointment of multiple counsel and indicate a willingness to revisit the issue. ENFORCEMENT PROCEEDINGS

COLLATERAL BAR ENTERED AGAINST BETTY RUBIN IN OIL AND GAS PONZI SCHEME

On November 30, 1998, the Commission accepted Betty Ann Rubin's (Rubin) Offer of Settlement wherein, without admitting or denying the Commission's findings, Rubin agrees to the entry of an administrative order barring her from association with any broker,

dealer, municipal securities dealer, investment adviser or investment company. The Order Instituting Administrative Proceeding Pursuant to Sections 15(b) and 19(h) of the Securities Exchange Act of 1934, issued on June 24, 1998, was based upon an Order of Permanent Injunction and Other Relief entered against Rubin in the United States District Court for the Central District of California on March 5, 1998.

The Commission's complaint in the District Court action alleged that Rubin, the sole owner and president of Lazar Frederick & Company (Lazar), a registered broker-dealer, misused and misappropriated investor funds through the fraudulent offer and sale of 29 oil and gas limited partnerships from May 1993 through December 1995. Rubin, through Lazar, raised \$35,534,000 from more than 2,000 investors in this alleged Ponzi-like scheme. The complaint further alleged that Lazar sales agents misrepresented that the partnerships had paid investors between 10% and 12% annually from partnership oil and gas revenue when in fact a large portion of the returns came from other investors' money.

The District Court judgment permanently enjoined Respondent Rubin from violations of Sections 5(a) and 17(a) of the Securities Act of 1933 and Sections 10(b) and 15(c) of the Securities Exchange Act of 1934, and Rules 10b-5 and 15c1-2 thereunder. FINAL JUDGEMENT AGAINST JASON WALL

The Commission announced today that Jason S. Wall has consented to the entry of a final judgment permanently enjoining him from committing securities fraud. The final judgment has been submitted for approval to the United States District Court for the Southern District of New York.

The action was commenced on September 4, 1997, when the Commission filed a complaint alleging that Wall had obtained over \$200,000 from a then ongoing fraudulent offering of bogus securities. According to the complaint, Wall -- who held himself out to investors as a securities broker with Rothschild Global Investments, Inc. -- offered and sold supposed "private placements" in well-known companies and promised investors a return of twenty-five to thirty-five percent in eight weeks. The complaint alleged that Wall was not employed by Rothschild during the relevant period, never had access to the so-called private placements and, in fact, never invested the money as he represented he would do. The Commission charged Wall with violating Section 17(a) of the Securities Act of 1933, Section 10(b) of the Securities Exchange Act of 1934, and Rule 10b-5 thereunder. Wall consented to the entry of the final judgment without admitting or denying the allegations in the complaint.

In connection with the conduct charged in the Commission's complaint, Wall also was convicted of one criminal count of securities fraud on May 19, 1998. He was ordered to pay restitution

in the amount of \$425,154, and is currently serving a thirty-month prison sentence at the Allenwood Federal Prison Camp in Montgomery, Pennsylvania.

COMMISSION SEEKS ASSET FREEZE AND TEMPORARY RESTRAINING ORDER AGAINST BROKER-DEALER, ITS CHAIRMAN AND AFFILIATED COMPANIES

The Commission announced that on December 3 in the United States District Court for the Southern District of New York it sought a temporary restraining order against The Brownstone Group a/k/a Brownstone Holdings, Inc. (Brownstone Holdings), Brownstone Capital Corp. (Brownstone Capital), Blackstone Entertainment Group (Blackstone Entertainment) and Gregory Cooper. The complaint seeks to freeze the defendants' assets, temporarily restrain the defendants from violating the antifraud provisions of the securities laws and appoint a Receiver for the three corporate defendants. The application for a temporary restraining order also seeks to freeze the assets of two relief defendants, Blackstone Unisex and Selene Alverio.

The complaint alleges that the defendants made false and misleading statements to investors in soliciting purchases of Brownstone Holdings and Blackstone Entertainment securities including that (1) the funds would be used for specified business and operational expenses when in fact they were used for other businesses and to pay personal expenses and (2) that an initial public offering was imminent when that was not the case.

In the complaint, the Commission also seeks preliminary and permanent injunctive relief against the defendants from violating the antifraud provisions of the securities laws, an officer and director bar against Cooper, an accounting from all defendants and the relief defendants and disgorgement of their unjust enrichment plus prejudgment interest, as well as civil penalties from the defendants.
