## COMMISSION ANNOUNCEMENTS

# CHRISTMAS EVE HOLIDAY

President Clinton signed an Executive order declaring a half-day Christmas Eve Holiday. The Commission will close at 1:30 p.m. on Thursday, December 24 and will be closed all day on Friday, December 25. The EDGAR system will not receive, process, or accept filings after 1:30 p.m. on December 24 or on December 25. The Filing Desk for paper filings will also be closed during that time. The EDGAR system will resume normal operations at 8:00 a.m. on Monday, December 28.

# ENFORCEMENT PROCEEDINGS

ADMINISTRATIVE AND CEASE AND DESIST PROCEEDINGS INSTITUTED AGAINST FORMER PERSONNEL OF W.R. GRACE & CO.

On December 22, the Commission instituted public administrative and cease and desist proceedings against Jean-Paul Bolduc, Brian J. Smith, CPA (Smith), Richard N. Sukenik, CPA (Sukenik), Philip J. Ryan III, (Ryan), Constantine L. Hampers, A. Miles Nogelo, and Robert W. Armstrong III, CPA (Armstrong). The Order Instituting Proceedings (Order) alleges that all respondents except Ryan committed or caused violations of the antifraud, reporting, and books and records provisions of the Securities Exchange Act of 1934 (Exchange Act). The Order alleges that Ryan caused violations of the books and records provisions of the Exchange Act. In addition, the Order alleges that Smith, Sukenik and Armstrong willfully violated the antifraud and books and records provisions of the Exchange Act and engaged in improper professional conduct.

All of the allegations in the Order arise out of events that occurred while the respondents worked at W.R. Grace & Co. (Grace) in Boca Raton, Florida and/or its subsidiary, National Medical Care, Inc. (NMC) in Waltham, Massachusetts. The Order alleges that Grace, through respondents, falsely reported to the Commission and the investing public results of operations for Grace and its Health Care Group segment for fiscal years 1991 through 1995. The Order alleges that, from 1991 through 1995, Grace deferred reporting income earned by NMC, the primary component of the Health Care Group, primarily to

smooth the earnings of the Health Care Group. According to the Order, Grace deferred reporting income by increasing or establishing reserves not in conformity with generally accepted accounting principles, and used the reserves to manipulate its reported quarterly and annual earnings of the Health Care Group.

The Order alleges that these excess reserves were primarily used for profit planning purposes, i.e., to bring the Health Care Group's quarterly reported results of operations in line with Grace's targets for the Health Care Group. The Order further alleges that Grace also released some of the excess reserves to increase Grace's earnings per share. According to the Order, when Grace reversed the excess reserves from its reported financial statements in the fourth quarter of 1995, it improperly netted the excess reserves with other charges and adjustments and misleadingly described the reversal as "a change in accounting estimate."

A hearing will be scheduled to determine whether the allegations are true, and if so, what sanctions, if any, are appropriate. (Rel. 34-40819; AAE Rel. 1090; File No. 3-9793)

# CIVIL PROCEEDINGS FILED AGAINST W.R. GRACE & CO.

On December 22, the Commission filed a civil action against W.R. Grace & Co. (Grace), located in Boca Raton, Florida, seeking an injunction and civil penalties. The complaint alleges that Grace violated the antifraud, reporting, and books and records provisions of the Securities Exchange Act of 1934. All of the allegations in the complaint arise out of events that occurred while Grace owned National Medical Care, Inc. (NMC) which was located in Waltham, Massachusetts.

The complaint alleges that Grace, through members of senior management of Grace and NMC, falsely reported results of operations for Grace and its Health Care Group segment for fiscal years 1991 through 1995. The complaint further alleges that, from 1991 through 1995, Grace deferred reporting income earned by NMC, the primary component of the Health Care Group, primarily to smooth the earnings of the Health Care Group. According to the complaint, Grace deferred reporting income by increasing or establishing reserves not in conformity with generally accepted accounting principles, and used the reserves to manipulate its reported quarterly and annual earnings of the Health Care Group.

The complaint alleges that these excess reserves were primarily used for profit planning purposes, i.e., to bring the Health Care Group's quarterly reported results of operations in line with Grace's targets for the Health Care Group. The complaint further alleges that Grace also released some of the excess reserves to increase Grace's earnings per share. According to the complaint, when Grace reversed the "excess reserves" from its reported financial statements in the fourth quarter of 1995, it improperly netted the excess reserves with other charges and adjustments and misleadingly described the reversal as "a change in accounting estimate."

A trial will be scheduled to determine whether the allegations are true, and if so, what sanctions, if any, are appropriate. [SEC v. W.R. Grace & Co., Civil Action No. 98-8942 CIV Hurley, S.D. Florida] (LR-16008)

# INVESTMENT COMPANY ACT RELEASES

# MFS INSTITUTIONAL TRUST

An order has been issued on an application filed by MFS Institutional Trust for an exemption from Section 17(a) of the Investment Company Act. The order permits an in-kind redemption of shares of the applicant by an affiliated person of the applicant. (Rel. IC-23617 - December 21)

# HOLDING COMPANY ACT RELEASES

#### INTERSTATE ENERGY CORPORATION

An order has been issued authorizing a proposal by Interstate Energy Corporation (Interstate), a registered holding company, Alliant Industries (Alliant), a nonutility subsidiary of Interstate and Whiting Petroleum Corporation (Whiting Petroleum), a nonutility subsidiary of Alliant. Interstate has been authorized to issue shares of its common stock and to exchange those shares to acquire all of the issued and outstanding common stock of Golden Gas Production Company (Golden Gas), an independent oil and gas producer. In addition, Interstate and Alliant have been authorized to contribute these shares to Whiting Petroleum, which will manage the oil and gas assets of Golden Gas. (Rel. 35-26957)

## PROPOSED RULE CHANGE

The American Stock Exchange LLC filed a proposed rule change (SR-Amex-98-34) regarding the listing and trading of Nasdaq-100 Shares, units of beneficial interest in the Nasdaq-100 Trust, Series 1, a unit investment trust based on the Nasdaq-100 Index. The Commission approved a proposed rule change filed by the <u>National Association of Securities Dealers</u> (SR-NASD-98-81) to exempt certain offerings by charitable organizations from the filing requirements under NASD Rule 2710. (Rel. 34-40816)
