ENFORCEMENT PROCEEDINGS

SEC SUSPENDS AND FINES SUPERVISOR OF BROKER

The Commission has settled public administrative proceedings against Cesar A. Montilla (Montilla) of Rio Piedras, Puerto Rico, formerly chief executive officer and registered principal of the Clark Melvin Securities Corporation (CMS or firm) and the supervisor of Hernan Perez (Perez). The Commission's Order finds that from at least January 1995 through September 1997, Perez, while a registered representative at CMS, willfully violated the antifraud provisions of the federal securities laws. Specifically, Perez misappropriated at least \$2.9 million from at least 19 customers of CMS and from one person who provided him with funds for the purpose of opening a securities account. In addition, Perez made materially false and misleading statements to the CMS customers and to the intended customer, concerning, among other things, the use of their funds, the need for them to cover margin debt, and the value of their securities accounts.

The Order further finds that from at least January 1995 through September 1997, Montilla failed reasonably to supervise Perez with a view to preventing Perez's violations of the antifraud provisions of the federal securities laws. Among other things, Montilla failed to place Perez under heightened supervision, despite firm procedures mandating that he do so in light of Perez's serious disciplinary past. Montilla further failed reasonably to respond to warning signs that Perez was engaging in misconduct. Montilla also failed to ensure that the firm's employees followed procedures relating to delivery of customer checks.

Without admitting or denying the findings of the Order, except that he admitted the jurisdiction of the Commission, Montilla consented to consecutive suspensions of three months from association with any broker or dealer, and nine months from association, in a supervisory capacity, with any broker or dealer. Montilla further consented to pay an administrative money penalty in the amount of \$5,000. (Rel. 34-40855)

INVESTMENT COMPANY ACT RELEASES

CCB FUNDS

An order has been issued on an application filed by CCB Funds (formerly, 111 Corcoran Funds) granting an exemption from Section 17(a) of the Investment Company Act to permit an in-kind redemption of shares of the applicant by an affiliated person of the applicant. (Rel. IC-23623 - December 28)

SELECT ADVISORS TRUST A, ET AL.

An order has been issued on an application filed by Select Advisors Trust A, et al. granting an exemption from Section 17(a) of the Investment Company Act. The order permits a reorganization involving certain registered investment companies. (Rel. IC-23624 - December 29)

CREDIT SUISSE FIRST BOSTON CORPORATION

An order has been issued on an application filed by Credit Suisse First Boston Corporation (CSFB) exempting SAILS Trusts for which CSFB will serve as a principal underwriter from Section 12(d)(1) and Section 14(a) of the Investment Company Act, and exempting CSFB and the Trusts from Section 17(a) of the Act. The order would permit other registered investment companies and companies excepted from the definition of investment company under Sections 3(c)(1) and 3(c)(7) of the Act to own a greater percentage of the total outstanding voting stock of the Trusts than that permitted by Section 12(d)(1) of the Act. The order would also exempt the Trusts from the initial net worth requirements of Section 14(a) of the Act and permit the Trusts to purchase U.S. government securities from CSFB at the time of a Trust's initial issuance of securities. SELF-REGULATORY ORGANIZATIONS

PROPOSED RULE CHANGE

The <u>Municipal Securities Rulemaking Board</u> filed a notice of filing of a proposed rule change under Rule 19b-4 (SR-MSRB-97-12) to amend Rules G-37, relating to political contributions and prohibitions on municipal securities business; G-38, relating to consultants; G-8, relating to books and records; and G-9, relating to the preservation of records. Publication of the notice in the <u>Federal Register</u> is expected during the week of January 4, 1999. (Rel. 34-40845)

EXTENSION OF COMMENT PERIOD

The Commission has decided, pursuant to Section 19(b)(2) of the Securities Exchange Act of 1934, to extend the comment period for a proposed rule change filed by the <u>New York Stock Exchange</u> (Rel. 34-40679, November 13, 1998, SR-NYSE-98-32) relating to shareholder approval of stock option plans. The comment period has been extended until January 25, 1999. (Rel. 34-40847)

APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change submitted under Rule 19b-4 by the <u>National Association of Securities Dealers</u> (SR-NASD-98-57) relating to amendments to NASD Membership and Registration, Investigation and Sanctions, Conduct and Code of Procedure rules. (Rel. 34-40853)
