U.S. SECURITIES AND EXCHANGE COMMISSION

GROUP FINANCIAL SERVICES, INC., OTHERS CITED

Public administrative proceedings have been instituted against Group Financial Services, Inc. (GFS), a registered investment adviser located at Rockville, Maryland, and the firm's principals, Marvin Yoder and John McQueary, also of Rockville. The proceeding was instituted based on staff allegations that GFS, Yoder and McQueary wilfully violated the antifraud provisions of the Investment Advisers Act of 1940, the Securities Act of 1933 and the Securities Exchange Act of 1934, and the books and records provisions of the Advisers Act; and failed to register as broker-dealers pursuant to the Exchange in sales of investment packages composed of shares of a no-load mutual fund, deposit term life insurance and a savings account type rider to the life insurance.

A hearing will be scheduled to take evidence on the staff allegations and to afford the respondents an opportunity to offer any defenses thereto. The purpose of the hearing is to determine whether the allegations are true and, if so, whether any action of a remedial nature should be ordered by the Commission. (Rel. IA-672)
