CLOSED MEETING - TUESDAY, MARCH 15, 1994 - 2:30 P.M.

The subject matter of the March 15 closed meeting will be: Institution of injunctive actions; Institution of administrative proceedings of an enforcement nature; Settlement of administrative proceedings of an enforcement nature; and Opinions.

OPEN MEETING - WEDNESDAY, MARCH 16, 1994 - 10:00 A.M.

The subject matter of the March 16 open meeting will be:

Consideration of whether to propose for public comment two new rules and rule amendments under the Investment Advisers Act of 1940. The first rule would expressly prohibit investment advisers from making unsuitable recommendations to clients. The second rule would prohibit registered investment advisers from exercising investment discretion with respect to client accounts unless they have a reasonable belief that the custodians of those accounts send account statements to the clients no less frequently than quarterly. ENFORCEMENT PROCEEDINGS

SALESMAN OF PRIME BANK INSTRUMENT INVESTMENTS ORDERED TO CEASE AND DESIST

The Commission announced that public administrative proceedings were instituted on March 1 against Neal Kent Lekwa & Associates, Inc. and its owner, Neal Kent Lekwa, of Mercer Island, Washington. The proceedings were based on allegations that the respondents offered investments in "prime bank" instruments in violation of Section 17(a) of the Securities Act of 1933 by making misrepresentations and omissions of material fact concerning the background and expertise of the respondents and their investigation of the securities being offered. In the administrative proceedings, with their consent, the respondents agreed to cease and desist the violative conduct. (Rel. 33-7045)

ROBERT BUCHANAN, JR. BARRED

On September 29, 1993, the Commission instituted public administrative proceedings against Robert M. Buchanan, Jr. (Buchanan), the former owner of a registered broker-dealer. On March 1, the Commission accepted Buchanan's Offer of Settlement, pursuant to which he consented, without admitting or denying the Commission's findings, except to findings of his indictment and subsequent conviction of securities fraud, mail fraud and conspiracy to commit securities and mail fraud, to an order barring him from association with any broker, dealer, municipal securities dealer, investment adviser or investment company. In the Order, the Commission found that on March 31, 1992, Buchanan was convicted of thirteen felony counts involving the offer or sale of a security. (Rel. 34-33695)

SCOTT JENSON SANCTIONED

The Commission instituted public administrative proceedings against Scott L. Jenson, a Salt Lake City, Utah, certified public accountant pursuant to Rule 2(e)(1) of the Commission's Rules of Practice. Simultaneously, the Commission accepted Jenson's Offer of Settlement. The Commission found that Jenson engaged in improper professional conduct by material departures from generally accepted auditing standards and by failing to cite material departures from generally accepted accounting principals in his audit reports issued in conjunction with the audits of TV Communications Network, Inc. for its fiscal years ended March 31, 1990, 1991 and 1992. The Commission's order denies Jenson the privilege of appearing or practicing before the Commission provided that after four years from the effective date of the order, Jenson may apply to resume appearing or practicing before the Commission. INVESTMENT COMPANY ACT RELEASES

AMERICAN SKANDIA LIFE ASSURANCE CORPORATION, ET AL.

A notice has been issued giving interested persons until March 29 to request a hearing on an application filed by American Skandia Life Assurance Corporation, American Skandia Life Assurance Corporation Variable Account B (Class 1 Sub-Accounts)(Variable Account) and Skandia Life Equity Sales Corporation for an order under Section 6(c) granting exemptions from the provisions of Sections 26(a)(2)(C) and 27(c)(2) of the Investment Company Act. The order would permit the deduction from the assets of the Variable Account of a mortality and expense risk charge assessed under certain variable annuity contracts. (Rel. IC-20114 - March 4)

HOLDING COMPANY ACT RELEASES

THE SOUTHERN COMPANY, ET AL.

A notice has been issued giving interested persons until March 28 to request a hearing on a proposal by The Southern Company (Southern), a registered holding company, and Southern Company Communications, Inc. (Communications). Southern proposes to form Communications and to acquire all of its authorized capital stock. Communications will design, construct, finance, maintain and operate the Southern electric system's communications system, including a mobile radio network that, when complete, will provide contiguous mobile radio services. In addition to providing communications services to the affiliated companies, Communications proposes to sell such services to nonaffiliated companies at market rates. Existing facilities and frequencies owned by other system companies will be transferred or leased to Communications for the new system. Southern proposes to invest up to \$179 million from time to time through December 31, 1998, for purchases of Communications' stock, loans and capital contributions to Communications or guarantees of obligations of Communications or any combination thereof. IP HOLDING COMPANY

A notice has been issued giving interested persons until March 28 to request a hearing on an application by IP Holding Company (Holding Company), an Illinois corporation, to acquire all the outstanding common stock of Illinois Power Company, an Illinois electric and gas public-utility holding company exempt from registration under Section 3(a)(2) of the Act pursuant to Rule 2. In addition, Holding Company requests an order of exemption under Section 3(a)(1) from all provisions of the Act except, except Section 9(a)(2). (Rel. 35-25996)

PUBLIC SERVICE CO. OF OKLAHOMA

A notice has been issued to provide all interested persons until March 14 to request a hearing on a proposal by Public Service Company of Oklahoma, an electric public utility subsidiary of Central and South West Corporation, a registered holding company, to invest up to \$2.5 million, through capital stock purchases, in Excel Energy Technologies, Limited, a Delaware corporation that is engaged in research, development, and installation of energy management micro-processors. NATIONAL FUEL GAS SUPPLY CORP., ET AL.

An order has been issued authorizing a proposal by National Fuel Gas Supply Corporation (National) and Penn-York Energy Corporation (Penn-York), (both, Applicants), wholly-owned, non-utility subsidiaries of National Fuel Gas Company, a registered holding company. National proposes to acquire all of the assets of Penn-York and merge Penn-York into National, with National emerging as the surviving corporation. The Applicants propose that the transaction is reasonably incidental or economically necessary or appropriate to the operation of National as a gas utility company pursuant to Section 2(a) of the Gas Related Activities Act of 1990.
