COMMISSION ANNOUNCEMENTS

JAMES C. TREADWAY, JR., BECOMES 61ST SEC COMMISSIONER; BEVIS LONGSTRETH SWORN IN FOR REAPPOINTMENT

James C. Treadway, Jr. became the 61st member of the SEC in ceremonies held at Commission Headquarters on September 13, 1982. He was given the oath of office by Chairman John S.R. Shad, filling a vacancy created when Philip A. Loomis, Jr. retired in June. His five year term expires June 5, 1987.

Bevis Longstreth, who first became a Commissioner July 29, 1981, was also sworn in by Chairman Shad yesterday. His current term expires June 5, 1984.

At the time of his appointment, Mr. Treadway, 39, and a native of Anderson, South Carolina, was a partner with the Washington and New York law firm of Dickstein, Shapiro & Morin, where he has been associated since October 1, 1972. During the past 15 years he has been engaged in a broad securities and corporate finance practice, representing corporate issuers, officers and directors. In addition, he has represented a U.S. and a foreign securities exchange, investment banking firms and investment companies. He is the author of various articles on the securities laws. ADMINISTRATIVE PROCEEDINGS

ADMINISTRATIVE PROCEEDINGS INSTITUTED AGAINST FIRST INTERREGIONAL EQUITY CORP. AND OTHERS IN CONNECTION WITH CURRENCY AND OTHER TRANSACTIONS

The Commission announced the institution of public administrative proceedings against First Interregional Equity Corp. (FIE), a Millburn, New Jersey municipal bond dealer with offices in Hollywood, Florida and New York City; and eight respondents who are current or former officers of FIE. The Commission also announced that FIE and one of the individual respondents consented to findings of violations, without admitting or denying the allegations, and to censures.

In the Order for Proceedings, the Division of Enforcement alleged violations of the antifraud provisions of the securities laws and the pricing regulatory provision of the Municipal Securities Rulemaking Board (MSRB) based upon excessive prices charged to customers in connection with municipal securities transactions. The Division also alleged violations of the recordkeeping provisions of the securities laws and of the MSRB in connection with currency payments by customers of the firm.

The individual respondents named in the proceeding are FIE's Chief Executive Officer, Herbert N. Goettlich; FIE's compliance officer; Robert J. O'Brien; former Executive Vice President, Nicholas A. Codispoti; Jay L. Knight, manager of FIE's Hollywood office; Harold Levine, assistant manager of the Hollywood office; and the following salesmen, Jerome S. Gross; Daniel J. Gottbetter; and Martin S. Brodner.

FIE consented, without admitting or denying the Commission's allegations, to findings of violations as charged and to a censure, and agreed to maintain certain supervisory procedures. Codispoti also consented to a censure and to a finding, without admitting or denying, of having failed to reasonably supervise. A hearing will be scheduled to determine whether the allegations against the remaining respondents are true, and if so, to determine, what, if any, remedial action is necessary in the public interest.

Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
