## ADMINISTRATIVE PROCEEDINGS

---

### PROCEEDINGS INSTITUTED AGAINST MORGAN STANLEY & COMPANY

The Commission has instituted public administrative proceedings pursuant to Section 15(b) and 19(h) of the Securities Exchange Act of 1934, to determine whether Morgan Stanley & Co., Inc. (Morgan Stanley) willfully violated Section 5 of the Securities Act of 1933 (Securities Act). The Order Instituting Public Proceedings makes three allegations. First, in October 1987, Morgan Stanley & Co., Inc. sold over 2.4 million shares, representing 4% of the outstanding common stock, of KaiserTech, Ltd. ("KaiserTech") in order to satisfy margin deficiencies in an account owned by Alan E. Clore ("Clore"). Second, at the time of these sales, Morgan Stanley knew, or had reason to know, that the Clore stock was "control stock" and therefore subject to restrictions on resale pursuant to Section 5 of the Securities Act. Third, Morgan Stanley willfully violated those restrictions by publicly selling, without registration, the Clore stock.

A hearing will be scheduled to determine whether the allegations against Morgan Stanley are true and, if so, what, if any, remedial sanctions are appropriate. (Rel. 34-28990)

### SECURITY FIRST LIFE INSURANCE COMPANY

## HOLDING COMPANY ACT RELEASES

### THE SOUTHERN COMPANY

A notice has been issued giving interested persons until April 15 to request a hearing on a proposal by The Southern Company (Southern), a registered holding company, its wholly owned electric public-utility subsidiary companies, Alabama Power Company, Georgia Power Company, Gulf Power Company, Mississippi Power Company (collectively, Operating Companies), and its wholly owned service subsidiary company, Southern Company Services, Inc., to enter into certain transactions pursuant to the settlement of litigation with Gulf States Utilities Company (Gulf States). The transactions are for: 1) approximately \$75 million in cash; 2) Gulf States notes in the aggregate principal amount of \$160 million (Notes); 3) six million shares of Gulf States authorized and unissued common stock (Shares); and 4) an agreement by Gulf States to pay an \$18.25 Differential (Differential) and issue \$18.25 Notes (\$18.25 Notes). The Notes, the Differential and the \$18.25 Notes will be secured by: (1) a guaranty executed by GSG&T, Inc. (GSG&T), a wholly owned subsidiary of Gulf States; (2) a first mortgage lien created by GSG&T for the benefit of the Operating Companies on the Lewis Creek Generating Station; and (3) a pledge to the Operating Companies of all GSG&T stock. Southern may purchase all or a portion of the Shares, the Notes and/or the \$18.25 Notes from one or more of the Operating Companies. (Rel. 35-25280)

### GULF POWER COMPANY

A notice has been issued giving interested persons until April 15 to request a hearing on a proposal by Gulf Power Company (Gulf), an electric public-utility subsidiary of The Southern Company, a registered holding company, to issue and sell up to \$125 million of first mortgage bonds and up to \$50 million of preferred stock, to finance or refinance up to \$100 million of its pollution control facilities in Florida, Georgia and Mississippi with pollution control revenue bond proceeds, and to engage in related transactions. ### NARRAGANSETT ELECTRIC COMPANY

A notice has been issued giving interested persons until April 15 to request a hearing on a proposal by Narragansett Electric Company (Narragansett), an electric utility subsidiary of New England Electric System, a registered holding company, to extend, until September 30, 1998, Narragansett's authority to incur unsecured indebtedness up to 20% of the aggregate of the principal amount of all bonds and other secured indebtedness and the capital and surplus (capital and retained earnings) of Narragansett. Narragansett has been authorized to solicit proxies from shareholders of its cumulative preferred stock for use at a special meeting of such shareholders, to be held June 5, 1991, for approval of such proposal. ## KU ENERGY CORPORATION

A notice has been issued giving interested persons until April 18 to request a hearing on an application by KU Energy Corporation (KU Energy) (formerly Holdings, Inc.), a newly formed Kentucky corporation, under Sections 3(a)(1), 9(a)(2) and 10 of the Act. KU Energy proposes to acquire all of the outstanding common stock of Kentucky Utilities Company (KU), a Kentucky electric utility and a holding company exempt from registration by order under Section 3(a)(2) of the Act, and, through such acquisition, KU's holdings of all of the outstanding shares of capital stock of Old Dominion Power Company (ODP), a Virginia electric utility, and 20% of the outstanding shares of capital stock of Electric Energy, Inc., an Illinois electric utility. ODP will be merged into KU with KU as the surviving corporation, and KU will be incorporated as a Virginia corporation, while remaining a Kentucky corporation. (Rel. 35-25282)

Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
