RULES AND RELATED MATTERS

U.S. SECURITIES

APPROACH OF COMMENT DEADLINE

Interested persons, particularly members of the broker-dealer community, are reminded that comments on the Commission's proposed amendments to Rule 15c2-11 under the Securities Exchange Act of 1934 should be submitted on or before January 1, 1992. The proposed amendments (Rel. 34-29095, April 17, 1991) would, among other things, substantially narrow or eliminate the present "piggy back" exemption from the rule's record-gathering and review requirements. See also 56 FR 19158.

COMMISSION ANNOUNCEMENTS

CHICAGO REGIONAL OFFICE RELOCATION

The Chicago Regional Office of the Commission will relocate to new offices on December 2, 1991. After that date, all correspondence to the Chicago Regional Office should be addressed to Northwestern Atrium Center, 500 West Madison Street, Suite 1400, Chicago, Illinois 60661-2511. The telephone number of the Chicago Regional Office will remain (312) 353-7390. CIVIL PROCEEDINGS

CIVIL ACTION AGAINST WESTDON HOLDING & INVESTMENT, INC. AND OTHERS

The Commission announced on November 14 the issuance of a preliminary injunction and asset freeze on November 12 by the U.S. District Court for the Southern District of New York against Westdon Holding & Investment, Inc., Kishore J. Shah, Ioannis A. Koutsoubos, FNIC Europe S.A., First National Investment Corporation, USA Enterprises, Inc. and Megacom S.A. The case seeks permanent injunctions, disgorgement of illegally obtained profits and civil penalties against the Defendants for violations of the registration provisions of Section 5 of the Securities Act of 1933 and the beneficial ownership reporting provisions of Section 13(d) of the Securities Exchange Act of 1934 and Rule 13d-1 thereunder.

The case is the first enforcement action filed by the Commission involving purported reliance on Regulation S, which was adopted by the Commission on April 24, 1990, to provide certain "safe harbors" from the registration provisions of the Securities Act for offers and sales of securities made abroad. However, Regulation S is not available for any transaction or chain of transactions that is part of a plan or scheme to evade the registration requirements of the Securities Act. [SEC v. INVESTMENT COMPANY ACT RELEASES

WOODS INVESTMENT COMPANY TAFT PHILANTHROPIC TRUST SECURITY OMNI FUND

Orders have been issued under Section 8(f) of the Investment Company Act declaring that WOODS INVESTMENT COMPANY, TAFT PHILANTHROPIC TRUST and SECURITY OMNI FUND have ceased to be investment companies. (Rel. IC-18403; IC-18404 and IC-18405 - November 13)

HOLDING COMPANY ACT RELEASES

HOPE GAS, INC.

An order has been issued authorizing Hope Gas, Inc. (Hope Gas), a public-utility subsidiary company of Consolidated Natural Gas Company, a registered holding company, to acquire an approximately 50% partnership interest in Avenel Capital (I) Limited Partnership (Partnership), a West Virginia limited partnership, for a purchase price of \$2 million. The Partnership, which will make venture capital investments in West Virginia businesses, will qualify for \$2 million of state tax credits under West Virginia law. Hope Gas will be assigned all of the Partnership's state tax credits. (Rel. 35-25407)

LISTING, DELISTING AND UNLISTED TRADING ACTIONS

UNLISTED TRADING PRIVILEGES GRANTED

Orders have been issued granting the applications of three exchanges for unlisted trading privileges in issues which are listed and registered on one or more other national securities exchanges and are reported in the consolidated transaction reporting system. The exchanges and number of issues are as follows: Philadelphia Stock Exchange - 19 issues (Rel. 34-29936); Midwest Stock Exchange - 2 issues (Rel. 34-29941).

UNLISTED TRADING PRIVILEGES SOUGHT

Notices have been issued giving interested persons until December 5 to comment on the applications of three exchanges for unlisted trading privileges in issues which are listed and registered on one or more other national securities exchanges and are reported in the consolidated transaction reporting system. The exchanges and number of issues are as follows: <u>Boston Stock Exchange</u> - 13 issues (Rel. 34-29938); <u>Philadelphia Stock Exchange</u> - 6 issues (Rel. 34-29939); and <u>Midwest Stock Exchange</u> - 3 issues (Rel. 34-29940)

BELF-REGULATORY ORGANIZATIONS

ACCELERATED APPROVAL OF PROPOSED RULE CHANGES

The Commission granted accelerated approval to a proposed rule change filed by the <u>Pacific Stock Exchange</u> (SR-PSE-91-30) that extends the PSE's Options Trading Crowd <u>Performance Evaluation pilot program until October 1, 1992</u>. Publication of the order is expected in the <u>Federal Register</u> during the week of November 18. (Rel. 34-29930)

The Commission granted accelerated approval to a proposed rule change filed by the American Stock Exchange (SR-Amex-91-24) to allow the Amex to list capped options on the Amex's stock indexes. Publication of the order is expected in the Federal Register during the week of November 18. (Rel. 34-29934)

The Commission granted accelerated approval to a proposed rule change filed by the Chicago Board Options Exchange (SR-CBOE-91-35) to extend the Exchange's Modified Trading System pilot program until September 22, 1993. Publication of the order is expected in the Federal Register during the week of November 18. (Rel. 34-29935)

PROPOSED RULE CHANGE

The <u>National Association of Securities Dealers</u> filed a proposed rule change (SR-NASD-91-54) under Rule 19b-4 that would amend Section 30 of the NASD's Code of Arbitration Procedure to require the deposit of adjournment fees with any request for adjournment, unless waived by the Director of Arbitration upon a showing of financial need. Publication of the proposal is expected in the <u>Federal Register</u> during the week of November 18. (Rel. 34-29933)

ACQUISITION OF SECURITIES

Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
