

### ORDERS FOR PUBLIC PROCEEDINGS

### LIBRARY

CABOT, SHAW, INC.

Public administrative proceedings under the Securities Exchange Act have been ordered against Cabot, Shaw, Inc., a registered broker-dealer of Los Angeles, California and Darold Myles Shirwo, its president and principal shareholder, also of Los Angeles. The National Association of Securities Dealers, Inc. (NASD) cooperated greatly with the SEC's investigation of the facts leading up to the institution of these proceedings. Cabot, Shaw, Inc. and Shirwo are charged with violations of the registration and antifraud provisions of securities laws in the offer and sale of the common stock of Environmental Devices, Inc.

A hearing will be scheduled to take evidence on the staff allegations and to afford Cabot, Shaw, Inc. an opportunity to offer any defenses. The hearing is to determine whether the allegations are true, and if so, whether any action of a remedial nature should be ordered by the Commission. (Rel. 34-10701)

#### LEXINGTON CAPITAL CORP., OTHERS

Public administrative proceedings under the Securities Exchange Act have been ordered against Lexington Capital Corp., (Lexington) a New York City broker-dealer, and Sam Frank, Elliot Frank, Leonard Frank, Norton Frederick Hight, and William Jacob Mandelbaum, officers and directors of Lexington, Ivor Tanenhaus, a former officer of Lexington, and George Mazur, a salesman at Lexington. The proceedings are based on allegations by the Division of Enforcement that the respondents violated or aided and abetted violations of the antifraud provisions of the securities laws in the underwriting and trading of the common stock of Kolpak Industries, Inc. The order also alleged that Lexington, Sam Frank, Elliot Frank, Leonard Frank, Norton Frederick Hight and William Jacob Mandelbaum violated or aided and abetted violations of the net capital provisions of the Securities Exchange Act and that a trustee was appointed to liquidate Lexington pursuant to the Securities Investor Protection Act of 1970. The proceedings arose out of a joint SEC-NASD task force investigation of Lexington.

A hearing will be scheduled by further order to take evidence on the staff charges and afford the respondents an opportunity to offer any defense. The hearing is to determine whether the allegations are true and, if so, whether any action of a remedial nature is necessary or appropriate in the public interest. (Rel. 34-10700)

## **COURT ENFORCEMENT ACTIONS**

#### ROBERT L. OLIVER PLEADS GUILTY

The Seattle Regional Office announced that on March 11 Robert L. Oliver, a former resident of Spokane and Moses Lake, Washington, pleaded guilty to fraud in the sale of securities and of unregistered securities of Spokane National Mines, Inc. A presentence investigation was ordered.

The indictment charged that Oliver and two other defendants, Jack A. Taitch and Robert R. Newhouse, sold in excess of 1,700,000 shares of unregistered stock of

Spokane National Mines to the public for some 1,100,000 for which stock the defendants paid the company only 135,000 in cash and assignments of options and leases of non-producing mining properties of little or no value. The mining is now defunct. (LR-6287)

### COMPLAINT NAMES COMMERCIAL TECHNOLOGY

The Denver Regional Office announced the filing of a complaint on March 15 in the Federal Court for Utah in Salt Lake City, charging Commercial Technology, Inc. (formerly Ashley Minerals, Inc. and Cancer Detection, Inc.), a Nevada corporation, with offices in Salt Lake City; Dennis G. Madsen of Salt Lake City; and Philip P. Taylor and D. Keith Whatcott both of Provo, Utah, with violations of the registration and antifraud provisions of the securities laws. (LR-6288)

COMPLAINT NAMES SECURITY LAND AND DEVELOPMENT CORPORATION, OTHERS

The Atlanta Regional Office announced that on March 11 a complaint was filed in the U. S. District Court in Augusta, Georgia seeking to enjoin Security Land and Development Corporation, Coastal States Land and Development Corporation, both Georgia corporations located in Augusta, and Southeastern Land and Development Corporation, a South Carolina corporation with offices also in Augusta, from violations of the registration and antifraud provisions of the securities laws in the offer and sale of their common stock. The complaint also seeks to enjoin Douglas R. Smith of Belvedere, South Carolina, Gary L. Matthews and Dale Simpson of Augusta, from violations of these laws in the offer and sale of Security Land stock; Smith, Matthews, Frank Dowdy of Forsyth, Georgia, Simpson and Jerry E. Noles of Belvedere, South Carolina from violations of these laws in the offer and sale of Coastal States stock; and Smith, Matthews, Dowdy and Noles with respect to the offer and sale of Southeastern Land stock.

In addition, the Commission's complaint seeks an order compelling Security Land to file a registration statement with the Commission in accordance with the requirements of Section 12(g) of the Securities Exchange Act of 1934. (LR-6289)

### HOLDING COMPANY ACT RELEASES

NEW ORLEANS PUBLIC SERVICE INC.

A notice has been issued giving interested persons until April 17 to request a hearing on a proposal of the New Orleans Public Service Inc., subsidiary of Middle South Utilities, Inc., to sell \$35 million of first mortgage bonds. The net proceeds will be used to finance construction and for other corporate purposes. (Rel. 35-18334)

### PENNSYLVANIA ELECTRIC COMPANY

A notice has been issued giving interested persons until April 15 to request a hearing on an application-declaration of General Public Utilities Corporation, and two of its subsidiaries, Pennsylvania Electric Company (Penelec) and Waterford Electric Light Company (Waterford), regarding the proposed acquisition by Penelec of all of the assets of Waterford and certain related transactions.
