WORKING CAPITAL OF NONFINANCIAL U.S. CORPORATIONS ROSE IN 1973 FOURTH QUARTER

LIBRARY

The net working capital of nonfinancial U.S. corporations rose \$3.4 billion during the fourth quarter of 1973. This gain in working capital compares with increases of \$4.2 billion in the previous quarter and \$5.1 billion in the final quarter of 1972. For the year 1973, net working capital increased \$21.0 billion in contrast to \$19.5 billion in 1972 and \$17.4 billion in 1971. Net working capital, which represents corporate investment in current assest in excess of current liabilities, totaled \$245.3 billion at the close of 1973. For further details see the Statistical Bulletin dated April 24, 1974.
