COMPLAINT NAMES CAPITAL SYNDICATIONS, INC., OTHERS

The Fort Worth Regional Office announced that a complaint was filed in Federal District Court at Fort Worth, Texas, on July 22, 1974, seeking to enjoin Capital Syndications, Inc., Capital Syndications Company, both of Hurst, Texas, Wayne R. Morgan, Fort Worth, Texas, and Jesse D. Sanders, Dallas, Texas, from violations of the antifraud provisions of the securities laws in the offer and sale of investment contracts evidenced by limited partnership agreements, and seeking the appointment of a receiver for Capital Syndications, Inc. and Capital Syndications Company.

The complaint alleged that the violations occurred in connection with Capital Syndications, Inc.'s syndication of some 50 undeveloped tracts of real estate in the Dallas-Fort Worth area by the marketing of approximately 130 limited partnerships involving the sale of more than 3,150 limited partnership interests to some 1,840 Texas investors for a total purchase price of more than \$34,440,000. It is alleged that the defendants violated the antifraud provisions of the securities laws in that Capital Syndications, Inc. and Capital Syndications Company, without the knowledge of investors, diverted limited partnership and investor funds to meet obligations for which the funds were not intended, including acquisition of unrelated properties, interest payments on unrelated properties, and general operating expenses. The complaint further alleged that the misapplication of funds has totaled at times in excess of \$363,000, and that Capital Syndications, Inc. and Capital Syndications Company are presently unable to repay the funds diverted from the limited partnerships.

The complaint alleged further that the defendants violated the antifraud provisions of the securities laws by making misrepresentations of material facts and omitting to state material facts in the offer and sale of the limited partnership interests. Such misrepresentations and omissions included, among others, statements as to the financial security of the company, the experience and success of the issuer and its management in raw land syndication and the existence of escrow accounts for investors' funds.

In asking the court for the appointment of a receiver for Capital Syndications, Inc. and Capital Syndications Company, the Commission alleged that due to the diversion and misapplication of funds and the inability of Capital Syndications, Inc. and Capital Syndications Company to repay the funds to the limited partnerships, a receiver is needed to preserve current assets and manage the limited partnerships. AMERICAN EDUCATIONAL SPECIALISTS, INC., OTHERS, ENJOINED

> The Fort Worth Regional Office announced that the U.S. District Court in Dallas, Texas, entered orders on the dates indicated below enjoining the following corporations and individuals from further violations of the registration and/or antifraud provisions of the securities laws: American Educational Specialists, Inc., Tronics Corporation, U.S. Environmental Systems, Inc., Erie-Niagara, Ltd., and Med-Peds, Inc. all of Dallas, Texas on May 21, 1974; Edward H. Miller, Jr. of Fort Erie, Ontario, on May 22, 1974; Vito J. Caruso of Buffalo, New York, on June 6, 1974; David A. Paroline of Bridgeville, Pennsylvania, on June 24, 1974; Ivan Marra of Butler, Pennsylvania, on July 1, 1974; James Wallace White of Twenty-Nine Palms, California, on July 1, 1974; Helene K. Garner, also known as Helene K. Geddes of Carlsbad, California, on July 10, 1974; and Anne White, also known as Anne R. Kenny, also known as A. K. Peto, Twenty-Nine Palms, California, on July 18, 1974. James Wallace White and Anne White were preliminarily enjoined; all of the other defendants were permanently enjoined.

> The above defendants consented to the orders without admitting or denying the allegations in the complaint. (LR-6449)

COMPLAINT NAMES MANAGEMENT CORPORATION OF ATLANTA, INC.

The Atlanta Regional Office announced that on July 17 the Commission filed a complaint in the Federal District Court at Atlanta, Georgia seeking to enjoin Management Corporation of Atlanta, Inc. (MCA) and Robert R. Dearborn from violations of securities registration and antifraud provisions of the securities laws in the offer and sale of common stock of MCA. MCA is engaged in the sale of franchises for automobile service centers under the trade name of "Drive-Rite". (LR-6447)
